**Amendment to Budget Bill Items 7760-001-6057 and 7760-002-0666, Support, Department of General Services**

**Office of Public School Construction Reduction**—It is requested that Item 7760-001-6057 be decreased by \$690,000 and 6 positions to align administrative resources with workload for the School Facilities Program.

**Technical Adjustment**—It is requested that Item 7760-002-0666 be decreased by \$943,000 to reflect reduced lease rental payments due to the refinancing of the original lease revenue bonds.

**Amendment to, Addition of, and Elimination of Various Budget Bill Items, Support,  
California Public Employees' Retirement System**

It is requested that Item 7900-003-0830 be decreased by \$26,442,000, Item 7900-015-0815 be increased by \$515,000, Item 7900-015-0820 be increased by \$117,000, Item 7900-015-0830 be increased by \$510,000, Item 7900-015-0833 be increased by \$1,526,000, Item 7900-015-0849 be increased by \$7,000, Item 7900-015-0884 be increased by \$615,000, and an increase of 39 positions to reflect the request by the California Public Employees' Retirement System (CalPERS) to incorporate their board approved budget into the Budget Act.

The Budget Bill items mentioned above are display items for informational purposes to reflect a corresponding change in CalPERS' continuous appropriation authority. These changes reflect the fiscal year 2016-17 budget approved during the April 18, 2016 CalPERS board meeting. The budget approved by the CalPERS board reflects a reduction of \$16,264,000 primarily driven by higher than anticipated position vacancies and lower than anticipated outside counsel and third party investment management fees.

It is requested that Item 7900-001-0822 be added in the amount of \$40,518,000 to replace Item 7900-015-0822, which is being eliminated. The funds and authority in Item 7900-015-0822 are being transferred to Item 7900-001-0822. This includes an increase of \$6,888,000 to reflect the budget approved by the CalPERS board.

**Amendment to Budget Bill Item 7920-011-0001, Support, California State Teachers' Retirement System**

It is requested that Item 7920-011-0001 be increased by \$4,571,000 due to an increase in creditable compensation reported by the California State Teachers' Retirement System for fiscal year 2014-15. The Defined Benefit payment will be increased by \$1,044,000, the Pre-1990 Defined Benefit Level payment will be increased by \$2,232,000, and the Supplemental Benefit Maintenance Account contribution will be increased by \$1,295,000. These adjustments represent existing statutory funding requirements.
