REVENUE

Revenues provide the major source of state government financing. Generally, revenues are the result of taxes, licenses, and fees collected, or from investment earnings. Revenues cause an increase to asset and fund equity accounts in governmental funds.

This section contains the account codes and titles to be used for the accounting and reporting of revenue. The first digit of the six digit revenue code will be coded a one (1). The second digit is coded to identify the revenue type. The third and fourth digits are coded to show the detail revenue account. The last two digits may be coded by the department when greater detail is required.
