## **BKK Hazardous Waste Landfill Site Maintenance**

It is requested that Item 3960-001-0001 be increased by \$8,491,000 to provide emergency response and essential site operations at the BKK hazardous waste landfill facility in West Covina and that Item 3960-001-0014 be amended to reflect this change. This request will provide funds for daily site maintenance and repair or replacement of essential equipment. The Department of Toxic Substances Control (Toxics) will continue to seek release of site maintenance responsibility or cost relief from potential responsible parties through appropriate legal remedies. The state is a potential responsible party at the site, and any costs incurred for post-closure activities will offset any future liability the state may be assigned when all the potential responsible parties are identified. Suggested Budget Bill language is attached that would require Toxics to take all reasonable actions to recover post-closure costs from potential responsible parties, and that the amounts received be paid to the General Fund (Attachment 1).

# **Brownfield Remediation**

It is requested that Item 3960-001-0890 be increased by \$500,000 to provide cleanup loans and grants for brownfield properties from the federal Brownfields Cleanup and Redevelopment Program and that Item 3960-001-0014 be amended to reflect this change. The federal funds would be used for program development and outreach, and the distribution of loans and grants would likely begin in 2006-07. Suggested Budget Bill language is attached to provide Toxics the authority to make brownfield loans and grants pursuant to the federal requirements (Attachment 2).

# Stringfellow Pretreatment Plant

It is requested that Item 3960-001-0001 be decreased by \$1,063,000 and that Item 3960-001-0014 be amended to reflect this change. It is also requested that Item 3960-301-0001 be added in the amount of \$1,063,000 and Item 3960-490 be added to reappropriate funds for the purpose of preparing preliminary plans for the construction of a new pretreatment plant at the Stringfellow Federal Superfund site. This appropriation is subject to the condition that, to the extent that funds are expended for purposes for which any private or public entity is or may be held financially liable, the Department of Toxic Substances Control shall take all reasonable actions to recover the amount of that expenditure from one or more of those entities, and that the amounts so recovered be paid to the General Fund in reimbursements of the amount of that expenditure. In doing so, the Department of Toxic Substances Control shall comply with the State Contract Act and other applicable competitive selection processes. Notwithstanding any other provision of law, the Department of Toxic Substances Control may enter into any and all contracts for the design, construction and management of the project authorized in this item.
