## Updated Total Reserve, including April 1 Finance Letters

The January 10 Budget proposed difficult but necessary steps to bring the state's chronic structural deficit under control on a permanent basis. Consistent with that goal, we have approved April 1 Finance Letters that result in a small net improvement on the reserve. However, as shown in the table below, in spite of the actions taken by the Legislature in the Special Session, there is still considerable work to be done to address the expected deficit.

Here is a summary of the major General Fund changes since the Governor's Budget.
