Amendment to Budget Bill Items 2240-101-0001 and 2240-101-0890, and Addition of Budget Bill Item 2240-490, Local Assistance, Department of Housing and Community Development

American Recovery and Reinvestment Act of 2009 (Issue 200)—It is requested that Item 2240-101-0890 be increased by \$129,119,000, and that Item 2240-101-0001 be amended to reflect this change, to provide additional federal fund authority for the anticipated receipt of federal stimulus funds under the American Recovery and Reinvestment Act of 2009. This amount includes \$10,652,000 for the Community Development Block Grant Program, \$44,467,000 for the Federal Emergency Shelter Grant Program and an estimated \$74.0 million for the Neighborhood Stabilization Program. Add Budget Bill language to authorize the Department of Housing and Community Development (HCD) to expend up to \$1.6 million of the local assistance appropriation for state operations costs (see Attachment 1).

Reappropriation of Proposition 1C Local Assistance and Extension of Liquidation Period (Issue 201)—It is requested that Item 2240-490 be added to reappropriate \$335.0 million local assistance for the Infill Infrastructure Grant Program, Transit Oriented Development Program and Building Equity, and Growth in Neighborhoods Program, and to extend the liquidation period for one year. The awarding of local assistance for these programs has been impacted by the freeze on Pooled Money Investment Account loan disbursements, HCD may not receive sufficient cash resources to fully encumber the funding by the end of fiscal year 2008-09. Consistent with the five-year liquidation period given for the Infill Infrastructure Grant Program, Transit Oriented Development Program, and Building Equity and Growth in Neighborhoods Program in the 2008 Budget Act, it is requested to extend the liquidation periods for these local assistance funds by one year.

## Amendment to Budget Bill Item 2720-301-0044, Capital Outlay, California Highway Patrol

It is requested that Item 2720-301-0044 be increased by \$2,717,000 to provide authority for the working drawings phase of the California Highway Patrol Enhanced Radio System: Replace Towers and Vaults project. Many of these high-elevation towers are snowbound throughout the winter. To minimize the effect of seasonal delays on these replacements, most will need to start the working drawings between April 2010 and July 2010, which will allow tower construction to begin in spring 2011 and be completed before the following winter season.
