Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance, Judicial Branch

It is requested that Items 0250-001-0001 and 0250-001-0932 be revised by adding provisional language, Item 0250-001-3037 be decreased by \$7,108,000, Item 0250-001-3066 be increased by \$64,784,000, Item 0250-101-0932 be revised by adding provisional language and Reimbursements, and Item 0250-001-3138 be added to the Budget Bill (See Attachment I) for the following purposes:

Separate Appropriation for Immediate and Critical Needs Account—It is requested that Item 0250-001-3138 be added to the Budget Bill and increased by \$10.0 million, and that Item 0250-001-3037 be decreased by an equal amount to provide for facility modification expenditures authorized by Chapter 311, Statutes of 2008 (SB 1407).

**Judicial Branch Facilities Program Staffing**—It is requested that Item 0250-001-3037 be increased by \$2,892,000 to provide additional resources for workload associated with trial court facilities that have transferred to state responsibility.

**Court Appointed Counsel**—It is requested that Item 0250-001-0001 be revised to add language providing the Judicial Branch with flexibility to address projected funding shortfalls in the Court Appointed Counsel program for the Courts of Appeal.

**Dependency Counsel Cost Recovery**—It is requested that Item 0250-101-0932 be amended by adding language and increasing Reimbursements by \$1,000 related to the recovery of costs for court-appointed dependency counsel services provided at the trial court level. It is also requested that Item 0250-001-0932 be revised to add language authorizing increased expenditures for administrative costs supporting these activities.

Court Facilities Trust Fund Adjustment—It is requested that Item 0250-001-3066 be increased by \$64,784,000 to reflect estimated operational costs for facilities that have transferred to state responsibility.

### Amendments and Additions to 2009-10 Budget Bill for Judicial Branch

### Issue 150: Immediate and Critical Needs Account Item

Item 0250-001-3138 is added to the Budget Bill:

## Issue 153: Court Appointed Counsel Program in Courts of Appeal

Provision X is added to Item 0250-001-0001:

Provision X. The Judicial Branch may submit a deficiency request to address budgetary shortfalls in the Courts of Appeal Court Appointed Counsel program. Any shortfalls in this program are deemed to be unanticipated for the purpose of Items 9840. The Judicial Branch shall provide updated projections of the shortfall to the Department of Finance during the preparation of the Governor's Budget and May Revision, as well as the methodology for estimating the shortfall. The Judicial Branch is hereby authorized to accrue current year claims when the appropriated funding is insufficient.

### Issue 154: Court Appointed Dependency Counsel Services

Provisions X and X are added to Item 0250-101-0932:

Provision X. Notwithstanding any other provision of law, upon approval of the Director of Finance, Reimbursements appropriated in Schedule (11) of this item may be increased by the amount of any additional resources collected for recovery of costs for Court Appointed Dependency Counsel services.

Provision X. Upon approval by the Administrative Director of the Courts, the Controller shall transfer up to \$556,000 of funding identified in Provision X of this Item to Item 0250-001-0932 for administrative services provided to the trial courts in support of the court appointed dependency counsel program.

Provision X is added to Item 0250-001-0932:

Provision X. Upon approval of the Administrative Director of the Courts, the Controller shall increase this item by an amount sufficient to allow for the expenditure of any transfer to this item made pursuant to Provision X of Item 0250-101-0932.

Amendment to and Addition of Various Budget Bill Items as follows:

Capital Outlay, Judicial Council

0250-301-3037 0250-301-3138 0250-490

It is requested that the following actions be taken:

Decrease Item 0250-301-3037 by \$97,870,000 and add a like amount to Item 0250-301-3138 to reflect a fund shift. Chapter 311, Statutes of 2008 (SB 1407) increased specific fees and fines to finance the renovation, rehabilitation, and replacement of court facilities. The fees and fines were to be deposited into an account within the State Court Facilities Construction Fund (fund 3037). In order to accurately track the revenues, Chapter 10, Statutes of 2009, Second Extraordinary Session (SB 12), allowed for the creation of the Immediate and Critical Needs Account (fund 3138). The requested action reflects proper placement of projects to be funded from the Chapter 311 (SB 1407) revenue. Therefore, the specified projects and associated funding, along with Provision 3, will be removed from Item 0250-301-3037 and added to Item 0250-301-3138.

Add Item 0250-301-3138 to reflect a new funding source for all projects that utilize funding from Chapter 311 (SB 1407). As noted above, the identified projects will be added to this item to accurately reflect project tracking for Chapter 311 (SB 1407) funds along with Provision 3. Additionally, Provisions 1 and 2 from Item 0250-301-3037 will be added to Item 0250-301-3138.

Increase Item 0250-301-3138 by a total of \$1,739,000 to provide funding for the Fairfield Old Solano Courthouse renovation project. This project will renovate the existing 29,900 square foot (sf) building into a three-courtroom facility for the civil case calendar. The county of Solano is donating this site as well as the adjacent parking lot to the state, which is valued at approximately \$3.0 million. This project addresses the court's need for additional courtrooms in Solano County and is included on the approved list of 41 immediate and critical needs projects. This project will be funded from Chapter 311 (SB 1407) revenue.

Add Provision 4 to Item 0250-301-3138 to allow the Judicial Council to enter into a lease-purchase agreement with the county of Santa Clara for the New Family Justice Center Courthouse project. This project consists of a new 193,000 sf, twenty-courtroom facility, which will consolidate services that are currently housed in six different leased facilities. The county of Santa Clara will donate a 2 1/2 acre site for the new courthouse. Additionally, the county will

finance the project costs and the Judicial Council will manage the project. Debt service will be funded by a combination of trial court and county resources. Upon retirement of debt, the county will transfer title to the facility and land to the state. This project is included on the approved list of 41 immediate and critical needs projects.

Add Item 0250-490 to reappropriate the following items:

Item 0250-301-3037 (0.5), Budget Act of 2008, for the working drawings phase of the New San Andreas Courthouse in Calaveras County. There has been a delay in site acquisition because of a sewer moratorium imposed by the San Andreas Sewer District (District). The Judicial Council and the county have been working with the District to transfer the sewer rights from several closed businesses to the new courthouse. The Judicial Council estimates that acquisition will be completed by August 2009.

Item 0250-301-3037 (1.5), Budget Act of 2008, for the working drawings phase of the New Susanville Courthouse in Lassen County. There had been a delay to this project because some acquisition activities were delayed. Acquisition has been completed and the Judicial Council anticipates preliminary plan approval in August 2009. The Judicial Council estimates they will award the construction contract by April 2010.

Item 0250-301-3037 (2), Budget Act of 2008, for the preliminary plan phase of the New Madera Courthouse in Madera County. There has been a delay in site acquisition for the following reasons: (1) the presence of an underground drainage ditch on the corner of the largest parcel, (2) unknown ownership of an alley way that bisects the selected properties, and (3) potential relocation of utilities in the alley way. The Madera Redevelopment Agency has been working to acquire the five selected parcels on behalf of the Judicial Council. The Department of General Services (DGS) has been working with the Judicial Council to resolve these issues. The Judicial Council anticipates that acquisition will be completed by June or July 2009.

Item 0250-301-3037 (3), Budget Act of 2008, for the construction phase of the New Mammoth Lakes Courthouse in Mono County. There has been a delay in completion of the schematic designs for the facility. The Judicial Council anticipates awarding the construction contract by January 2010.

Item 0250-301-3037 (5.5), Budget Act of 2008, for the preliminary plan and working drawing phases of the New Hollister Courthouse in San Benito County. There has been a delay in site acquisition while the county performed an extensive geological study to determine whether or not the selected site is buildable. This study has been reviewed by the DGS and they concur with the findings that this is an acceptable site for the new courthouse. In addition, the county is covering the increased costs for construction because of the delay in site acquisition. The Judicial Council anticipates acquisition will be completed by June 2009.

Item 0250-301-3037 (7), Budget Act of 2008, for the preliminary plan phase of the New Stockton Courthouse in San Joaquin County. There has been a delay in site acquisition because the Judicial Council needs to re-issue the Environmental Impact Report (EIR). Based on comments from the city of Stockton and the public, the Judicial Council had to revise several of the studies and conclusions in the EIR. The changes will require that it be circulated for another 45-day public comment period. The Judicial Council estimates that preliminary plans will be completed by July 2009.

- SEC. 1. Section 42102.1 is added to the Public Resources Code, immediately following Section 42102, to read:
- 42102.1. The Chrome Plating Pollution Prevention Fund is hereby abolished. All moneys remaining in the Chrome Plating Pollution Prevention Fund shall revert to the General Fund. The Secretary of the Business, Transportation & Housing Agency shall deposit all subsequent loan repayments to the Treasurer to the credit of the General Fund. The abolishment of the Chrome Plating Pollution Prevention Fund does not terminate any of the following rights, obligations, or authorities, or any provision necessary to carry out those rights, obligations, or authorities:
- (a) The repayment of loans due and payable to the department or the relevant financial company.
- (b) The obligation of the state to pay claims arising from the default of outstanding loans that have been guaranteed.
- (c) Payment to lenders for default of any outstanding guaranteed loans secured by those moneys.
  - (d) The resolution of any cost recovery action.

## **CALFED Science Program**

It is requested that: (1) Item 0540-001-6031 be increased by \$2,899,000 and Item 0540-001-0140 be amended to reflect this change, (2) Item 0540-001-6031 be amended to extend the period of availability for encumbrance or expenditure through June 30, 2014, and (3) Item 0540-492 be added to extend the period of availability for encumbrance or expenditure for funds appropriated in the 2008 Budget Act through June 30, 2013.

The Natural Resources Agency (Agency) anticipates that the CALFED Science Program grantees will need three years to complete their scientific studies. This proposal will provide adequate time for the Agency to award the grants and the grantees to complete their studies prior to the expiration of the appropriations. (See Attachments A and B.)

### California River Parkways

It is requested that Item 0540-491 be added to extend the liquidation period for River Parkway projects funded from the 2005 Budget Act. Due to a variety of factors, several projects cannot be completed by the expiration of the liquidation period. This request will provide additional time for the projects to be completed. ## Strategic Growth Council

It is requested that 2.0 positions be established to support the activities of the Strategic Growth Council. Chapter 729, Statutes of 2008 (SB 732), established the Strategic Growth Council to oversee the Urban Greening and the Sustainable Communities grant programs established under the Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006. Funding for these positions will be provided from an appropriation provided in SB 732.

## Amendment to Budget Bill Items 0555-001-0028 and 0555-001-0044, Support, Secretary for Environmental Protection

It is requested that Item 0555-001-0028 be increased by a total of \$2,732,000 Unified Program Account (UPA) and that Item 0555-001-0044 be amended to reflect this change. These resources will provide funding: (1) for Unified Program Data System and Exchange Node Support, and (2) to implement the provisions of Chapter 571, Statutes of 2008 (AB 2286). This request contains two components.

The first is a request for an increase of \$219,000 UPA and 1.0 position to support the operations of the Unified Program Data System (UPDS) and Exchange Node. Specifically, these resources will support UPDS local government web based inspection and enforcement reporting and exchange node information reporting to the United States Environmental Protection Agency.

The second is a request for an increase of \$2,513,000 UPA and 5.1 positions to implement the provisions of AB 2286, which require the Secretary for Environmental Protection to complete the Unified Hazardous Materials and Hazardous Waste Regulatory Management Program (Unified Program) information management system by January 1, 2010. AB 2286 also requires all local governments and businesses regulated by the Unified Program to report their hazardous waste inventory to the state electronically by 2013.

Provision X. The amount appropriated in Schedule (2c) shall be competitive grants to cities. No grant shall exceed \$500,000, and at least two grants shall be awarded to cities with populations of 200,000 or less. In awarding grants, the California Emergency Management Agency shall give preference to applicants that incorporate regional approaches to anti-gang activities.

Provision X. Each city that receives a grant from Schedule (2b) or (2c) shall collaborate and coordinate with area jurisdictions and agencies, including the existing county juvenile justice coordination council, with the goal of reducing gang activity in the city and adjacent areas. Each grantee shall establish a coordinating and advisory council to prioritize the use of the funds. Membership shall include city officials, local law enforcement, including the county sheriff, chief probation officer, and district attorney, local educational agencies, including school districts and the county office of education, and community-based organizations.

Provision X. Each city that receives a grant from Schedule (2b) or (2c) shall distribute at least 25 percent of the grant funds it receives to one or more community-based organizations pursuant to the city's application.

# Addition of Budget Bill Item 0690-301-0890, Capital Outlay, California Emergency Management Agency

It is requested that Item 0690-301-0890 be added in the amount of \$1,857,000 to include the replacement of the California Emergency Management Agency (CalEMA) Southern Region Facility. This project will replace the outdated, undersized Southern Region Facility, which is 7,200 square feet (sf). As proposed, the new facility will include a 30,000 sf headquarters building, a 3,000 sf warehouse, a 120-foot communication tower, and surface parking for 75 vehicles. The CalEMA anticipates entering into a 50-year lease on the land with the United States Army Corps of Engineers (USACE). This project was included in the 2009-10 Governor's Budget proposal utilizing General Fund, but was removed as part of the budget negotiations. Because the allowable uses of Emergency Management Performance Grant (EMPG) funding have been expanded, the preliminary plan phase of this project can proceed using federal funds. Future phases may be funded from the same EMPG funds if additional funds are made available by the federal government in subsequent fiscal years. Receipt and use of the preliminary plan funds are not contingent upon approval of future funding for this project. Additionally, provisional Budget Bill language will be included to allow CalEMA to negotiate a lease with the USACE.

The Board of Equalization estimates the 1 cent increase in the state rate will result in a cost shift from local government reimbursements to the General Fund of \$1,185,000 million in fiscal year 2008-09, \$6,438,000 million in 2009-10, and \$12.6 million in 2010-11.

Sales and Use Tax—1 Percent Rate Increase (Issue 032)—It is requested that Item 0860-001-0001 be increased by \$880,000 and Reimbursements be increased by \$342,000 to establish 13.3 limited-term positions (12.6 PYs) to administer the 1 cent temporary increase in the state's sales and use tax rate.

### Addition of Budget Bill Item 0911-001-0001, Support, Citizens Redistricting Initiative

It is requested that Item 0911-001-0001 be added to provide \$3.0 million for implementation of the "Voters FIRST Act" (Proposition 11) which was approved by the voters in the fall of 2008.

Proposition 11 requires that \$3.0 million be included in the 2009-10 Budget for the Citizens Redistricting Initiative. It also requires that the appropriation be made available for a three-year period for the Citizens Redistricting Commission (Commission), the Secretary of State (SOS), and the Bureau of State Audits (BSA) in carrying out their responsibilities defined in the initiative.

Therefore, it is requested that Item 0911-001-0001 be added appropriating \$3.0 million. It is also requested that Budget Bill language be added to make the funding available for three years, and to require the Department of Finance to allocate the \$3.0 million among the Commission, the SOS, and the BSA.
