## Amendment to Budget Bill Item 2320-001-0317, Support, Department of Real Estate

It is requested that Item 2320-001-0317 be increased by \$2,612,000 to provide resources for the Department of Real Estate to relocate its Sacramento headquarters to a new facility. This move is necessary due to deteriorating conditions at the current headquarters facility. According to the Department of General Services, problems with the current facility include a floor load that exceeds the engineered capacity, insufficient electrical capacity, inadequate storage capacity which results in items being placed where they create fire and life safety violations, inadequate sewer and plumbing capacity that results in flooding, and roof leaks that have led to significant water intrusion and mold issues.

This request would be funded from within existing resources, and would not result in a fee increase for licensees.

Amendment to Various Budget Bill Items, Support, Local Assistance, and Capital Outlay, Department of Transportation (Caltrans)

It is requested that the following changes be made to the items identified below:

Increased Federal Environmental Requirements (Issue 103)—It is requested that Item 2660-001-0042 be increased by \$591,000 to allow Caltrans to complete federally required environmental reviews on local and regional transportation projects. This request includes the redirection of 6.0 positions previously held vacant to achieve the 5 percent workforce cap reduction. The dollars associated with these positions were removed as part of the Governor's Budget.

In addition, this request requires changes to the following items to reflect funding of this workload from local subvention funds:

- Decrease Item 2660-102-0890 by \$591,000
- Decrease Item 2660-302-0042 by -\$591.000
- Increase Item 2660-302-0890 by \$591,000

Continuation of Indirect Cost/Incurred Cost Audit Resources (Issue 104)—It is requested that Item 2660-001-0042 be increased by \$2,890,000 for two years, limited-term, to allow Caltrans to complete federally mandated incurred cost audits and to contract with the State Controller's Office to complete indirect cost allocation plan audits for local entities receiving federal funds. This request includes the redirection of 12.0 positions previously held vacant to achieve the 5 percent workforce cap reduction. The dollars associated with these positions were removed as part of the Governor's Budget.

In addition, this request requires changes to the following items to reflect funding for local audit workload from local subvention funds:

- Decrease Item 2660-102-0890 by \$2,890,000

American Recovery and Reinvestment Act (ARRA) Program Accounting
Resources (Issue 105)—It is requested that Item 2660-001-0042 be amended as follows:

- Increase Item 2660-001-0042 by \$587,000 and redirect 7.0 positions previously held vacant to achieve the 5 percent workforce cap reduction, for one year, limited-term, in order to complete temporary ARRA-drive accounting workload in fiscal year 2011-12. The dollars associated with these positions were removed as part of the Governor's Budget.
- Decrease Item 2660-001-0042 by \$302,000 and 4.0 positions in the Local Assistance Program based on updated ARRA-related workload.
- Increase Item 2660-001-0042 by \$456,000 and redirect 5.0 positions previously held vacant to achieve the 5 percent workforce cap reduction, for one year, limited-term, in order to complete temporary ARRA-drive accounting workload in 2011-12.

Addition of Budget Bill Item 2720-490, Support, California Highway Patrol

Reappropriation of California Highway Patrol Enhanced Radio System (CHPERS) (Issue 101)—It is requested that Item 2720-490 be added to reappropriate \$24,120,000 in state operations for the California Highway Patrol Enhanced Radio System (CHPERS) (see Attachment 1). This will pay for installation of radio and related equipment at remote sites throughout the state to complete the CHPERS project. Due to a number of factors, including the late budget, furloughs, and travel limitations the Public Safety Communication Office of the California Technology Agency, was unable to complete this work before winter weather caused delays at these remote locations. Therefore, it is necessary to extend the availability of these funds for one year to ensure completion of the enhanced statewide radio system.
