**Addition of Budget Bill Item 3125-494, Capital Outlay, California Tahoe Conservancy**

**Extension of Liquidation Period—Habitat Conservation Fund**

It is requested that Item 3125-494 be added to extend the liquidation period of a 2006 appropriation. (See Attachment I.) The 2006 Budget Act appropriated \$369,000 Habitat Conservation Fund to the California Tahoe Conservancy (Conservancy) for restoration projects in the Lake Tahoe basin. Of that amount, approximately \$72,000 has not been expended due to a change of project scope for a restoration plan for the Upper Truckee River. Therefore, it is necessary to extend the liquidation period until June 30, 2013 to allow the Conservancy to complete environmental documentation and site planning.

**Amendment to Budget Bill Items 3360-001-0465 and 3360-001-0382, and Addition of Budget Bill Item 3360-001-0115, Support, Energy Resources Conservation and Development Commission**

**California Solar Initiative (Issue 100)**

It is requested that Item 3360-001-0382 be increased by \$250,000 and that Item 3360-001-0465 be amended to reflect this change to provide a two-year extension for limited-term staffing to perform ongoing California Solar Initiative (CSI) workload. Position authority will be accommodated by filling existing vacancies.

The CSI required the California Energy Resources Conservation and Development Commission (Energy Commission) to initiate public proceedings to determine conditions when solar energy systems should be required for new buildings. The CSI also required the Energy Commission, in collaboration with other utility entities, to identify the criteria for solar energy installations to receive ratepayer subsidies.

The Energy Commission determines the conditions when photovoltaic systems should be mandatory under state building standards. Additionally, the Energy Commission would establish a program requiring builders to offer photovoltaic systems as an optional feature for all new subdivisions, and implement a program to allow builders to install higher levels of photovoltaics on other types of building projects (e.g., low-income housing, commercial, and industrial buildings).

**Fund Shift from Energy Resources Programs Account to the Air Pollution Control Fund (Issue 101)**

It is requested that Item 3360-001-0465 be decreased by \$483,000 and that Item 3360-001-0115 be added in the amount of \$483,000, to shift funds from the Energy Resources Programs Account to the Air Pollution Control Fund to fund 4.0 staff and resources related to AB 32 activities.

These positions support Climate Action Team activities and provide technical assistance to the Air Board on a broad range of AB 32 energy-related sources of Green House Gas (GHG) emissions.

**Amendment to and Addition of Various Budget Bill Items, Support, Department of Conservation**

**Plan of Financial Adjustment Change**

It is requested that trailer bill language be enacted to enable the Department of Conservation (Conservation) to use the Oil, Gas, and Geothermal Administrative Fund as its main appropriation, or clearing account (see Attachment 1). Currently, Conservation uses the General Fund as its clearing account which has a \$4.5 million annual appropriation. Historically, Conservation used the Beverage Container Recycling Fund as its clearing account because of the available cash for payroll and reimbursement contracts. However, that fund moved to the Department of Resources, Recycling, and Recovery in January 2010. Enabling Conservation to use the Oil, Gas, and Geothermal Administrative Fund is consistent with the common practice recommended by the State Controller's Office that a department should use the fund with the largest appropriation as its clearing account.

**Bond Funding Technical Corrections**

It is requested that Item 3480-001-6031 be decreased by \$1,176,000, Item 3480-001-6051 be decreased by \$165,000, and that Item 3480-001-0001 be amended to reflect these changes to align bond appropriations with expected expenditures. It is also requested that Item 3480-492 be added to reappropriate Proposition 84 funds for the conservation of agricultural and open space land resources (see Attachment 2).

**Addition of Budget Bill Items 3500-404 and 3500-405, Support,  
Department of Resources Recycling and Recovery**

**Extension of Repayment Dates of Existing Loans**

**Issue 404**—It is requested that Item 3500-404 be added to extend the loan repayment date from June 30, 2012 to June 30, 2014 for a \$39.0 million loan from the Glass Processing Fee Account to the General Fund. This loan was authorized in the 2003 Budget Act with a repayment date of June 30, 2009. The loan repayment date was subsequently extended to June 30, 2012 in the 2008 Budget Act. (See Attachment.)

**Issue 405**—It is requested that Item 3500-405 be added to extend the loan repayment from June 30, 2012 to June 30, 2014 for a \$27.0 million loan from the PET Processing Fee Account to the General Fund. This loan was authorized in the 2003 Budget Act with a repayment date of June 30, 2009. The loan repayment date was subsequently extended to June 30, 2012 in the 2008 Budget Act. (See Attachment.)

## **Budget Bill Language**

### **Add Item 3500-404**

The amount loaned pursuant to Provision 1 of Item 3480-011-0269, Budget Act of 2003 (Ch. 157, Stats. 2003), as amended by Item 3480-401 of Chapters 268 and 269 of the Statutes of 2008, shall not be required to be repaid until June 30, 2014. The Director of Finance shall order the repayment of all or a portion of this loan if he or she determines that either of the following circumstances exists: (1) The fund or account from which the loan was made has a need for the moneys; or (2) there is no longer a need for the moneys in the fund or account that received the loan.

### **Add Item 3500-405**

The amount loaned pursuant to Provision 1 of Item 3480-011-0278, Budget Act of 2003 (Ch. 157, Stats. 2003), as amended by Item 3480-401 of Chapters 268 and 269 of the Statutes of 2008, shall not be required to be repaid until June 30, 2014. The Director of Finance shall order the repayment of all or a portion of this loan if he or she determines that either of the following circumstances exists: (1) The fund or account from which the loan was made has a need for the moneys; or (2) there is no longer a need for the moneys in the fund or account that received the loan.

**Add Budget Bill Items 3540-301-0668 and 3540-496, Capital Outlay, Department of Forestry and Fire Protection**

It is requested that Item 3540-301-0668 be added to provide \$500,000 for the following:

Add \$300,000 for acquisition of the Blanchard Forest Fire Station and adjacent property. The Department of Forestry and Fire Protection (CAL FIRE) has operated this ten-acre site since 1944 under a long-term lease, which is set to expire on December 31, 2012. The Lessor has indicated the lease will not be renewed or extended and has instead put the property up for sale. Acquisition of this site by CAL FIRE is needed to maintain the current level of emergency response services in this area. The failure to secure this site could result in increased response times and the need to expedite the planned replacement of the existing facility.

Add \$200,000 for acquisition of a purchase option for a new site for the relocation of the Shasta-Trinity Unit Headquarters. This facility was constructed in 1938 on state-owned property located outside the City of Redding but, because of urbanization over the years, is now located within the city's urban core, which has resulted in increased emergency response times. In addition, the current site is too small to replace the existing old and under-sized facilities.

For several years, CAL FIRE has been searching for a new site and recently located a partially-improved 6.63-acre site that would appear to be well-suited for the relocation of the Shasta-Trinity Unit Headquarters. While the city has expressed a strong desire to acquire the existing CAL FIRE site, and there is existing legislation authorizing the sale, exchange, lease, or any combination thereof for the relocation of this facility, the acquisition of a purchase option for a new site is needed while the necessary project evaluations are completed and future project funding is secured.

It is further requested that the following provisional language be added to clarify that the acquisition funds may be used to acquire certain less than fee property rights:

1. Notwithstanding any other provision of law, the funds appropriated in this item may be used to acquire less than fee interests in real property, including a purchase option or a lease with purchase option, subject to State Public Works Board approval.

It is also requested the Item 3540-496 be added to revert the unencumbered balance of the funding for the following projects:

Item 3540-301-0001, Budget Act 2006, as reappropriated by Item 3540-491, Budget Acts of 2007, 2008, and 2009, and partially reverted by Item 3540-496, Budget Act of 2008

1. Statewide: Construct Communications Facilities—Working Drawings and Construction

Item 3540-301-0001, Budget Act of 2007, as reappropriated by Item 3540-491, Budget Act of 2009, and Item 3540-493, Budget Act of 2010

2. Batterson Forest Fire Station: Relocate Facility—Construction

This reversion is needed to realize \$5,264,450 in General Fund savings assumed in the Governor's Budget, plus \$101,135 in additional General Fund savings recently indentified, and would expedite the General Fund benefit. These savings are a result of construction costs being less than the state's estimates.

**Amendment to and Addition of Various Budget Bill Items, Support, Department of Fish and Game**

**Office of Oil Spill Prevention and Response**

It is requested that Item 3600-001-0320 be increased by \$2.6 million and that Item 3600-001-0001 be amended to reflect this change to correct a miscalculation in the development of the Department of Fish and Game's (DFG) budget. The fund condition statement for the Oil Spill Prevention and Administration Fund inadvertently excluded a repayment of a prior year cash flow loan. Consequently, the fund balance presented was inaccurate. This request will restore \$2.6 million in Oil Spill Prevention and Administration Fund expenditure authority that was reduced as a result of the incorrect fund balance.

**Big Game Management Account**

It is requested that Item 3600-001-0200 be increased by \$1,490,000, and that Item 3600-001-0001 be amended to reflect this change to implement Chapter 408, Statutes of 2010 (SB 1058). SB 1058 created the Big Game Management Account within the Fish and Game Preservation Fund in an effort to consolidate three existing subaccounts: Deer, Bighorn Sheep, and Wild Pig. Pursuant to the bill, all revenues deposited into the existing subaccounts are to be deposited into the Big Game Management Account beginning January 1, 2011. Additionally, SB 1058 redirected revenues from the sale of bear, antelope, and elk tags from the non-dedicated Fish and Game Preservation Fund into the Big Game Management Account. The DFG will use the requested funds in the Big Game Management Account to manage and conserve big game species.

**Various Technical Corrections**

It is requested that Item 3600-001-6051 be decreased by \$17,025,000, and that Item 3600-001-0001 be amended to reflect this change to align bond appropriations with expected expenditures. It is also requested that Item 3600-492 be added to reappropriate Proposition 84 and Salton Sea Restoration Fund appropriations for Salton Sea restoration projects (see Attachment 1).

**Extension of Liquidation Period—Proposition 12**

It is requested that Item 3640-493 be added to extend the liquidation period of Proposition 12 funds. (See Attachment I.) The 2000 Budget Act appropriated approximately \$14.6 million to the San Joaquin River Conservancy (Conservancy) through the Wildlife Conservation Board (WCB) for projects and acquisitions related to the San Joaquin River Parkway Master Plan. The funds were reappropriated in Budget Acts of 2003 and 2006. To date, approximately \$145,000 of the funds have not been liquidated as a result of the December 2008 bond freeze. It is necessary to extend the liquidation period to allow the Conservancy to continue to implement the San Joaquin River Parkway Master Plan.

**Extension of Liquidation Period—Habitat Conservation Fund and Proposition 50**

It is requested that Item 3640-492 be added to extend the liquidation periods of the Habitat Conservation Fund and the associated Proposition 50 transfer. (See Attachment II.) The 2004 Budget Act transferred \$21.0 million from Proposition 50 funds to the Habitat Conservation Fund (HCF) and appropriated the \$21.0 million HCF to the WCB to implement the Wildlife Conservation Act. The 2009 Budget Act extended the liquidation periods of these funds as a result of the December 2008 bond freeze. It is necessary to further extend the liquidation periods of these funds until June 30, 2013 because of delays caused by permitting requirements that only allow restoration work to be completed in the summer.

**Amendment to Budget Bill Items 3680-101-0516 and 3680-301-0516, Local Assistance and Capital Outlay, Department of Boating and Waterways**

It is requested that Item 3680-301-0516 be increased by \$3,250,000 to reflect the state's share of the construction phase of the Channel Islands Boating and Instruction Safety Center (BISC) project (see related issue 3680-101-0516 below). The Channel Islands BISC is a continuing project that has been stalled for several years because of litigation that has recently been resolved. The project is a joint venture between The Department of Boating and Waterways (Boating) and the County of Ventura. Construction costs are estimated at \$6.0 million, with Boating contributing up to \$3,250,000 and the county contributing the balance. The county funds include \$1.8 million in donations that will expire after 2011. If the project is delayed and these donations are no longer available, it is unlikely that the county would be able to fund its share of the project.

Furthermore, it is also requested that Item 3680-101-0516 be decreased by \$3,250,000 to accommodate the corresponding increase in capital outlay funding for the Channel Islands BISC project. These local assistance funds were included in the Governor's Budget for planning, California Environmental Quality Act funding, and reassessed loan and grant amounts. This request will redirect these local assistance funds for the completion of the Channel Islands BISC project and can be deferred without significant programmatic impacts.

**Fund Shift to Maintain Baseline Budget**

It is requested that Item 3760-001-6051 be increased by \$1.6 million, Item 3760-001-6076 be increased by \$841,000, and Item 3760-001-0565 be decreased by \$2,441,000 to reflect a one-time fund shift from the State Coastal Conservancy Fund (Conservancy Fund) to Proposition 84 funds.

In an effort to maximize the amount of bond funds allocated to projects, the State Coastal Conservancy (Conservancy) has used the Conservancy Fund in lieu of the bond funds to administer its bond funded projects. As a result of a declining fund balance, the Conservancy Fund is unable to continue to provide the existing level of support funding.

**Office of Historic Preservation Database—Extension of Liquidation Period**

It is requested that Item 3790-493 be added to extend the liquidation period of up to \$163,000 General Fund for Parks' Office of Historic Preservation (OHP) Database Rehost Project. (See Attachment I.) This information technology project was initiated in 2008 to replace the legacy OHP database. To date, all project costs have been absorbed within Parks' existing budget. Due to delays caused by the contractor, it is necessary to extend the liquidation period of the requested funds to allow Parks to complete the upgrade.

**Local Assistance Funding—Proposition 40**

It is requested that Item 3790-103-6029 be added in the amount of \$108,250,000 Proposition 40 funds for local assistance grants. (See Attachment II.) Proposition 40 provides funding for a specified list of grant programs and provides a total of eight years (until June 30, 2011) for grantees to complete their projects. Proposition 40 also states that by July 1, 2011, any unspent grants shall revert to the fund. As a result of the December 2008 bond freeze, the grantees will not be able to fully complete their projects by June 30, 2011. This request will provide a new appropriation to allow the grantees to complete their projects, as intended by Proposition 40.

**California State Railroad Museum—Reappropriation**

It is requested that Item 3790-490 be amended to reappropriate \$11.6 million, including \$6.6 million Proposition 40 funds and \$5.0 million in reimbursements. (See Attachment III.) Chapter 689, Statutes of 2008 (AB 2945), provides \$11.6 million for the development of a proposed railroad technology museum. The funding will allow the California State Railroad Museum Foundation (Foundation) to acquire two former industrial buildings (known as the Boiler Shop) at the Downtown Sacramento Railyards.

After the proposed acquisition, the Foundation would renovate the buildings to house the proposed Railroad Technology Museum, consistent with the master plan of the California State Railroad Museum. As a result of a change of ownership of the industrial buildings, the Foundation was unable to complete the acquisition as scheduled. However, Parks expects the acquisition to be completed by June 30, 2011, and this extension request will ensure the funds are available to complete the acquisition in case of further delays.

**Amendment to and Addition of Various Budget Bill Items, Support, Local Assistance, and Capital Outlay, Department of Water Resources**

**Salton Sea Restoration**

It is requested that Item 3860-001-0001 be amended by increasing reimbursements by \$4.2 million. The Department of Water Resources (DWR) is under contract with the Department of Fish and Game and the Wildlife Conservation Board to support the state's obligations for Salton Sea restoration, mitigation, and monitoring activities as a result of the Colorado River Quantification Settlement Agreement. This proposal will allow DWR to continue the Salton Sea Restoration Program through June 30, 2013. (See Attachment A.)

**Davis Dolwig Cost Allocation Study**

It is requested that Item 3860-011-0516 be added in the amount of \$34,000 to provide funding for a study to examine DWR's cost allocation methodology for determining the recreational benefits at State Water Project facilities. A recent independent study identified deficiencies in DWR's cost allocation methodology in calculating water supply and recreational benefits. A new study to address these deficiencies is estimated to cost \$600,000. The state's share of the cost, under the current methodology, is \$34,000. This request will provide 5.7 percent of the total expected costs for the project in fiscal year 2011-12, consistent with the provisions of the Davis Dolwig Act. The remaining share would be charged to State Water Project (SWP) contractors. The total cost of all repairs at Lake Perris is projected to be approximately \$300.0 million. Under the current cost allocation methodology, the SWP cost share will be approximately \$280.0 million. Budget Bill language will allow for an adjustment of the cost sharing formula based on the new cost allocation study to be completed in 2012. (See Attachment C.)

These programs have been delayed for a variety of reasons, including contracting delays, delays in closeout activities, and timing issues related to the bond freeze. This request will provide additional time for these projects to be completed.

#### Reversion

It is requested that Item 3860-495 be added to revert \$6,777,476 Water Security, Clean Drinking Water, Coastal and Beach Protection Fund of 2002 (Proposition 50) appropriated in the 2007 and 2009 Budget Acts. This action will remove funding that is no longer necessary.

#### **Reappropriations and Extension of Liquidation Requests: Capital Outlay (See Attachment D.)**

##### Reappropriations

It is requested that Item 3860-492 be added to reappropriate funding for the following projects:

- West Sacramento Early Implementation Project – Reappropriation is needed to provide the state's cost-share for levee improvement work performed by the West Sacramento Area Flood Control Agency. Information collected on subsurface conditions and site constraints has forced the local agency to alter its work program and has delayed the work schedule.
- Lower Cache Creek, Yolo County, Woodland Area Project – Reappropriation is needed to continue a feasibility study to examine viable alternatives to reduce flood risk. The project has been delayed while federal and local cost sharing agreements have been negotiated and finalized.
- Merced County Streams Project Bear Creek Unit – Reappropriation is needed to develop the Merced Streams Group General Reevaluation Report in coordination with the United States Army Corps of Engineers (Corps). The project was delayed due to the lack of dedicated federal and local funds. Local partners and the Corps have now identified available funds for the project to move forward.
- Systemwide Levee Evaluations and Repairs – Reappropriation is needed to continue to evaluate and address deficiencies in the state's levees, weirs, bypasses, and facilities of the State Plan of Flood Control. Overall schedules have been delayed due to state cash-flow issues, project interruptions, protracted permitting requirements, and project planning issues with Corps.
- Sutter Bypass East Water Control Structures – Reappropriation is needed to complete the replacement of Weir 2 and Willow Slough Weir structures. The project was delayed when the plans had to be changed to address foundation stability and seepage issues.
- Feather River Early Implementation Project – Reappropriation is needed to continue rehabilitation of the west levee of the Feather River. The project was delayed to ensure compliance with the Central Valley Flood Protection Plan.

It is requested that Item 3860-493 be added to extend the liquidation for the following project:

- Upper Sacramento River Area Levee Reconstruction Project – Construction of the project is complete. However, costs remain for closeout procedures and outstanding invoices. An extension of liquidation is necessary to fulfill contractual obligations to federal and local partners.
