It is requested that Item 8320-001-0001 be increased by \$1,970,000 and 13.1 positions and reimbursements be increased by \$174,000. It is also requested that Item 7350-001-0001 be decreased by \$1,970,000 and 13.4 positions and reimbursements be decreased by \$174,000 to provide ongoing support to transfer the State Mediation and Conciliation Service (SMSC) program of the Department of Industrial Relations to the Public Employment Relations Board (PERB).

This transfer would consolidate public-sector labor relation functions under PERB and would result in a net-zero change between the two budget items and a reduction in 1.0 limited-term position. The Labor and Workforce Development Agency, which initiated the request, maintains that SMCS is a better organizational fit under PERB. The proposal is consistent with efforts to streamline state government through consolidations and operational efficiencies.

The Financial Information System for California (FI\$Cal) will bring enhanced functionality, automation, transparency, and flexibility to the state's decision makers enabling California to be more effective in delivering services to constituents, while simultaneously providing increased responsiveness to the needs of California businesses and local governments.

The Governor's Budget included \$130,613,000 for the FI\$Cal Project of which \$91,536,000 was set aside until such time the prime vendor was selected and specific funding needs were identified. Total cost of the Project came in lower than expected, and is now estimated at \$616,805,000. Of this amount, approximately \$94,594,000 will have been expended by the end of the current fiscal year. The Project cost proposed for fiscal year 2012-13 is \$88,978,000 and 86.0 positions (72.0 new Project positions and 14.0 new Partner Agency positions {58.5 PYs}). This request allocates the set aside to the appropriate items of expense and results in an overall net reduction of \$41,635,000 (\$11,466,000 General Fund). The costs reflected in this letter are consistent with the required report to the Legislature submitted March 2, 2012 and the 90-day legislative review per Government Code section 15849.21.

It is requested that Item 8880-001-9737 be increased by \$26,747,000 and 72.0 new Project positions (49.6 PYs) to provide resources for the first full fiscal year of the System Integration contract, and Item 8880-001-9740 be decreased by \$3,077,000 to reflect pending negotiations for potential federal reimbursement.

It is requested that Item 8880-011-0001 be increased by \$26,747,000 to conform to the action above.

It is requested that Item 9210-110-0001 be decreased by \$2,912,000 to reflect elimination of Mono County's share of funding originally proposed as reimbursement for fiscal year 2010-11 shortfalls related to the Sales and Use Tax Countywide Adjustment authorized by Revenue and Taxation Code section 97.68, and the Vehicle License Fee Adjustment Amount authorized by Revenue and Taxation Code section 97.70. This adjustment also reflects that the Governor's Budget inadvertently reversed the proposed appropriations for Amador and Mono Counties.

The proposed appropriation for Mono County was based on information available when the Governor's Budget was prepared. Mono County has since determined they did not experience a shortfall in 2010-11. Therefore, we are requesting the \$2,912,000 proposed appropriation for Mono County be removed.

We also request the provisional language in the Item be amended as follows:

- 1. The amount appropriated in this item is to reimburse the counties county of Amador and Mone, and the cities located therein, for shortfalls incurred in the 2010-11 fiscal year related to the Sales and Use Tax Countywide Adjustment Amount authorized by Revenue and Taxation Code Section 97.68, and the Vehicle License Fee Adjustment Amount authorized by Revenue and Taxation Code Section 97.70.
- 2. No later than October 1, 2012 each the county shall submit to the Department of Finance a countywide claim detailing the shortfall incurred in the 2010-11 fiscal year by the county, and by each city located therein, in relation to each of the specified Revenue and Taxation Code sections. The Department of Finance shall review the claims for accuracy, and upon determining the claims are is accurate and complete, shall forward them it to the State Controller for payment.
- 3. The amount provided to Amador County, and the cities located therein, shall not exceed \$2,912,000-\$1,524,000, and the amount provided to-Mono-County, and the cities located therein, shall not exceed \$1,524,000. If these this amounts is are insufficient to fully backfill the shortfalls incurred by the eligible claimants, the State Controller

shall prorate the amount provided to each claimant pursuant to Provision 2.
