Amendment to Budget Bill Item 3540-001-0001 and Addition of Item 3540-001-0115, Support, Department of Forestry and Fire Protection

#### Carbon Sequestration Research and Analysis

It is requested that Item 3540-001-0115 be added in the amount of \$290,000 (see Attachment 1) and that Item 3540-001-0001 be amended to reflect this change to enable the Department of Forestry and Fire Protection (CAL FIRE) to conduct research studies and technical analyses as required by Chapter 534, Statutes of 2010 (Assembly Bill (AB) 1504). AB 1504 requires the Board of Forestry to ensure that its rules and regulations that govern timber harvesting consider the capacity of forest resources to sequester carbon in an effort to meet greenhouse gas emission targets outlined in the Global Warming Solutions Act of 2006, Chapter 488, Statutes of 2006 (AB 32). CAL FIRE will implement various strategies to measure the effect of the harvesting of commercial tree species on the state forests' sequestration target contained in AB 32.

#### **Unemployment Insurance Funding**

It is requested that Item 3540-001-0001 be increased by \$5,300,000 to fund increased costs associated with Unemployment Insurance (UI) for seasonal firefighters. Until 2009, CAL FIRE was responsible for payment of 26 weeks of UI benefits. However, Chapter 22, Statutes of 2009 (AB X3 23) extended the Federal-State Extended Duration Benefits. This extension increased the duration of UI benefits to a total of 99 weeks of which CAL FIRE is responsible for the payment of an additional 20 weeks. Although CAL FIRE's budget includes funding for this previously approved UI benefit extension, the department is experiencing increased UI payments because of an additional federal UI extension passed in late December 2011.

#### Firefighter I Separation Costs

It is requested that Item 3540-001-0001 be increased by \$2,149,000 to cover ongoing costs associated with the annual separation of seasonal Firefighter I staffing. The increase is the result of a negotiated settlement in a lawsuit which challenged CAL FIRE's practice of excluding certain compensation from the calculations. The requested funding is based on a 5-year average of firefighter separations within the department.

#### Air Quality Compliance

It is requested that Item 3790-001-0263 be increased by \$4,802,000 and that Item 3790-001-0392 be amended to reflect this change to provide funding to implement dust management plans at various state vehicular recreation areas for compliance with fugitive dust emission regulations.

#### Water Quality Compliance

It is requested that Item 3790-001-0263 be increased by \$1,033,000 and that Item 3790-001-0392 be amended to reflect this change to provide funding to implement a storm water management plan and to complete a metal assessment plan at Carnegie State Vehicular Recreation Area for compliance with water quality standards.

#### **Capital Outlay Funding**

It is requested that Item 3810-301-6029 be added in the amount of \$2,845,000 and Item 3810-301-6031 be added in the amount of \$1,385,000 to continue Proposition 40 and Proposition 50 capital outlay programs. (See Attachments I and II.) The funds will be used for high priority projects in the Santa Monica Mountains Zone and the Rim of Valley Trail Corridor, consistent with the adopted Santa Monica Mountains Conservancy Work program. In addition, Budget Bill Language is proposed to authorize the expenditure of the funds only after verification that the Santa Monica Mountains Conservancy (Conservancy) has adequately addressed specified bond audit findings.

Currently, the Conservancy has four positions with one position designated to its Proposition 84 projects. Without the requested extension, the Conservancy will have no designated staff to work on its Proposition 84 projects beginning in 2012-13. Therefore, it is necessary to provide the requested extension for the Conservancy.

It is requested that Item 3835-496 be added to revert Proposition 84 program delivery funding to fund the extension. (See Attachment I.)

# **Proposition 1E and Proposition 84 Programs**

It is requested that Item 3860-001-6051 be increased by \$69,000, Item 3860-001-6052 be increased by \$108,306,000, and that Item 3860-001-0001 be amended to reflect these changes. Additionally, it is requested that Item 3860-101-6051 be added (Attachment 1) in the amount of \$249,000 and Item 3860-101-6052 be added (Attachment 2) in the amount of \$274,957,000.

The Department of Water Resources (DWR) requests \$280,475,000 to support the FloodSAFE California program. Included in this request are \$69,000 Proposition 84 and \$108,306,000 Proposition 1E for state operations, and \$172,100,000 Proposition 1E for local assistance. The DWR implements the FloodSAFE program, an initiative developed to reduce flood risk in California. The FloodSAFE program is funded by Proposition 1E and Proposition 84 in seven functional areas. FloodSAFE's goals are to reduce flood risk to people and property, develop sustainable flood management systems for the future, and reduce the adverse consequences of floods when they occur.

The DWR also requests to fund Stormwater Flood Management (SWFM) grants from Proposition 1E and Integrated Regional Water Management (IRWM) grants from Proposition 84 and is combining the program implementation of SWFM and IRWM funds since they are for grant programs with complementary purposes. The DWR will use \$102,857,000 Proposition 1E for SWFM projects which are not part of the state plan of flood control, have at least 50 percent non-state cost share, and are consistent with any applicable IRWM plan.

Proposition 84 includes \$1.0 billion for grants for the IRWM Program. The IRWM Grant Program is a joint program between DWR and the State Water Resources Control Board which provides funding for projects to protect communities from drought, protect and improve water quality, and reduce dependence on imported water. Proposition 84 specifies \$900.0 million be allocated to 11 regions, and leaves \$100.0 million unallocated. Of the \$100.0 million in unallocated IRWM funds, only \$25,000 remains unappropriated and \$224,000 has been returned. The DWR seeks a new appropriation for the combined total of \$249,000 to be used for new IRWM projects.

# **Capital Outlay Flood Projects**

It is requested that Item 3860-301-6052 be added in the amount of \$140,771,000 and reimbursements be added in the amount of \$8,579,000 (see Attachment 3). Additionally, it is requested that Item 3860-302-6052 be added in the amount of \$20.0 million (see Attachment 4). All proposed Capital Outlay expenditures are included in DWR's comprehensive Planned Bond Expenditures Table which provides for planned expenditures through the anticipated life of the Prop 1E bond. This request will allow DWR to continue various existing capital outlay flood control projects and feasibility studies as part of the overall state flood plan.

### Reappropriations, Reversions, and Technical Adjustments: Non-Capital Outlay

### **Technical Adjustments**

It is requested that Item 3860-001-0404 be decreased by \$709,000, Item 3860-001-6051 be increased by \$1,683,000, Item 3860-001-6052 be increased by \$1,137,000, and that Item 3860-001-0001 be amended to reflect these changes. The DWR requests state operations baseline funding from the Central Valley Project Improvement Subaccount be reduced to reflect the reduced need for program administration. Additionally, DWR requests restoring baseline funding for Proposition 84 contract services and Proposition 1E fund tracking, auditing, and reporting.

### Reappropriations

These items provide funding for projects that have been delayed for a variety of reasons, including federal and local funding issues, design changes, and permitting requirements. The request will provide additional time for the projects to be completed.

A number of projects cannot be completed within the timeframes allowed by their original appropriations. These programs have been delayed for a variety of reasons, including contracting delays, delays in closeout activities, and timing issues related to the bond freeze. This request will provide additional time for these projects to be completed.

### Reversions

It is requested that Item 3860-496 be added (Attachment 7) to revert \$1,250,149 Proposition 50 funds, \$302,933 Proposition 84 funds, and \$65,357,000 Proposition 1E funds. This action will remove Proposition 50 and Proposition 84 funds that are no longer necessary or have been returned.

The reversion of \$45,357,000 Proposition 1E funds reflects DWR's efforts to allocate the remaining Stormwater funds after Chapter 1, Statutes of 2008 (SB 1 second extraordinary session) allocated and earmarked much of the funding. This Chapter appropriated \$150.0 million for SWFM grants and specified that at least \$100.0 million be available "for projects that address immediate public health and safety needs (and) strengthen existing flood control facilities to address seismic safety issues." The DWR made additional grant awards in December 2011 based on the criteria outlined in this Chapter.

The demand for these funds was significantly less than the \$100.0 million allocated amount due to the lack of projects meeting this Chapter's specifications regarding seismic issues. While all qualified seismic projects have been funded, \$45,357,000 remains unallocated. The DWR requests to revert this amount and provide a new appropriation for SWFM projects without the project-type narrowing language restricting the funds to seismic issues.

Additionally, DWR requests the reversion of \$20.0 million Proposition 1E in order to re-characterize the funds as capital outlay. The Chapter appropriated \$135.0 million Proposition 1E to DWR for essential emergency preparedness supplies and projects. Recent engineering and economic modeling analysis have demonstrated a high relative value of constructing and equipping emergency response facilities in specific Delta locations. The DWR has updated the Floodsafe Five-year Capital Outlay Plan to include these projects. As such, it is necessary to revert a portion of the state operation appropriation as to make it available for use as capital outlay.

### Extension of Liquidation

It is requested that Item 3860-494 be added (Attachment 9) to extend the liquidation period through June 30, 2015 for the Systemwide Levee Evaluations and Repairs Project, originally appropriated in 2007. Habitat constraints, inclement weather, and right-of-way issues have impacted the completion of this project. The protection of specific species during designated months has disrupted construction schedules and forced delays. Additionally, the extremely wet winter of 2010-11 limited opportunities to complete field work.

The funds appropriated in this item may be expended for relocations and acquisition of land, easements, and rights-of-way, including, but not limited to, borrow pits, spoil areas, and easements for levees, clearing, flood control works, and flowage, and for appraisals, surveys, and engineering studies necessary for the completion or operation of the projects in the Sacramento and San Joaquin watersheds as authorized by Section 8617.1 and Chapters 1 (commencing with Section 12570), 2 (commencing with Section 12639), 3 (commencing with Section 12800), 3.5 (commencing with Section 12840), and 4 (commencing with Section 12850) of Part 6 of Division 6 of the Water Code. Notwithstanding paragraph (1) of subdivision (a) of Section 12582.7 and Section 12585.5 of the Water Code, prior to state and federal authorization of the project and appropriation of federal construction funds by Congress and subsequent to submittal of a report to the Legislature pursuant to Section 12582.7 of the Water Code; the amounts appropriated in this item may be expended for state costs associated with preconstruction design and engineering work conducted by the federal government and others.
- Funds appropriated in this item may also be expended for the evaluation, repair, rehabilitation, reconstruction, or replacement of flood protection facilities consistent with subdivision (a) of Section 5096.821 of the Public Resources Code; for study, evaluation, improvement, and addition of facilities to provide enhanced levels of flood protection consistent with subdivision (b) of Section 5096.821 of the Public Resources Code; or for

- the protection, creation, and enhancement of flood protection corridors and bypasses consistent with Section 5096.825 of the Public Resources Code.
- 3. Funds appropriated in this item may also be used for any of the following:
  - (a) Advances to the federal government, or payments to the federal government or others for incidental construction or reconstruction items that are an obligation of the state in connection with the completion or operation of the projects and for materials.
  - (b) Flood protection-related activities of the state associated with construction, reconstruction, relocation, or alterations to levees, other flood control works, highways, railroads, bridges, power lines, communication lines, pipelines, irrigation works, and other structures and facilities, and for appraisals, surveys, mitigation and engineering studies incidental thereto.
  - (c) Flood protection-related planning studies, surveys, preliminary plans, drawings, acquisitions, relocations, rights-of-way, construction, construction supervision, contract administration, and other work activities to be performed by Department of Water Resources personnel and contractors for completion of the projects.
- 4. Funds appropriated in this item may be used to implement the projects identified in this item without arrangements with the federal government while making reasonable efforts to obtain funding from the federal government in advance or by arranging to perform work which is a federal responsibility prior to the availability of federal appropriations with the intention that the costs will be reimbursed or eligible for credit by the federal government as provided in Public Law 99-662, Section 104, November 17, 1986; Public Law 90-488, Section 215, August 13, 1968; or other applicable law.
- 5. Notwithstanding Section 26.00, funds may be transferred, with the approval of the Department of Finance, among projects specified in this item and other Department of Water Resources flood protection-related major capital outlay projects with an active appropriation. The Director of Finance shall notify, in writing, the chairpersons of the committees in each house of the Legislature that consider appropriations and the Chairperson of the Joint Legislative Budget Committee, within 30 days or such lesser time as the chairperson of the joint committee, or his or her designee, may determine, prior to any transfer.
- 6. Payments from a local sponsor may be received by the Department of Water Resources and may be advanced to the federal government.

# Proposition 50—Delta Science Program

It is requested that Item 3885-001-0001 be amended to extend six limited-term positions. The 2008-09 Budget Act provided six limited-term positions until June 30, 2012 for the Delta Stewardship Council's Delta Science Program. This request will extend the positions for an additional two years, until June 30, 2014. No new funding is necessary to implement this request.

The proposed 2012-13 Governor's Budget reappropriates \$5.9 million of unencumbered Proposition 50 funds through June 30, 2014.
