**Amendment to Budget Bill Item 7502-001-9730, Support, California Department of Technology**

It is requested that Item 7502-001-9730 be increased by \$2,987,000 in fiscal year 2014-15 for support of the CalCloud services offering. CalCloud allows California Department of Technology (CalTech) customers to manage information technology in a virtualized, or cloud environment. Under this model, CalTech customers can more efficiently ramp up data capacity needs through a shared server bank which remains onsite, and secure at CalTech's data center. Notification of the CalCloud services offering was previously provided to the Joint Legislative Budget Committee in 2013-14. This request is being submitted for CalCloud's ongoing costs.

**Amendment to Various Budget Bill Items, Support, Department of General Services**

**California Records and Information Management (CalRIM) Program Transfer**

**(Issue 100 and Issue 900)**—It is requested that Item 7760-001-0666 be decreased by \$432,000 and 3 positions to reflect the proposal in the Governor's January budget to transfer the CalRIM program from the Department of General Services (DGS), Office of State Publishing to the Secretary of State. This request also includes corresponding reductions to departments statewide to reflect the reduction in the Statewide Surcharge collected by the DGS. The net impact of these statewide adjustments is \$259,000 General Fund and \$173,000 other funds.

**Mercury Cleaners Site Remediation (Issue 101)**—It is requested that Item 7760-001-0001 be increased by \$2,652,000 and that Item 7760-001-0666 be amended to reflect this change to fund the continued remediation of the Mercury Cleaners building located at 1419 16<sup>th</sup> Street, Sacramento, and to fund additional site investigation and assessment of the surrounding areas. This property is owned by the state.

**Golden State Financial Marketplace (GS \$SMART) Program (Issue 103)**—It is requested that Item 7760-001-0026 be increased by \$1,000, Item 7760-001-0328 be increased by \$10,000, Item 7760-001-0602 be increased by \$12,000, Item 7760-001-0666 be increased by \$204,000, Item 7760-001-6044 be increased by \$1,000, and Item 7760-001-6057 be increased by \$4,000 and 2 positions. Chapter 28, Statutes of 2013 requires the DGS to develop a new payment process whereby the DGS makes loan payments on behalf of state departments that have loans through the GS \$SMART program, and requires the DGS to prepare and submit claim schedules for these loan payments. These resources are necessary to comply with the legislative changes to the GS \$SMART program that require enhanced oversight over the new loan payment process.

## ATTACHMENT 1

Amend Budget Bill Item 7920-490:

“7920-490—Reappropriation, State Teachers’ Retirement System. Up to \$21,010,000 ~~\$18,260,000~~ as specified in the following citations is reappropriated and shall be available for encumbrance or expenditure subject to the limitations set forth in Provisions 1 and 3:

0835—Teachers’ Retirement Fund

- (1) Up to \$4,361,000 of Item 1920-001-0835, Budget Act of 2012 (Chs. 21 and 29, Stats. 2012), as reappropriated by Item 7920-490, Budget Act of 2013 (Ch. 20, Stats. 2013)
- (2) Up to \$4,649,000 of Item 7920-001-0835, Budget Act of 2013 (Ch. 20, Stats. 2013)
- (3) Up to \$12,000,000 ~~\$9,250,000~~ of Item 7920-003-0835, Budget Act of 2013 (Ch. 20, Stats. 2013)

Provisions:

1. The funds reappropriated in (1) and (2) of this item shall be available for expenditure by the State Teachers’ Retirement System for the purposes of meeting unanticipated system costs and promoting better service to the system’s membership. The funds may not be encumbered without advance approval of the Teachers’ Retirement Board. The board shall report to the Legislature on a quarterly basis throughout the 2014-15 fiscal year on expenditures made pursuant to this item.
2. The basis for the reappropriation in (1) and (2) of this item is 3 percent of the preceding two fiscal years’ expenditure authority.
3. The funds reappropriated in (3) of this item, shall be available for expenditure upon written approval of the Teachers’ Retirement Board for costs associated with Information Technology Projects. The board shall report to the Legislature on a quarterly basis throughout the 2014-15 fiscal year on expenditures made pursuant to this item.”
