Amendment to Budget Bill Item 8260-001-0001 and Reimbursements, Support, California Arts Council

Ongoing Reimbursement Authority for Arts-in-Corrections Program (Issue 001)—It is requested that Item 8260-001-0001 be amended by permanently increasing reimbursements by \$2 million. These funds, which are received from the California Department of Corrections and Rehabilitation (CDCR), would provide support for arts instruction to inmates in California's prison system. The Arts-in-Corrections program has been operating as a pilot for the last two years, but a recently-executed interagency agreement with CDCR provides the certainty of ongoing funding for this program, which has demonstrated success in improving inmate behavior.

**Information Technology Restructuring**—It is requested that various items be increased by \$3,370,000 and 24 positions, as follows:

- Item 8660-001-0042 be increased by \$149,000
- Item 8660-001-0046 be increased by \$87,000
- Item 8660-001-0461 be increased by \$422,000
- Item 8660-001-0462 be increased by \$1,762,000 and 24 positions
- Item 8660-001-0464 be increased by \$10,000
- Item 8660-001-0470 be increased by \$8,000
- Item 8660-001-0471 be increased by \$29,000
- Item 8660-001-0483 be increased by \$54,000
- Item 8660-001-0493 be increased by \$31,000
- Item 8660-001-0890 be increased by \$196,000
- Item 8660-001-3089 be increased by \$578,000
- Item 8660-001-3141 be increased by \$44,000

The requested changes are to support the Information Technology Services Branch with increasing operational workload. These resources will also enhance information security and support public transparency. The costs are allocated to various special funds based on the PUC's cost allocation plan.

**Outside Counsel Support**—It is requested that Item 8660-001-0462 be increased by \$6,045,000 on a one-time basis to retain the services of outside counsel. These services are needed to support cooperation with federal and state agencies investigating the PUC. The criminal and civil investigations of the PUC are continuing into fiscal year 2016-17 and expanding in scope.

**Rail Transit Safety**—It is requested that Item 8660-001-0046 be increased by \$701,000 and 5 positions to maintain safety inspections and accident investigation levels related to the expansion of rail transit systems in the state.

**Chapter 611, Statutes of 2013 (AB 327) Extension**—It is requested that Item 8660-001-0462 be increased by \$527,000 and 4 positions to support ongoing implementation of AB 327. AB 327 restructures rate design for residential electric customers and creates a new net energy metering program.

Chapter 627, Statutes of 2014 (AB 1414) Extension—It is requested that Item 8660-001-0462 be increased by \$131,000 and 1 position to support ongoing implementation of AB 1414. AB 1414 requires the PUC to establish or maintain demand response products and tariffs that can meet or reduce an electrical corporation's resource adequacy requirements.

**Trailer Bill Language, Transportation Rate Fund**—It is requested that trailer bill language be adopted to increase the maximum fee that can be charged to household goods movers from 0.7 percent to 1.0 percent of gross revenues (see Attachment 1).

## Public Utilities Code

"5003.2. (a) Notwithstanding Section 5003.1, the commission shall require every highway carrier otherwise subject to Section 5003.1 for whom the commission does not establish minimum or maximum rates, or require rates to be on file with the commission, to pay a fee equal to one-tenth of 1 percent of the amount of gross operating revenue.

(b) When a household goods carrier pursuant to Section 5137 elects to transport under its household goods carrier permit used office, store, and institution furniture and fixtures, notwithstanding Section 5003.1, the fee on the gross operating revenue derived from

transporting those items shall be one-tenth of 1 percent.

(c) The commission may raise the fee imposed by Section 5003.1 upon those persons and corporations subject to that section for whom the commission establishes minimum or maximum rates or requires rates to be on file, up to a maximum of one seven-tenths of 1 percent of gross operating revenue, if the commission decides this increase is necessary to maintain adequate financing for the Transportation Rate Fund."

## Amend Provision 3 in Item 8940-001-0001:

"3. Of the funds appropriated in this item, \$275,000 \$349,000 shall be used to provide mandatory employee compensation increases for state active duty employees. The funds provided in this provision shall be expended pursuant to Sections 320 and 321 of the Military and Veterans Code, which require state active duty employees to receive the same compensation increases as their counterparts on federal active duty. Any unspent funds pursuant to this provision shall revert to the General Fund."

#### Amend Provision 1 in Item 8940-001-0890:

"1. Of the funds appropriated in this item, \$395,000 \$499,000 shall be used to provide mandatory employee compensation increases for state active duty employees and shall only be available for expenditure upon passage of a federal active duty compensation increase in the federal budget. The funds provided in this provision shall be expended pursuant to Sections 320 and 321 of the Military and Veterans Code, which require state active duty employees to receive the same compensation increases as their counterparts on federal active duty."

## Add the following provision to Item 8940-101-8078:

2. The Department of Finance may authorize the augmentation of the total amount available for expenditure under this item in the amount of any donations from the private sector received by the California Military Department that are in excess of the amount appropriated in this item. Any augmentation shall be accompanied by a spending plan submitted by the California Military Department. The spending plan shall include, at a minimum, the source and level of donations received to date, a detailed description of activities already completed and those activities proposed, the source and amount of any additional donations expected to be received, and the identification of any impact of the spending plan on other state funds. An approval of an augmentation of this item shall be effective not sooner than 30 days after the transmittal of the approval and spending plan to the Chairperson of the Joint Legislative Budget Committee, or not sooner than whatever lesser time the chairperson of the joint committee, or his or her designee, may determine.
