**Amendment to Budget Bill Items 0250-301-0668, 0250-301-3138, and 0250-490, and  
Addition of Item 0250-491, Capital Outlay, Judicial Branch**

**Shasta County: New Redding Courthouse Project (Issue 308)**—It is requested that Item 0250-301-0668 be decreased by \$2,127,000 and Item 0250-301-3138 be increased by \$2,301,000 to reflect a fund shift for the construction phase of this project. An additional \$174,000 appropriated in the 2015 Budget Act from Item 0250-301-0668 will revert on the natural resulting in a net zero increase to the construction phase. This request would shift bond funds (0668) proposed in the Governor's Budget to the Immediate and Critical Needs Account, State Court Facilities Construction Fund (3138). The fund shift will allow for the completion of needed site work prior to the bond sale for the remaining construction costs.

**Los Angeles County: New Hollywood Courthouse Project (Issue 301)**—It is requested that Item 0250-301-3138 be increased by \$14,729,000 to fund cost increases associated with a revised scope for this project. The project was originally appropriated in the 2014 Budget Act as a renovation and addition to the existing Hollywood Courthouse. During the initial design phases of this project a geotechnical report showed that a fault line runs through the existing building, preventing the proposed renovation project from moving forward. However, there is adequate space for new construction on the same lot that would not touch the fault line.

**Stanislaus County: New Modesto Courthouse Project (Issue 309)**—It is requested that Item 0250-301-3138 be increased by \$2,066,000 to reflect a fund shift and the completion of site work sooner than previously estimated. Future bond funds requested for the completion of the construction phase of this project will be reduced by the same \$2,066,000 to reflect a net zero change to the construction phase for this project.

**Reappropriations (Issue 303)**—It is requested that Item 0250-490 be amended to reappropriate funding from the Immediate and Critical Needs account for the following four projects (see Attachment 1):

- Santa Barbara County: New Santa Barbara Criminal Courthouse project. The acquisition phase took longer than estimated which delayed the start of preliminary plans. This timeline delay will prevent working drawings from starting before the appropriation

expires on June 30, 2016. Reappropriation of both phases will allow this project to continue without further delay.

- Sonoma County: New Santa Rosa Criminal Courthouse project. Unforeseen delays during the preliminary plans phase will prevent the working drawings from starting before the appropriation expires on June 30, 2016. Reappropriation of the working drawings phase will allow this project to continue without further delay.
- El Dorado County: New Placerville Courthouse project. Delays in acquisition due to longer than anticipated negotiations will prevent preliminary plans from starting before the appropriation expires on June 30, 2016. Reappropriation of the preliminary plans phase will allow this project to continue without further delay.
- Sacramento County: New Sacramento Criminal Courthouse project. This project originally consisted of two courthouses: (1) a new 44-courtroom courthouse, and (2) the renovated Schaber Courthouse. However, in February 2016, the Judicial Council (JC) approved a revised scope to exclude the renovation of the Schaber Courthouse and increase the courtrooms in the new courthouse by nine courtrooms (from 44 to 53). The start of preliminary plans was put on hold pending approval of this change. Therefore, working drawings will not start before the appropriation expires on June 30, 2016. This request incorporates the revised scope approved by the JC and reappropriation of the working drawings phase will allow this project to continue without further delay.

**Glenn County: Renovation and Addition to Willows Courthouse Project (Issue 313)**—It is requested that Item 0250-491 be added to reappropriate the construction phase of this project. Delays in the approval of the working drawings will prevent this project from proceeding to bid before the appropriation expires on June 30, 2016. The reappropriation of the construction appropriation will allow this project to continue without further delay (see Attachment 2).

**Amendment to Budget Bill Item 0530-001-9745, Support, Health and Human Services Agency**

**County Expense Claim Reporting Information System (CECRIS) (Issues 300-A1)**—It is requested that Item 0530-001-9745 be increased by \$149,000 and 1 position to support procurement activities for the CECRIS. In December 2014, the California Department of Technology (CDT) suspended the CECRIS because the original proposed solution was deemed not viable. Since then, the Department of Social Services (DSS), the Office of Systems Integration, and CDT have been working closely on a new solution and have made significant progress. In February 2016, CDT submitted a project reinstatement notification letter to the Legislature. An increase in expenditure authority is also being requested for DSS (see Item 5180-001-0001, Issue 300-A1 and Item 5180-001-0890, Issue 300-A1).

**Child Welfare Digital Services (Issue 306-A1)**—It is requested that Item 0530-001-9745 be increased by \$28,663,000 to support the development and implementation of the Child Welfare Services-New System project. In November 2015, the project's procurement approach changed from a monolithic multi-year approach to an agile development approach. This new approach will consist of numerous smaller modules of functionality and produce stand-alone functionality after each phase. Additionally, the revised approach requires flexibility and in-depth collaboration among all entities involved to make sound decisions quickly and effectively. As such, it is also requested that Budget Bill language be added to Item 0530-001-9745 to provide flexibility with respect to project funding (see Attachment 1). An increase in expenditure authority is also being requested for DSS (see Item 5180-151-0001, Issue 306-A1 and Item 5180-151-0890, Issue 306-A1).

**Amendment to Budget Bill Items 0540-001-0140, 0540-001-3212, 0540-001-6051, and Reimbursements, and Addition of Item 0540-490, Support, and Item 0540-301-6051, Capital Outlay, Secretary of Natural Resources Agency**

**Implementation of AB 142**—It is requested that Item 0540-001-0140 be increased by \$125,000 and reimbursements be increased by \$125,000 to provide one-time funding for a report on the suitability of sections of the Mokelumne River for State Wild and Scenic River designation.

**Timber Regulation and Forest Restoration Public Process and Technical Support**—It is requested that Item 0540-001-3212 be increased by \$230,000 and trailer bill language be adopted (see Attachment 1) to provide on-going funding for public process and scientific expertise and offer per diem payments to non-governmental participants in Timber Regulation and Forest Restoration Program working groups.

**San Joaquin River Settlement**—It is requested that Item 0540-001-6051 be increased by \$16,548,000 and Item 0540-301-6051 (see Attachment 2) be added in the amount of \$15,983,000 to provide funding for interagency agreements with Department of Fish and Wildlife and Department of Water Resources for the construction of a fish hatchery that support the San Joaquin River Settlement.

**Reappropriation**—It is requested that Item 0540-490 be added to reflect reappropriated funds from various local assistance appropriations from prior years to make funds available for encumbrance or expenditure until June 30, 2019 (see Attachment 3) for River Parkways and California Cultural and Historical Endowment programs. These grant programs have residual funds from projects that were unsuccessful or came in under budget.

**Trailer Bill Language for Green Infrastructure Projects**—It is requested that trailer bill language be adopted (see Attachment 4) that would authorize the Secretary of Natural Resources Agency to create and implement a local assistance grant program for green infrastructure projects that reduce greenhouse gas emissions and provide other environmental benefits. This language is associated with the Governor's Budget proposal to provide \$20 million Greenhouse Gas Reduction Fund for the Green Infrastructure Program.

Sec. X Section 12815 is added to the Government Code, to read:

12815(a) To support the development of sustainable communities, the Secretary for Natural Resources shall manage and award financial assistance to a city, county, special district, nonprofit organization, or entity formed pursuant to Chapter 5 (commencing with Section 6500) of Division 7 of the Government Code, if at least one of the parties to the joint powers agreement qualifies as an eligible applicant, for the preparation, and implementation of green infrastructure projects that reduce greenhouse gas emissions and provide multiple benefits. The multiple benefits include, but are not limited to, a decrease in air and water pollution, a reduction in the consumption of natural resources and energy, an increase in the reliability of local water supplies, or an increased adaptability to climate change.

The financial assistance provided pursuant to this section shall initially be funded from monies made available from the Green House Gas Reduction Fund. After initial funding, monies for this purpose are subject to appropriation by the Legislature in the annual budget act or other legislation.

(b) The Secretary for Natural Resources shall develop minimum requirements for funding eligible projects pursuant to this section, which shall require a project to meet at least one of the following criteria in addition to reducing greenhouse gas emissions:

(1) Use natural systems, or systems that mimic natural systems, to achieve the benefits identified in subdivision (a).

(2) Create, enhance, or expand community green spaces.

(c) The multiple benefits of a project, may include, but are not limited to, the establishment or enhancement of one or more of the following:

(1) Greening of existing public lands and structures, including schools.

(2) Multi-objective storm water projects, including construction of permeable surfaces and collection basins and barriers.

(3) Green streets and alleys that integrate green infrastructure elements into the street and/or alley design, including permeable surfaces, bioswales and trees.

(4) Urban heat island mitigation and energy conservation efforts through greening, including green roof projects.

(5) Nonmotorized urban trails that provide safe routes for both recreation and travel between residences, workplaces, commercial centers, and schools.

(6) Tree canopy.

(7) Wetlands.

(8) Local parks and open space.

(d) The Secretary shall give additional consideration to funding a project pursuant to this section that meets one or more of the following criteria:

(1) The project uses interagency cooperation and integration.

(2) The project uses existing public lands and facilitates use of public resources and investments, including schools.

(3) The project is proposed by an economically disadvantaged community.

(e) The Secretary shall locate at least 40 percent of these green infrastructure investments in and provide benefits to disadvantaged communities, as identified through CalEnviroScreen.

(f) Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government code does not apply to the development and adoption of program guidelines and selection criteria adopted pursuant to this section.

**Amendment to Budget Bill Item 0690-491, Capital Outlay, Office of Emergency Services**

**Headquarters Complex, Rancho Cordova: Public Safety Communications Network**

**Amendment to Budget Bill Items 0840-001-0001, 0840-001-9740, and Reimbursements, Support, State Controller's Office**

It is requested that Item 0840-001-0001 be increased by \$1,691,000, Item 0840-001-9740 be increased by \$1,275,000, and reimbursements be decreased by \$1,880,000 as follows:

**California Automated Travel Expense Reimbursement System (CalATERS) Replacement Study**—A one year increase of \$619,000 for Item 0840-001-0001 and \$467,000 for Item 0840-001-9740, to support 3 positions to continue the study of alternatives to CalATERS and to fund increased fiscal year 2016-17 system costs.

**CalATERS Funding Realignment**—A permanent increase of \$1,072,000 for Item 0840-001-0001, a permanent increase of \$808,000 for Item 0840-001-9740, and a permanent reduction of \$1,880,000 for reimbursements. Currently, the State Controller's costs are funded by reimbursements from departments participating in CalATERS. **Enhanced Fraud Investigation eDiscovery (Civil Litigation Software)**—It is requested that Item 0845-001-0001 be increased by \$626,000 in fiscal year 2016-17 to provide support for the Department of Insurance's (CDI's) civil litigation of insurance fraud cases. These resources would be used to purchase document storage and analysis software to assist CDI in arguing large whistleblower cases that involve millions of documents. By enabling CDI to possibly achieve a higher success rate in such cases and to intervene in more cases, it is anticipated that this software will result in more settlement and judgement revenue for the General Fund.

**Health Network Adequacy**—It is requested that Item 0845-001-0217 be increased by \$424,000 and 1 position in 2016-17 to provide support for CDI's efforts to ensure adequate coverage of health care insurance provider networks. As a result of CDI's statutorily-mandated review of its network adequacy regulations, recent regulatory revisions now require health insurers to annually submit data on their provider networks. The CDI must compare insurer submissions to minimum network adequacy standards, which necessitates the use of software for a process that would be unrealistic to complete manually.

**Enhanced Fraud Investigation and Prevention (Warner Chilcott Settlement)**—It is requested that Item 0845-002-0001 be increased by \$1,567,000 and 8 positions in 2016-17 to provide support for CDI's expanded efforts targeting life and annuity fraud against seniors. As a result of a recent settlement with pharmaceutical company Warner-Chilcott, \$11.8 million was deposited into the General Fund and is available for enhanced insurance fraud investigation and prevention efforts. The CDI requests to use this money for investigation of additional senior fraud complaints, outreach to seniors and law enforcement groups, and for a software tool to help it target multi-jurisdictional fraud networks.

ATTACHMENT 1

0981-011-0001—For transfer by the Controller, upon order of the Department of Finance, to the California ABLE Administrative Fund..... (850,000)

Provision:

1. The Department of Finance may transfer up to \$850,000 as a loan to the California ABLE Administrative Fund to implement the California ABLE Act program. This loan shall be repaid once sufficient revenue is available, but no later than June 30, 2022, with interest calculated at the rate earned by the Pooled Money Investment Account at the time of the transfer.
