Amendment to and Addition of Various Budget Bill Items, Support, and Trailer Bill Language, Multiple Departments—Aliso Canyon and Implementing the Governor's Emergency Proclamation

In late October 2015, a leak was discovered expelling natural gas from a well at the Aliso Canyon Natural Gas Storage Facility (Facility) in Los Angeles County. The well, which was being used for injection and storage of gas by its operator Southern California Gas Company (SoCalGas), was located in close proximity to residential neighborhoods. The Porter Ranch community, one of the closest, experienced some of the most severe effects.

SoCalGas, in conjunction with state oversight agencies, attempted to plug the leak using conventional methods. However, these initial efforts were not successful, and in early December a more complex solution (i.e., the drilling of a relief well) was initiated. In the meantime, SoCalGas provided temporary housing and filtration/purification systems for the neighboring communities.

As part of the state's response to Aliso Canyon, the Governor's Emergency Proclamation was issued in early January to direct multiple oversight agencies to focus on the following main principles: (1) addressing the immediate threat to public health and safety by directing efforts to plug the leak, (2) ensuring that accountability falls on the operators of the Facility, (3) taking steps to prevent a similar event from occurring in the future, and (4) implementing necessary actions to ensure energy reliability.

It is requested that various items be changed and added as follows to (1) implement the Governor's Emergency Proclamation, and (2) enhance efforts to improve public safety statewide.

California Energy Commission—It is requested that Item 3360-001-0381 be added in the amount of \$1,739,000 and 3 positions (see Attachment 1) to provide the Energy Commission with additional technical ability to monitor, model, and analyze the interaction of electricity and natural gas systems for reliability. It is also requested that trailer bill language be adopted to amend statute (see Attachment 2). This language will eliminate the final transfer of funds from the Public Interest Research, Development, and Demonstration Fund to the Alternative and

Renewable Fuel and Vehicle Technology Fund so that resources are available to support this proposal.

Department of Conservation—It is requested that Item 3480-001-3046 be increased by \$4,172,000 and 20 positions to support increased regulatory activities at underground gas storage facilities. It is also requested that this item be increased by \$1 million to protect public safety by increasing efforts to remediate orphan wells. It is further requested that provisional language be added to this item (see Attachment 3) to increase the expenditure limit for remediation of orphan wells to \$2 million.

Air Resources Board (ARB)—It is requested that Item 3900-001-3046 be increased by \$2,276,000 and 4 positions to support neighborhood air quality monitoring near oil and gas facilities and enhance ARB's emergency response capabilities. Of this amount, \$1,357,000 is for one-time equipment purchases in 2016-17. Beginning in 2017-18, ongoing costs will be \$915,000 annually for staff support and equipment maintenance. It is also requested that trailer bill language be adopted to make ARB an authorized user of the Oil, Gas, and Geothermal Administrative Fund for these purposes (see Attachment 4).

Office of Environmental Health Hazard Assessment—It is requested that Item 3980-001-3046 be added in the amount of \$350,000 and 2 positions (see Attachment 5) to coordinate with and support ARB's neighborhood air quality monitoring near oil and gas facilities. It is also requested that trailer bill language be adopted to make the Office of Environmental Health Hazard Assessment an authorized user of the Oil, Gas, and Geothermal Administrative Fund for these purposes (see Attachment 4).

Public Utilities Commission—It is requested that Item 8660-001-0462 be increased by \$1,479,000 and 10 positions for increased workload related to regulating natural gas storage facilities. It also is requested that Item 8660-001-0462 be increased by \$1,694,000 and 11 positions to create the Division of Safety Advocates (Division) within the Public Utilities Commission (PUC). This Division will be focused on safety issues, testify in hearings and proceedings, and advocate for the protection and safety of California residents as a party to PUC proceedings.

3. Notwithstanding Public Resources Code Section 3258, of the funds appropriated in this item, up to \$2,000,000 is available for expenditure for the purposes Article 4.2 of Chapter 1 of Division 3 of the Public Resources Code.

Public Resources Code 3401

“(a) The proceeds of charges levied, assessed, and collected pursuant to this article upon the properties of every person operating or owning an interest in the production of a well shall be used exclusively for the support and maintenance of the department charged with the supervision of oil and gas operations, and for the State Water Resources Control Board and the regional water quality control boards for their activities related to oil and gas operations that may affect water resources. and for the Air Resources Board and Office of Environmental Health Hazard Assessment for their activities related to oil and gas operations that may affect air quality, public health, or public safety.

(b) Notwithstanding subdivision (a), the proceeds of charges levied, assessed, and collected pursuant to this article upon the properties of every person operating or owning an interest in the production of a well undergoing a well stimulation treatment, may be used by public entities, subject to appropriation by the Legislature, for all costs associated with ~~both~~ all of the following:

(1) Well stimulation treatments, including rulemaking and scientific studies required to evaluate the treatment, inspections, any air and water quality sampling, monitoring, and testing performed by public entities.

(2) The costs of the State Water Resources Control Board and the regional water quality control boards in carrying out their responsibilities pursuant to Section 3160 and Section 10783 of the Water Code.

(3) The costs of the Air Resources Board and the Office of Environmental Health Hazard Assessment in carrying out their responsibilities pursuant to Sections 38510 and 39607 of the Health and Safety Code with respect to oil and gas operations.”

**Amendment to Budget Bill Items 3100-001-0267 and 3100-003-0001, Support,
California Science Center**

Assistant General Manager Position/Provisional Language—It is requested that Item 3100-001-0267 be increased by \$150,000 and 1 position to provide funding for an Assistant General Manager position for the California Science Center, Office Exposition Park Management (Expo Park). Expo Park is requesting the 1 position to assist with daily operations and events at the park because of an increased workload. The increased workload is attributable to multiple construction projects on park grounds and city projects that effect Expo Park requiring participation at city meetings, professional sports teams contracted to play at sport venues on park grounds, and the development of a 2024 Olympic bid. It is also requested that Item 3100-001-0267 be amended to add Provision 2 (see Attachment 1), which will allow augmentations for operational costs associated with major events at the park, after a 30-day notification to the Joint Legislative Budget Committee. This will provide Expo Park the ability to meet operational needs, including public safety, related to special events held at the park.

Technical Adjustment—It is requested that Item 3100-003-0001 be decreased by \$268,000 to reflect reduced lease rental and insurance payments due to the refinancing of the original lease revenue bonds.

Add the following provision to Item 3100-001-0267 .

2. Upon approval of the Director of Finance, the amount available for expenditure in this item may be augmented for park operational costs, including but not limited to increased security and parking associated with major events at Exposition Park. Any augmentation under this provision shall be authorized no sooner than 30 days after notification in writing of the necessity of the increase to the chairpersons of the committee in each house of the Legislature that consider appropriations, the chairpersons of the committees and the appropriate Subcommittees that consider the state budget, and the Chairperson of the Joint Legislative Budget Committee, or not sooner than whatever lesser time the chairperson of the joint committee, or his or her designee, may determine.

Amendment to Budget Bill Items 3340-001-0001, 3340-001-0318, 3340-001-3063, 3340-001-3228, and 3340-001-8080, Support, California Conservation Corps

Minimum Wage Increase/Technical Adjustment—It is requested that Item 3340-001-0001 be decreased by \$2,106,000 (\$394,000 increase for minimum wage and \$2.5 million decrease for technical adjustment), Item 3340-001-0318 be increased by \$494,000, Item 3340-001-3063 be increased by \$396,000, and Item 3340-001-8080 be increased by \$97,000. The minimum wage increase totals \$1,381,000 and this amount will fully fund the \$1.00 per hour minimum wage increase that became effective January 1, 2016. The California Conservation Corps (Corps) received partial funding for the January 2016 minimum wage increase during the 2015-16 budget process. This request provides the required amount to fully fund the increase for corpsmembers. In addition to the minimum wage increase, the Corps is requesting a technical correction to decrease its General Fund appropriation by \$2.5 million. This reduction represents the removal of one-time funding that was inadvertently included in the Governor's Budget.

Enterprise Resource Management System (C³ System)—It is requested that Item 3340-001-0318 be increased by \$409,000 to provide one-time funding for project management consulting services to complete the C³ System. This additional cost is because of a four-month schedule extension to rework project deliverables that did not meet quality standards. The additional funding will allow the Corps to fund four contract extensions through October 31, 2016, and continue to have the management, quality, support, and oversight necessary to ensure successful implementation of the project.

Energy Corps Position Authority—It is requested that Item 3340-001-3228 be amended by adding 1 position. The Corps is requesting 1 position to be funded by a proposed appropriation included in the Governor's Budget of \$15 million Greenhouse Gas Reduction Fund. The Corps is requesting to establish a Deputy Director position that will oversee the operations of the Energy Corps Program, which will consist of four centers with 51 civil-service staff and 210 corpsmembers.

**Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance,
Department of Conservation**

Oil and Gas Studies—It is requested that Item 3480-001-3046 be increased by \$2,950,000 to provide funding for additional regulatory studies as recommended by the report titled "An Independent Scientific Assessment of Well Stimulation in California" from the California Council on Science and Technology. This report was required by Chapter 313, Statutes of 2013 (SB 4), as part of a broad regulatory package related to hydraulic fracturing and its effects on California.

Technical Adjustments: Reappropriations, Reversions, and New Item—It is requested that Item 3480-490 be added to reappropriate the unencumbered balance of Item 3480-001-3046, Provision 2, Budget Act of 2015 (see Attachment 1), to allow the Department of Conservation additional time to implement the project and expend the funds.

It is requested that Item 3480-495 be added to revert the unencumbered balance from Item 3480-101-6051, Budget Act of 2014 (see Attachment 2). It also is requested that Item 3480-101-6051 be added in the amount of \$2,097,000 and include Budget Bill language to allow for encumbrance through June 30, 2019 (see Attachment 3). This request will allow the Department of Conservation additional time to provide agricultural land conservation grants to local governments and non-profit land trusts to protect natural resources and agricultural lands.

Mobile Equipment Replacement Budget—It is requested that Item 3540-001-0001 be increased by \$6 million to provide funding for the Department of Forestry and Fire Protection's (Department) mobile equipment replacement budget. This action backfills funds that were committed in fiscal year 2015-16 for the purchase of equipment to address dead and dying trees throughout the state.

Federal Fund Authority Adjustment—It is requested that Item 3600-001-0890 be increased by \$13.5 million to reflect an increase in federal funding. Recently, the receipt of federal funds for the federal Sport Fish Restoration Program and the Wildlife Restoration and Hunter Education Program has increased significantly. This request aligns the appropriated amount with the anticipated ongoing awards.

Proposition 1: Watershed Restoration Grants—It is requested that Item 3600-101-6083 be increased by \$20 million and provisional language be added authorizing the additional funds be prioritized for eligible grant applications received in fiscal year 2015-16 (see Attachment 1). The Department of Fish and Wildlife awarded a total of \$31.4 million Proposition 1 through the Watershed Restoration Grant Program including \$24.6 million for projects of statewide importance outside of the Sacramento-San Joaquin Delta; and approximately \$6.8 million through the Delta Water Quality and Ecosystem Restoration Grant Program for projects that benefit the Sacramento-San Joaquin Delta specifically. The demand in grant requests for watershed restoration and protection projects was much larger than initially anticipated and the additional funds will help accelerate projects.

Amendment to Budget Bill Items 3760-001-6083 and 3760-101-6083, Support and Local Assistance, and the Addition of Item 3760-496, Capital Outlay, State Coastal Conservancy

Proposition 1—It is requested that Item 3760-001-6083 be increased by \$500,000 and Item 3760-101-6083 be increased by \$11,893,000 to provide program delivery and project funding, respectively, for watershed protection and restoration projects. The State Coastal Conservancy (Conservancy) has received approximately 90 grant applications totaling \$71.5 million after two rounds of grant solicitations, far exceeding currently requested appropriations. Two more rounds of grant solicitations are scheduled through May 2016. This increase will provide program delivery funds allowing the Conservancy to dedicate additional staff time for grant reviews and to award additional grants, consistent with the demand for Proposition 1 funding.

Technical Adjustments—It is requested that Item 3760-496 be added to revert prior appropriations that consist of only Habitat Conservation Fund reimbursement authority because the Conservancy no longer anticipates receiving reimbursements (see Attachment 1). The Habitat Conservation Fund is continuously appropriated and these appropriations were made through previous Budget Acts, so the reversion is necessary to remove items ranging from 1997 through 2010.

Amendment to Budget Bill Items 3790-101-0516 and 3790-101-3001, Local Assistance, and Addition of Item 3790-012-0516, Support, Department of Parks and Recreation

Public Beach Erosion Program—It is requested that Item 3790-101-0516 be increased by \$700,000 Harbors and Watercraft Revolving Fund to provide funding for the Santa Cruz Beach Erosion Project. This funding will help the county build a concrete seawall as part of a larger multi-year project that provides public access enhancement through a \$4.5 million public access and recreation project, including recreational trails, benches, stairs, and American Disabilities Act accessible pathways built into the structure, in addition to ensuring the stability and longevity of the public recreational access improvements associated with and along the roadway. The requested funding supplements other sources of funding that the local sponsor has already secured for this project.

Public Beach Restoration Fund—It is requested that Item 3790-101-3001 be increased by \$2.6 million Public Beach Restoration Fund and provisional language be added to authorize the use of funds if an insufficient amount of eligible proposals are received to meet the statutorily required split between public beach restoration projects allocated in specified areas of the state (see Attachment 1). Section 69.9 of the Harbors and Navigation Code requires the Department of Parks and Recreation to allocate 60 percent of the moneys in the Public Beach Restoration Fund to projects south of the point at which the Pacific Ocean meets the border between the county of San Luis Obispo and the county of Monterey and 40 percent to projects located north of that point. Currently, no eligible requests for fiscal year 2016-17 have been received for projects north of the border between the county of San Luis Obispo and the county of Monterey. The increased funding is to correct an error in the calculation of the local agency match for select proposed projects.

Vessel Operator Certification Program—It is requested that Item 3790-012-0516 be added to reflect the transfer of \$3 million as a loan from the Harbors and Watercraft Revolving Fund to the Vessel Operator Certification Account within the Harbors and Watercraft Revolving Fund pursuant to Section 678.7 of the Harbors and Navigation Code. Chapter 433, Statutes of 2014 (SB 941) established the Vessel Operator Certification Program which prohibits the operation of a motorized vessel in California without a valid vessel operator card developed by the Division of Boating and Waterways. SB 941 authorizes the transfer of up to \$4 million from the Harbors and Watercraft Revolving Fund to the Vessel Operator Certification Account in the form of a loan. The loan supports the existing appropriation used to develop and establish the program.

Revenue from fees for the issuance of the Vessel Operator cards is anticipated to repay the loan within eight years. The 2015 Budget Act included \$533,000 in support and a \$1 million transfer from the Harbors and Watercraft Revolving Fund to the Vessel Operator Certification Account.

Reappropriations (Issue 302)—It is requested that Item 3790-491 be amended to reappropriate an additional 17 projects (see Attachment 1):

0005—Safe Neighborhood Parks, Clean Water, Clean Air, and Coastal Protection Bond Fund

- San Elijo State Beach (SB): Replace Main Lifeguard Tower project. The project is delayed due to negotiations with the city for the required coastal permit. Design is nearly complete and it is anticipated that construction bids will be solicited in the summer of 2016.

0263—Off-Highway Vehicle Trust Fund

- Southern California Opportunity Purchase project. Reappropriating these funds is necessary to keep available the last of the funds for the acquisition of inholdings and adjacent properties within various Southern California Off Highway Vehicle (OHV) parks. This funding will be used for identified parcels throughout the OHV Districts located in Southern California.
- Carnegie State Vehicular Recreation Area (SVRA): Road Reconstruction project. Design of this project was delayed due to delays in the permitting process; a final permit application has been submitted and is pending approval. It is anticipated that construction bids will be solicited in May 2016. However, this reappropriation is requested in the event that there are further delays resulting from the permitting process.
- Carnegie SVRA: Vehicle Wash Station project. This project was delayed because the original design approach was found to be unworkable. It is anticipated that design will not be completed until the summer of 2016.
- Hungry Valley SVRA: Vehicle Wash Station project. This project was delayed because the original design approach was found to be unworkable. It is anticipated that design will not be completed until the summer of 2016.

- Oceano Dunes SVRA: Pismo SB Sediment Track-out Prevention project. Completion of design has been delayed due to permitting requirements.
- Hollister Hills SVRA: Waterline Expansion project. It is anticipated that the initial design will be completed in May 2016. However, in the event that there are delays in finalizing the plans, reappropriation is requested to prevent any further delays to this project.

0392—State Parks and Recreation Fund

- Leo Carrillo State Park (SP): Steelhead Trout Barrier Removal project. This project is delayed because permitting requirements do not allow for construction in this area in the spring. Therefore, construction cannot commence until June 2016.
- Mendocino Headlands SP: Big River Watershed Restoration project. The design of this project is delayed as a result of the project due diligence taking longer than expected. It is anticipated that construction bids will be solicited in May or June of 2016. Technical Adjustments—It is requested that Item 3860-001-0001 be increased by \$5,325,000, Item 3860-001-0544 be decreased by \$27,000, Item 3860-001-6005 be decreased by \$440,000, Item 3860-001-6023 be decreased by \$375,000, and Item 3860-001-6026 be increased by \$440,000. It is also requested that the funding be shifted between programs under Item 3860-001-0890, Item 3860-001-6031, Item 3860-001-6051, and Item 3860-101-6051. These changes are necessary to correct data errors inadvertently created such as duplicated reductions and incorrect program splits.

Reappropriations—It is requested that Item 3860-490 be added to reappropriate funds from various support appropriations from prior years and that provisional language be added making the funds available for encumbrance or expenditure through June 30, 2018 (see Attachment 1). A number of water-related programs have been delayed for various reasons, including California Environmental Quality Act timelines, statutory and regulation changes, extended contracting processes, or state and federal permitting delays. The reappropriations will provide additional time for these projects to be completed.

Extensions of Liquidation—It is requested that Item 3860-491 be added to extend the liquidation period to June 30, 2018, for support projects previously encumbered under various appropriations in prior years (see Attachment 2). This extension will provide additional time for final accounting and payments to be made on completed, or soon to be completed, projects.

System Reoperation Program and Surface Storage Program—It is requested that Item 3860-495 be amended to revert an additional \$2,990,000 (see Attachment 3) and that Item 3860-001-6051 be increased by \$75,000 to support 3.25 existing positions providing coordination for studies under the System Reoperation Program and the Surface Storage Program.

Reversions—It is requested that Item 3860-495 be amended to revert an additional \$2.6 million of various prior year funds that are not expected to be encumbered or expended in the current year (see Attachment 3).

The effect of my requested action is reflected on the attachment.
