Motor Vehicle Insurance Account Assessment—It is requested that Item 3900-001-0115 be increased by \$2,011,000 to reimburse the Department of General Services (DGS), Office of Risk and Insurance Management. This augmentation is necessary to reimburse DGS for a payment made on behalf of the Air Resources Board (ARB) for a judgment associated with a 2011 car accident in which an ARB employee was determined to be at fault. It is also requested that Budget Bill language be adopted specifying that Air Pollution Control Fund penalty revenues be used for this purpose (see Attachment 1).

- (1) The amount appropriated in this item includes revenues derived from the assessment of fines and penalties imposed as specified in Section 13332.18 of the Government Code.
- (2) Notwithstanding any other provision of law, of the amount appropriated in this item, \$2,011,000 shall be from penalty revenues that are subject to separate accounting in accordance with Health and Safety Code Sections 38580, 39674-39675, 42400-42410, 43016, 43025-43031.5, 43154, 43211, and 43212. Amendment to Budget Bill Items 3940-001-0001 and 3940-001-0306, and Addition of Item 3940-403, Support, and Trailer Bill Language, State Water Resources Control Board

Lead and Copper Rule and Improvements to Federal Reporting Requirements—It is requested that Item 3940-001-0306 be increased by \$480,000 and 2 positions. Of this amount, \$240,000 is two-year limited-term funding for temporary positions related to additional outreach to local educational agencies, and the preparation and production of guidance documents for local educational agency testing of water for lead. This proposal reflects the Water Board's directive to work with local educational agencies (school districts) and local public water systems to incorporate water quality testing in schools.

The remaining funding and the 2 positions will improve reporting to the U.S. Environmental Protection Agency (U.S. EPA) regarding public water system compliance with federal requirements. This proposal responds to a recent letter from the U.S. EPA that noted deficiencies in federal reporting as part of the Water Board's administration of the Safe Drinking Water Act.

Increased Statutory Limit for Safe Drinking Water Account Expenditures—It is requested that trailer bill language be adopted (see Attachment 1) to allow for the augmentations included in the Administration's various budget proposals that use Safe Drinking Water Account funding.

Drought Preparedness and Resiliency for Urban Water Agencies—It is requested that Item 3940-001-0001 be increased by \$240,000. These one-time resources will support the Department of Water Resources' activities to improve drought preparedness and resiliency for local urban water agencies and long-term water conservation through Water Shortage Contingency Plan improvements and development of long-term urban water use targets. The Department of Water Resources is also requesting funding in a separate Finance Letter.

Loan Repayment Deferral—It is requested that Item 3940-403 be added (see Attachment 2) to defer a \$1.6 million General Fund loan repayment to the Drinking Water Operator Certification Special Account until June 30, 2019.

Health and Safety Code Section 116590

- (a) Funds received by the state board pursuant to this chapter shall be deposited into the Safe Drinking Water Account that Account, which is hereby established, and shall be available for use by the state board, upon appropriation by the Legislature, for the purpose of providing funds necessary to administer this chapter. Funds in the Safe Drinking Water Account may shall not be expended for any purpose other than as set forth in this chapter.
- (b) A public water system may be permitted to may collect a fee from its customers to recover the fees paid by the public water system pursuant to this chapter.
- (c) The total amount of funds received for state operations program costs to administer this chapter for fiscal year 2016–17 shall not exceed thirty million four hundred fifty thousand dollars (\$30,450,000) thirty eight million fifty eight thousand dollars (\$38,058,000) and the total amount of funds received for administering this chapter for each fiscal year thereafter shall not increase by more than 5 percent of the amount received in the previous fiscal year plus any changes to salary, benefit, and retirement adjustments contained in each annual Budget Act. (d) This section shall become operative on July 1, 2016.

3940-403—Notwithstanding Provision 1 of Item 4265-011-0247, Budget Act of 2008 (Chs. 268 and 269, Stats. 2008), as amended by Item 4265-402, Budget Acts of 2010 (Ch. 712, Stats. 2010), 2012 (Chs. 21 and 29, Stats. 2012), 2013 (Chs. 20 and 354, Stats. 2013), and transferred by Item 3940-403, Budget Act of 2014 (Chs. 25 and 663, Stats. 2014), the \$1,600,000 loan to the General Fund will be repaid no later than June 30, 2019 upon order of the Director of Finance.
