Renewable Resources Trust Fund Loan Repayment—It is requested that Item 3600-011-0321 be added to reflect a loan of \$3,461,000 from the Oil Spill Response Trust Fund to the Renewable Energy Resources Development Fee Trust Fund with provisional language specifying that the loan is to be repaid with fees collected for mitigation actions developed and approved by the Department of Fish and Wildlife pursuant to Fish and Game Code section 2069 (see Attachment 1). Chapter 9, Statutes of 2010 established the Renewable Energy Resources Development Fee Trust Fund and authorized a \$10 million loan from the Renewable Resources Trust Fund. Loan repayment was due December 31, 2013. At the time, the fund did not have sufficient funds to repay the loan in full; therefore, a partial repayment of \$6,539,000 was processed. Extension of Loan Repayment—It is requested that Item 3600-401 be added to reflect the extension of a portion of the General Fund loan repayment to the Oil Spill Response Trust Fund (see Attachment 2). - (b) A transfer or loan described in subdivision (a) shall be repaid as soon as possible if a spill occurs and the administrator determines that response funds are needed immediately.
- (c) If there is a conflict between this section and any other law or enactment, this section shall control.
- (d) This section shall become inoperative on July 1, 20172019, and, as of January 1, 20182020, is repealed, unless a later enacted statute, that becomes operative on or before January 1, 20182020, deletes or extends the dates on which it becomes inoperative and is repealed."

Amendment to and Addition of Various Budget Bill Items, Support, and Trailer Bill Language, Multiple Departments—Integrating Environmental Justice into Disadvantaged Communities and California Pesticide Air Monitoring Network

Integrating Environmental Justice into Disadvantaged Communities

In 2013, the California Environmental Protection Agency (CalEPA) created the Environmental Justice Compliance and Enforcement Working Group (Working Group) to more fully integrate environmental justice into enforcement of environmental laws. Through the Working Group, Cal-EPA and its boards and departments led pilot enforcement and compliance initiatives in two of the most environmentally burdened areas of the state, one in Fresno and another in the Boyle Heights and Pacoima neighborhoods in Los Angeles. The Working Group conducted community outreach, engaged local agency enforcement partners, conducted compliance assistance and inspections, and took actions to return regulated entities to compliance when violations were observed.

These pilot programs had positive results. In addition to correcting violations discovered through inspections, the pilot programs also created conditions that will lead to greater environmental compliance in the future and improved and more coordinated working relationships between the community and the local, state, and federal regulating agencies involved in the initiatives. These pilot projects demonstrate a need for permanent resources to continue and enhance enforcement and compliance activities in disadvantaged communities statewide.

It is requested that various items be increased as follows to address the need for permanent resources to continue and enhance enforcement and compliance activities in disadvantaged communities statewide.

CalEPA—It is requested that Item 0555-001-0028 be increased by \$344,000 and 2 positions to lead and coordinate CalEPA's efforts to improve environmental justice results statewide. It is also requested that trailer bill language be adopted to clarify CalEPA and departmental responsibilities in addressing environmental justice issues (see Attachment 1).

Air Resources Board (ARB)—It is requested that Item 3900-001-0115 be increased by \$140,000 and 1 position to address workload coordinating and monitoring the ARB's environmental justice efforts with CalEPA and other participating departments.

Department of Pesticide Regulation (DPR)—It is requested that Item 3930-001-0106 be increased by \$140,000 and 1 position to address workload coordinating and monitoring the department's environmental justice efforts with CalEPA and other participating departments.

State Water Resources Control Board (SWRCB)—It is requested that Item 3940-001-0439 be increased by of \$140,000 and 1 position to address workload coordinating and monitoring the SWRCB's environmental justice efforts with CalEPA and other participating departments.

Department of Resources Recycling and Recovery—It is requested that the following items be increased to address workload coordinating and monitoring the department's environmental justice efforts with CalEPA and other participating departments:

- Increase Item 3970-001-0100 by \$28,000
- Increase Item 3970-001-0133 by \$28,000
- Increase Item 3970-001-0226 by \$29,000
- Increase Item 3970-001-0387 by \$28,000 and 1 position
- Increase Item 3970-001-3065 by \$27,000

California Pesticide Air Monitoring Network

California's pesticide air monitoring network is currently comprised of six sites that are monitored year round by the DPR and the ARB for various fumigant pesticides. ARB has also conducted seasonal ambient studies for DPR, most recently to determine the effects of DPR's chloropicrin mitigation measures implemented in 2015.

Although the combination of seasonal and year-round air monitoring has done much to improve the understanding of health risks associated with pesticide application, the pesticide air monitoring network is still a limited monitoring network compared to other networks for ozone and fine particulates. This proposal expands the scope of the current year-round pesticide monitoring network from six to eight sites, and also increases the seasonal ambient monitoring studies to three locations. These steps will enable DPR to better assess risk in more of California's communities, especially in environmental justice areas which already bear a disproportionate share of the air pollution burden.

ARB—It is requested that Item 3900-001-0106 be added in the amount of \$463,000 on a two year limited-term basis to expand California's existing year round air monitoring network and seasonal site studies with a focus on environmental justice considerations.

It is requested that Item 3900-001-0115 be increased by \$851,000 on a two year limited-term basis to provide equipment for air monitoring near schools in environmental justice communities. Of this amount, \$715,000 is for equipment purchases and \$136,000 is for limited-term maintenance funding. It is also requested that provisional language be added specifying that Air Pollution Control Fund civil penalties be used for the one-time equipment costs (see Attachment 2).

DPR—It is requested that Item 3930-001-0106 be increased by \$1,024,000 on a two year limited-term basis to expand California's existing year round air monitoring network and seasonal site studies with a focus on environmental justice considerations.

Government Code section 12812.2

- "(a) One of the deputies to the Secretary for Environmental Protection shall be a deputy secretary for law enforcement and counsel, who, subject to the direction and supervision of the secretary, shall have the responsibility and authority to do all of the following:
- (1) Develop a program to ensure that the boards, departments, offices, and other agencies that implement laws or regulations within the jurisdiction of the California Environmental Protection Agency take consistent, effective, and coordinated compliance and enforcement actions to protect public health and the environment. The program shall include training and cross-training of inspection and enforcement personnel of those boards, departments, offices, or other agencies to ensure consistent, effective, and coordinated enforcement.
- (2) (A) In consultation with the Attorney General, establish a cross-media enforcement unit to assist a board, department, office, or other agency that implements a law or regulation within the jurisdiction of the California Environmental Protection Agency, to investigate and prepare matters for enforcement action in order to protect public health and the environment. The unit may inspect and investigate a violation of a law or regulation within the jurisdiction of the board, department, office, or other agency, including a violation involving more than one environmental medium and a violation involving the jurisdiction of more than one board, department, office, or agency. The unit shall exercise its authority consistent with the authority granted to the head of a department pursuant to Article 2 (commencing with Section 11180) of Chapter 2 of Part 1.
- (B) The boards, departments and offices within the California Environmental Protection Agency shall participate in the cross-media enforcement unit established pursuant to this section. The unit, including representatives from the boards, departments and offices, shall focus its activities in disadvantaged communities identified by the California Environmental Protection Agency, through the California Communities Environmental Health Screening Tool. The activities of the unit shall be consistent with Public Resources Code section 71110.
- (3) Refer a violation of a law or regulation within the jurisdiction of a board, department, office, or other agency that implements a law or regulation within the jurisdiction of the California Environmental Protection Agency to the Attorney General, a district attorney, or city attorney for the filing of a civil or criminal action.
- (4) Exercise the authority granted pursuant to paragraph (3) only after providing notice to the board, department, office, or other agency unless the secretary determines that notice would compromise an investigation or enforcement action.
- (b) Nothing in this section shall authorize the deputy secretary for law enforcement and counsel to duplicate, overlap, compromise, or otherwise interfere with an investigation or enforcement action undertaken by a board, department, office, or other agency that implements a law or regulation subject to the jurisdiction of the California Environmental Protection Agency.
- (c) The Environmental Protection Agency shall post on its Web site, updated no later than December 1 of each year, the status of the implementation of this section."

Add the following provisions to Item 3900-001-0115:

- 1. The amount appropriated in this item includes revenues derived from the assessment of fines and penalties imposed as specified in Section 13332.18 of the Government Code.
- 2. Notwithstanding any other provision of law, of the amount appropriated in this item, \$851,000 shall be from penalty revenues that are subject to separate accounting in accordance with Health and Safety Code Sections 38580, 39674-39675, 42400-42410, 42420-42421, 43016, 43025-43031.5, 43154, 43211, and 43212. These funds shall be available for a one-time equipment purchase of air monitoring equipment and maintenance expenses of said equipment to assist the Department of Pesticide Regulation in their air monitoring network program.

Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance, Multiple Departments—Emergency Drought Response

The State of California is experiencing its fifth consecutive year of below-average rain and snow, and is currently facing severe drought conditions in various parts of the state. The four years between 2012 and 2015 were the driest four consecutive years on record in California. The winter of 2015-16 brought welcome storms to Northern California, but the Southern half of the state remains dry. Although the state's major northern reservoirs—Shasta, Oroville, and Folsom—all have higher-than-average storage levels for this time of year, storage in southern state reservoirs continues to lag. San Luis Reservoir—a key supplier to urban Southern California and the San Joaquin Valley—holds only half its average storage this time of year, and less than it held a year ago. The May Revision proposes additional resources for emergency drought response, based on current drought conditions. The details of this request are as follows:

Department of Forestry and Fire Protection—It is requested that Item 3540-001-0001 be increased by \$11 million to provide support costs and grants in affected counties to address dead and dying trees caused by drought and beetle infestation and that provisional language be added making the funds available for three years (see Attachment 1).

It is requested that Item 3540-001-0001 be increased by \$10,441,000 and 22 temporary help positions to provide for a contract for exclusive use helicopters for firefighting. The Department of Forestry and Fire Protection anticipates increased fire activity due to drought and tree mortality.

Department of Fish and Wildlife—It is requested that Item 3600-001-0001 be amended to redirect \$4.2 million General Fund for actions to benefit Delta smelt. It is also requested that 3 positions be reduced from the Governor's Budget Drought Proposal. Populations of Delta smelt are at historic lows as a result of unprecedented drought conditions. This proposal provides additional resources to improve habitat, promote food production, enhance aquatic weed control, and expand monitoring efforts to boost smelt populations. Funding for these efforts will be redirected from other drought response efforts originally proposed in the Governor's Budget, but no longer necessary as a result of improved conditions in the northern part of the state.

Department of Water Resources (DWR)—It is requested Item 3860-001-0001 be decreased by \$42 million. With improved hydrologic conditions from the Sacramento River basin this past winter the DWR will not need to install the proposed emergency salinity barrier for the spring of 2016 and therefore no funding is needed to remove any such barrier in the fall of 2016.

It is requested that Item 3860-001-0001 be decreased by \$3 million for the Save Our Water campaign to reflect the reduced need for a statewide campaign this year.

It is requested that Item 3860-101-0001 be increased by \$5 million to provide local assistance for local agencies to address cost effective long-term solutions for drinking water shortages in disadvantaged communities.

It is requested that Item 3860-490 be amended to reappropriate funds from various support appropriations from prior years to support the planning, permitting, and installation of emergency drought barriers in the spring of 2017 if conditions warrant (see Attachment 2).
