Amendment to and Addition of Various Budget Bill Items, Support, California Transportation Commission

Personal Service Fund Shift (Issue 401)—It is requested that the following items be adjusted and added to properly reflect the allocation of current workload. This net-zero adjustment is necessary because programs funded with Proposition 1B are decreasing, while the California Transportation Commission's responsibilities for projects funded by the State Transportation Account have increased. This request includes changes to the following items:

- Increase Item 2600-001-0042 by \$510,000 and 2.7 positions
- Decrease Item 2600-001-6055 by \$143,000 and 0.8 positions
- Decrease Item 2600-001-6056 by \$110,000 and 0.7 positions
- Decrease Item 2600-001-6058 by \$135,000 and 0.8 positions
- Decrease Item 2600-001-6059 by \$25,000 and 0.1 positions
- Decrease Item 2600-001-6060 by \$63,000 and 0.3 positions
- Decrease Item 2600-001-6063 by \$2,000 and 0.1 positions
- Decrease Item 2600-001-6064 by \$44,000 and 0.2 positions
- Add Item 2600-001-6072 in the amount of \$12,000 and 0.1 positions (see Attachment 1)

Amendment to Various Budget Bill Items and Reimbursements, Support, Local Assistance, and Capital Outlay, Department of Transportation

Capital Outlay Support: Project Delivery Workload—It is requested that the Capital Outlay Support program be increased by \$32,504,000 and decreased by 151 positions. This request reflects an overall reduction in anticipated workload resulting from winding down of Proposition 1B programs and lower estimated revenues from the state excise tax that supports the State Transportation Improvement Program. Additionally, this request fully funds all authorized positions based on actual cost of salaries. This request includes changes to the following items:

- Increase Item 2660-001-0042 by \$74,209,000 and decrease 329 positions
- Increase Item 2660-001-0890 by \$71,141,000 and 654 positions
- Increase Item 2660-002-3007 by \$8,833,000 and 21 positions
- Decrease Item 2660-004-6055 by \$23,934,000 and 74 positions
- Decrease Item 2660-004-6056 by \$8,617,000 and 54 positions
- Decrease Item 2660-004-6058 by \$756,000 and 1 position
- Decrease Item 2660-004-6060 by \$733,000 and 2 positions
- Decrease Item 2660-004-6064 by \$277,000 and 1 position
- Decrease Item 2660-004-6072 by \$8,001,000 and 36 positions
- Decrease reimbursements for Item 2660-001-0042 by \$79,783,000 and 331 positions
- Increase Government Code section 8879.3 (Fund 0653) by \$422,000 and 2 positions

It is also requested that the Capital Outlay Support program be increased by an additional \$155,464,000 and 352 positions and the Capital Outlay Projects program be decreased by \$83,445,000 to reflect the use of the new revenues to fund the increased support workload associated with the Governor's Transportation Package. The request includes changes to the following items:

- Increase Item 2660-001-0042 by \$72,019,000
- Increase Item 2660-001-3291 by \$83,445,000 and 352 positions
- Decrease Item 2660-301-3291 by \$83,445,000

**Federal Bridge Load Rating**—It is requested that Item 2660-001-0890 be increased by \$3,279,000 and 17 positions to complete federally required bridge load rating reports, making permanent a number of temporary positions that expire over the next two years.

**District 7 Express Lane Maintenance**—It is requested that Item 2660-001-0042 be amended by increasing reimbursements by \$2,377,000. Maintenance services being performed on the Interstate 10 and 110 express lanes by Caltrans will now be reimbursed by the local tolling authority that operates these lanes, consistent with the long-term plan.

**Lease Revenue Bond Refinancing**—It is requested that Item 2660-001-0042 be decreased by \$943,000 to reflect reduced lease rental payment for Caltrans' San Diego office due to the refinancing of the original lease revenue bonds.

Reappropriation of Bond Funds—It is requested that language be added to Item 2660-494 to reappropriate funds from the Highway Safety, Traffic Reduction, Air Quality, and Port Security Bond Act of 2006 (Proposition 1B) and the Safe, Reliable, High-Speed Passenger Train Bond Act (Proposition 1A) to reflect project savings and extensions. Local Proposition 1A bond funds are being used to complete three positive train control safety projects and Proposition 1B funds are being used for projects on State Route 99. Suggested Budget Bill language is attached (see Attachment 1).

**Fixing America's Surface Transportation (FAST) Act Federal Grants**—It is requested that language be added to Items 2660-302-0042 and 2660-302-0890 to allow these funds to be used for the state match for any grants received by the state from the new federal FAST program (see Attachment 2). These competitive grants can cover up to 60 percent of project costs, and the remaining 40 percent can be split between other federal and non-federal funds.

**Technical Adjustments**—It is requested that technical adjustments be made to various budget items resulting in a total reduction of \$243,431,000. In developing the 2016-17 Governor's Budget there were several items that were adjusted incorrectly due to a misunderstanding regarding how to reflect these changes. This request includes changes to the following items:

- Decrease Item 2660-302-0042 by \$243,430,000
- Decrease Item 2660-102-0890 by \$3,471,000
- Increase Item 2660-302-0890 by \$3,471,000
- Decrease reimbursements for Item 2660-005-0042 by \$1,000
- Decrease reimbursements for Item 2660-302-0042 by \$200 million
- Increase reimbursements for Item 2660-301-0046 by \$200 million

Additionally, for Item 2660-001-0042, it is requested that funding be shifted between various programs and reimbursements for the Capital Outlay Support and Administration programs be increased by \$8.1 million while the Operations and Distributed Administration programs are decreased by \$8.1 million.

Notwithstanding any other provision of law, the California Transportation Commission (CTC) may allocate up to \$60 million from this item to provide the required non-federal match to any state-sponsored project receiving a federal grant under the Fostering Advancements in Shipping and Transportation for the Long-term Achievement of National Efficiencies (FASTLANE) grants program authorized by the Federal Fixing America's Surface Transportation Act (FAST Act).

Add the following provisions to Item 2660-302-0890:

- 6. Notwithstanding any other provision of law, the California Transportation Commission (CTC) may allocate up to \$60 million from this item to provide the required match to any state-sponsored project receiving a federal grant under the Fostering Advancements in Shipping and Transportation for the Long-term Achievement of National Efficiencies (FASTLANE) grants program authorized by the Federal Fixing America's Surface Transportation Act (FAST Act).
- 7. Notwithstanding any other provision of law, the California Transportation Commission (CTC) will allocate Nationally Significant Freight Highway Program formula funds to corridor-based projects elected by local agencies and the State.
