**Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance,
Air Resources Board**

Implementation of Oil and Gas Methane Regulation—It is requested that Item 3900-001-3046 be increased by \$285,000 and Item 3900-001-3237 be increased by \$2,318,000 and 2 positions to implement and enforce the regulation to reduce methane emissions from oil and gas operations.

Continued Implementation and Program Oversight for Proposition 1B—It is requested that Item 3900-001-6054 be increased by \$826,000 and Item 3900-101-6054 be added in the amount of \$1,202,000 for support and implementation of various projects funded by Proposition 1B. It is also requested that Item 3900-495 be added to revert \$20 million unencumbered bond funds for support (see Attachment 1).

Implementation of the 3.0 Liter Volkswagen Consent Decree—It is requested that Item 3900-102-0115 be added in the amount of \$25 million to provide authority to spend penalty funds that will be received as part of the Volkswagen settlement agreement. These funds will support the zero-emission vehicle related aspects of the Enhanced Fleet Modernization Program Plus-Up program or other similar vehicle replacement programs, consistent with the Consent Decree (see Attachment 2). It is also requested that provisional language be included to make the funds available for encumbrance or expenditure through June 30, 2019.

**Amendment to Budget Bill Item 3900-301-0668, and Addition of Item 3900-301-0115,
Capital Outlay, Air Resources Board**

ARB Southern California Consolidation Project (Issue 300)—It is requested that Item 3900-301-0115 be added in the amount of \$82,624,000 and Item 3900-301-0668 be decreased by the same amount to reflect a partial shift of debt financing to cash funding for the construction phase of this project. As part of a court settlement with Volkswagen, the Air Resources Board will receive approximately \$154 million in civil penalties. Of this amount, \$82,624,000 is proposed for this project, which represents the Air Pollution Control Fund's share of the project's cost. By reducing the amount financed for this project, the state will reduce total debt service costs by an estimated \$66 million (see Attachment 1).

**Amendment to Budget Bill Item 3930-001-0106, and Addition of Item 3930-495, Support,
Department of Pesticide Regulation**

Pesticide Registration Data Management System Funding Realignment—It is requested that Item 3930-001-0106 be increased by \$3,022,000 and provisional language be added to support the development of the Pesticide Registration Database Management System, an integrated electronic system for pesticide registration (see Attachment 1). Additionally, it is requested that Item 3930-495 be added to revert unencumbered project funds (see Attachment 2). Funding was originally provided for this project in fiscal year 2015-16, but due to several project delays it is necessary to revert the unencumbered project funds and provide a new appropriation with an extended encumbrance or expenditure period through June 30, 2021. This request shifts expenditure authority for future years, but does not reflect an increase in total project costs.

**Amendment to Budget Bill Item 3940-001-0193 and Addition of Item 3940-001-8110,
Support, State Water Resources Control Board**

Funding for Fish Consumption Advisories—Technical Adjustment—It is requested that Item 3940-001-0193 be increased by \$381,000 to offset a corresponding decrease to the Cleanup and Abatement Account within the State Water Quality Control Fund, which is continuously appropriated. The fund shift is a correction to a proposal included in the Governor's Budget, for which a more appropriate fund source has been identified.

Open and Transparent Water Data Act—It is requested that Item 3940-001-8110 be added in the amount of \$289,000 to implement Chapter 506, Statutes of 2016 (AB 1755), Open and Transparent Water Data Act which requires the State Water Resources Control Board to help integrate existing water and ecological data information from multiple databases into a statewide data platform. This request is part of a combined proposal with the Department of Fish and Wildlife and the Department of Water Resources.
