Amendment to Budget Bill Item 8120-002-0903, Support, and Item 8120-102-0903, Local Assistance, Commission on Peace Officer Standards and Training

It is requested that Item 8120-002-0903 be decreased by \$4 million and Item 8120-102-0903 be increased by \$4 million to appropriately align funding for reimbursements provided to local law enforcement agencies for training activities. It is also requested that provisional language be added to earmark funds for training provided by the Museum of Tolerance (see Attachment 1). This language was inadvertently omitted in the 2017-18 Governor's Budget. These changes are necessary to adjust the Commission on Peace Officer Standards and Training's budget as part of the State Penalty Fund redistribution plan.

Add the following provision to Item 8120-002-0903:

3. Of the amount appropriated in this item, \$1,556,000 shall be used for contractual services in support of the "Tools of Tolerance" training program for law enforcement personnel operated by the Simon Wiesenthal Center-Museum of Tolerance. These contractual services shall only be used to provide training services to Commission on Peace Officer Standards and Training participating law enforcement agencies. Upon approval by the Department of Finance, funds may be transferred between this item and Item 8120-102-0903 to meet the needs of local training programs provided by Simon Wiesenthal Center-Museum of Tolerance. The transfer shall not reduce the total amount spent on training programs provided by Simon Wiesenthal Center-Museum of Tolerance by the Commission on Peace Officer Standards and Training. Upon requesting a transfer, the department shall provide justification for the increased expenditure in the item to which funds are transferred and the availability of excess funds in the item from which funds are transferred.

Add the following provision to Item 8120-102-0903:

2. Of the amount appropriated in this item, \$444,000 shall be used for allocation to cities, counties and cities and counties for the "Tools of Tolerance" training program for law enforcement personnel operated by the Simon Wiesenthal Center-Museum of Tolerance. Eligibility to receive funds appropriated for this purpose is limited to Commission on Peace Officer Standards and Training participating law enforcement agencies. At the discretion of the head of the law enforcement agency seeking reimbursement for this purpose, both sworn and nonsworn personnel who have contact with the public shall be eligible for reimbursement; however, priority should be given to sworn officers. To the extent funds are available after reimbursing the aforementioned personnel, peace officers employed by state law enforcement or correctional agencies shall be eligible to attend this training and receive reimbursement. Upon approval by the Department of Finance, funds may be transferred between this item and Item 8120-002-0903 to meet the needs of local training programs provided by Simon Wiesenthal Center-Museum of Tolerance. The transfer shall not reduce the total amount spent on training programs provided by Simon Wiesenthal Center-Museum of Tolerance by the Commission on Peace Officer Standards and Training. Upon requesting a transfer, the department shall provide justification for the increased expenditure in the item to which funds are transferred and the availability of excess funds in the item from which funds are transferred.

Amendment to and Addition of Various Budget Bill Items, Support, California Public Utilities Commission

Deputy Executive Director for Safety—It is requested that various items be increased in the amount of \$191,000 and 1 position, as follows:

- Increase Item 8660-001-0042 by \$7,000
- Increase Item 8660-001-0046 by \$11,000
- Increase Item 8660-001-0412 by \$4,000
- Increase Item 8660-001-0461 by \$20,000
- Increase Item 8660-001-0462 by \$131,000, and 1 position
- Increase Item 8660-001-0464 by \$1,000

It is also requested that trailer bill language be adopted to codify the Deputy Executive Director for Safety and Chief Internal Auditor positions. These changes are necessary to implement the Governor's 2016 signing message for a set of chaptered Public Utilities Commission (Commission) reform bills.

Federal Trust Fund Realignment to Authorize Spending of Federal Transit Administration Formula Grant Award—It is also requested that Item 8660-001-0890 be increased by \$2,664,000 to reflect receipt of a federal grant award. The grant will support Commission oversight of public rail transit system safety. The Commission is the federally designated State Safety Oversight Agency, and funding supports inspectors and engineers conducting safety inspections of track, vehicles, signals, train controls, and operations, as well as triennial safety audits.

It is further requested that provisional language be added to provide a two-year encumbrance period (see Attachment 1). This language is necessary to provide flexibility to the Commission to spend federal money over the course of the federal fiscal year, which runs through September 30, three months beyond the end of the state fiscal year.

Reappropriation—It is requested that Item 8660-490 be added to reappropriate funds for following purposes (see Attachment 2):

- Realigning current year expenditure authority from various funds for the development of an Information Technology eFiling Administration Support (eFAST) platform and related business configurations to comport with revised project plans that have been restructured to accommodate delays and other risks.
- Contracting for legal services with outside counsel representing the Commission in Federal Energy Regulatory Commission proceedings to recoup California ratepayer money on excessively priced electricity sales in California during the 2000-01 energy crisis.
- Obtaining consulting services to examine incumbent local exchange carrier service quality.
 The reappropriation of up to \$500,000 will be reimbursed by the incumbent local exchange carriers.

State Active Duty Compensation Alignment—It is requested that the California Military Department budget be increased by \$1,237,000 to align the pay of State Active Duty employees to the pay of their counterparts on federal active duty. This request requires changes to the following items:

Provisions:

- The State Public Works Board may issue lease-revenue bonds, notes, or bond anticipation notes pursuant to Chapter 5 (commencing with Section 15830) of Part 10b of Division 3 of Title 2 of the Government Code to finance the design and construction of the project authorized by this item.
- The Military Department and the State Public Works Board are authorized and directed to execute and deliver any and all leases, contracts, agreements, or other documents necessary or advisable to consummate the sale of bonds or otherwise effectuate the financing of the scheduled project.
- 3. Neither the State Public Works Board nor the Department of Finance shall be deemed a lead or responsible agency for purposes of the California Environmental Quality Act (Division 13 (commencing with Section 21000) of the Public Resources Code) for any action, approval or authorization provided with respect to the project authorized in this item. This provision does not exempt the Military Department Board from the requirements of the California Environmental Quality Act. This provision is declaratory of existing law.
- 4. The Military Department shall be a Department as defined in Public Contract Code section 10187.5(c) for procuring the contract(s) for the design build delivery process for the project authorized in Schedule (1) of this item."

Addition of Budget Bill Items 8955-301-0890, 8955-310-0668, and 8955-495, Capital Outlay, Department of Veterans Affairs

It is requested that Item 8955-495 be added to revert the unencumbered balance of the funds reappropriated in fiscal year 2016-17 for the following projects (see Attachment 1). It is also requested that Item 8955-310-0668 be added in the amount of \$10,553,000 (see Attachment 2), and that Item 8955-301-0890 be added in the amount of \$23,948,000 (see Attachment 3). These projects were originally appropriated in 2011, but had difficulty proceeding due to contracting issues and design delays related to the complexity of the projects. In February 2017, the Department of General Services provided updated cost analyses for these projects, which identified budget deficiencies resulting from increased costs and the current conditions in the construction services market in Napa County. This request incorporates the updated cost estimates for the projects listed below.

- Veterans Home of California, Yountville: Steam Distribution System Renovation—Working Drawings and Construction—This request will revert the unexpended balance of the original appropriations of approximately \$6.9 million (\$2.8 million lease revenue bond funds and \$4.1 million federal funds) reappropriated in 2016-17 for the working drawings and construction phases of this project. This request will also add \$14,164,000 (\$6,232,000 lease revenue bond funds and \$7,932,000 federal funds) for the working drawings and construction phases of this project. This request will allow the project to proceed to the construction phase in September 2019. Project completion is anticipated by September 2020.
- Veterans Home of California, Yountville: Chilled Water Distribution System Renovation—Construction—This request will revert the unexpended balance of the original appropriations of approximately \$5.4 million (\$1.7 lease revenue bond funds and \$3.7 federal funds) reappropriated in 2016-17 for the construction phase of this project. This request will also add \$10,957,000 (\$4,321,000 lease revenue bond funds and \$6,636,000 federal funds) for the construction phase of this project. This request will allow the project to proceed to the construction phase in January 2018. Project completion is anticipated by April 2019.

Veterans Home of California, Yountville: Central Power Plant Upgrade—
 Construction—This request will add \$9,380,000 federal funds for the construction phase of
 this project. In addition to this amount, approximately \$5.5 million will be used for this
 project from the continuously appropriated Veterans' Homes Fund, authorized by Military
 and Veterans Code section 1104.2. This request will allow the project to proceed to the
 construction phase in April 2018. Project completion is anticipated by August 2019.
