Technical Adjustments—It is requested that Item 3860-001-6007 be eliminated to reflect the lack of availability of bond funds in the Urban Stream Restoration Subaccount. It is also requested that Item 3860-001-3057 be decreased by \$24,000 to reflect updated calculations for the Division of Safety of Dams.

Proposition 13 San Joaquin River Fish Population Enhancement—It is requested that Item 3860-001-6026 be increased by \$3,730,000 to support work to improve fish populations in the San Joaquin River Watershed. The work will include construction of facilities such as physical habitat structures that have been modified to provide water delivery or flood water routing, and may involve the bed, banks, and floodways of the San Joaquin River and its tributaries.

Open and Transparent Water Data Act (AB 1755)—It is requested that Item 3860-001-8110 be added in the amount of \$2,490,000 to support 5 existing positions and implementation of the Open and Transparent Water Data Act, and that provisional language be included to require Department of Technology oversight (see Attachment 1). This expenditure authority will allow donations to the Water Data Administration Fund for work including the development and management of a statewide water data platform under a set schedule with prescribed protocols. This request is part of a combined proposal with the State Water Resources Control Board and the Department of Fish and Wildlife.

Reappropriations—It is requested that Item 3860-490 be added to reappropriate funds from various support appropriations from prior years with funding available for encumbrance or expenditure through June 30, 2019 (see Attachment 2). A number of water-related programs have been delayed for various reasons, including California Environmental Quality Act timelines, statutory and regulation changes, extended contracting processes, or state and federal permitting delays. The reappropriations will provide additional time for these projects to be completed.

Extensions of Liquidation—It is requested that Item 3860-491 be added to extend the liquidation period to June 30, 2019, for support projects previously encumbered under various

appropriations in prior years (see Attachment 3). This extension will provide additional time for final accounting and payments to be made on completed, or soon to be completed, projects.
