Amendment to and Addition of Various Budget Bill Item, Support and Local Assistance, California Public Utilities Commission

Supporting Statewide Presence (Sacramento)—It is requested that various items be decreased in the amount of \$52,000 in the budget year and \$124,000 ongoing, as follows:

- Decrease Item 8660-001-0042 by \$2,000 in the budget year and \$5,000 ongoing
- Decrease Item 8660-001-0046 by \$3,000 in the budget year and \$6,000 ongoing
- Decrease Item 8660-001-0461 by \$7,000 in the budget year and \$17,000 ongoing
- Decrease Item 8660-001-0462 by \$34,000 in the budget year and \$84,000 ongoing
- Decrease Item 8660-001-0464 by \$1,000 in fiscal year 2019-20 ongoing
- Decrease Item 8660-001-0471 by \$1,000 in the budget year and \$2,000 ongoing
- Decrease Item 8660-001-0483 by \$1,000 in the budget year and \$2,000 ongoing
- Decrease Item 8660-001-0493 by \$1,000 in the budget year and \$2,000 ongoing
- Decrease Item 8660-001-0890 by \$2,000 in the budget year and \$4,000 ongoing

The requested changes modify the Governor's Budget proposal to reflect cost savings from the termination of one leased location in Sacramento. If the PUC's Supporting Statewide Presence budget change proposal is approved, employees currently at that location will consolidate with staff at other PUC office locations.

Ongoing Strengthening of the Transportation Enforcement Branch—It is requested that Item 8660-001-0461 be increased in the amount of \$2,353,000 and 5 positions to provide staff for investigations and enforcement against illegally operating transportation carriers and for adequate leadership and supervision in the Transportation Enforcement Branch. Approximately \$1.4 million will fully fund existing positions (equivalent to 10 positions) for expanded investigations and enforcement workload, and \$975,000 would be for the 5 new positions. This request addresses the need for the Public Utilities Commission (PUC) to increase enforcement of laws against illegally operating transportation carriers and facilitate a fair market for compliant operators.

Regulation of Utilities Program Workload—It is requested that Item 8660-001-0462 be increased by \$996,000 and 4 positions to reflect increased workload related to natural gas reliability and regulation, legal support for an increased federal court case docket, and balancing account review requirements. This request includes the following four programmatic changes:

- Energy Division Compliance with Audit and Statutory Balancing Account Review Requirements—It is requested that Item 8660-001-0462 be increased by \$310,000 ongoing to support conversion of 2 currently limited-term positions to permanent positions within the Energy Division. These positions conduct utility balancing account reviews to protect ratepayers from unfair or unwarranted rate increases and were initially funded in fiscal year 2015-16, to maintain compliance with a State Auditor Report (2013-109) recommendation. The audit recommendation is now codified in Public Utilities Code section 792.5, making the workload ongoing.
- Gas Safety, Reliability, and Policy Legal Support—It is requested that Item 8660-001-0462 be increased by \$194,000 and 1 position to support increased workload related to natural gas reliability issues and the state's aging natural gas infrastructure. The position will also focus on regular gas market monitoring to detect market manipulation by gas operators, interstate gas transmission rate cases in front of the Federal Energy Regulatory Commission, state and federal pipeline safety matters in front of the PUC and the U.S. Department of Transportation, and defending the state's policies and stronger consumer protections in the face of intrusive or conflicting federal policies.
- Maximize Federal Litigation Outcomes—It is requested that Item 8660-001-0462 be increased by \$389,000 to fund 2 positions for two years to defend the PUC's implementation of state and federal legislation, policies, and rules. The PUC's federal court case docket expanded from one case in 2012-13 to 17 cases in 2017-18, with three cases filed in the last four months of calendar year 2017. Plaintiffs are challenging the state's renewable energy goals, statutory consumer privacy protections, just and reasonable rates and hearing processes, and the regulation of transportation network companies. Additional resources are necessary to address the increased workload and minimize court losses that could impede California's ability to realize executive and legislative goals and have cost implications for ratepayers in terms of consumer rates and fees, costs, or damages.
- Natural Gas Core Transport Agent Consumer Protection—It is requested that Item 8660-001-0462 be increased by \$103,000 and 1 position to implement a natural gas core transport agent regulatory and consumer protection program pursuant to Chapter 604, Statutes of 2013 (SB 656). This Chapter required the PUC to extend registration, oversight of, and consumer protection from core transport agents. The PUC began a two-phase rulemaking proceeding (Rulemaking 14-03-002) in 2014, and the PUC adopted the proposed decision on February 8, 2018. The position will support the decision's requirements which result in additional workload to register core transport agents, development of a "do not call" list, provision of consumer information, and mechanisms to enforce laws against core transport agents that violate PUC regulations.

Loan Repayment Extension—It is requested that Item 8660-403 be added to reflect the extension of a loan repayment from the Regional Railroad Accident Preparedness and Immediate Response Fund (3260) to the California High-Cost Fund-B Administrative Committee Fund (0470) (see Attachment 4). The Governor's Budget reflected a loan extension for both loans between these two funds, but the Budget Bill language only included the citation for one loan in Item 8660-402. This is intended to correct that oversight.

Extension of Liquidation Period, 2015 California Advanced Services Fund, Local Assistance—It is requested that Item 8660-490 be added to extend the liquidation period for Item 8660-101-3141, Budget Act of 2015, by two years, from June 30, 2018 to June 30, 2020 (see Attachment 1). Amendment to Various Budget Bill Items, Support, California Department of Veterans Affairs

Funding for the California Central Coast Veterans Cemetery—It is requested that Item 8955-001-0001 be increased by \$220,000 to enable the California Department of Veterans Affairs to continue operating the California Central Coast Veterans Cemetery. Funding from burial fees and federal burial allowances are insufficient to fully fund cemetery operations because the pace of burials is much lower than anticipated. It is also requested that Item 8955-001-0890 be decreased by \$143,000, and Items 8955-001-3013 and 8955-011-8048 be decreased by \$77,000 to reflect revised expenditure and transfer authority based on updated burial and revenue projections.

Amendment to Budget Bill Item 8955-301-0001, Capital Outlay, Department of Veterans Affairs

Veterans Home of California, Yountville: Skilled Nursing Facility—Performance Criteria—It is requested that Item 8955-301-0001 be decreased by \$8,624,000 to reflect updated costs and a shift in delivery method for this project (see Attachment 1). Funding for the preliminary plans phase of this project was included in the Governor's Budget in the amount of \$15,722,000, with total costs estimated at \$317,131,000 (\$15,722,000 for preliminary plans, \$12,984,000 for working drawings, and \$288,425,000 for construction) based on preliminary studies and cost analyses performed by the Department of General Services (DGS). Since then, DGS has completed additional geotechnical work on the site resulting in updated project costs. In addition, it has been determined that using the design-build project delivery method will provide additional cost and schedule efficiencies. This request will change the project delivery method to design-build, and update the project costs as follows: \$7,098,000 for performance criteria and \$286,411,000 for design-build, for a total project cost of approximately \$293,509,000.
