# Amendment to and Addition of Various Budget Bill Items and Statutory Changes, Capital Outlay, Various Departments

On March 4, 2020, the Governor declared a state of emergency to help the state prepare and respond to COVID-19. The impact on the state has resulted in a severe drop in economic activity, with corresponding negative effects on anticipated revenues. As a result of these conditions, all budget change proposals were reevaluated within the context of a workload budget based on the merits of each proposal and ultimately subject to the availability of funding.

As a result, the Administration is withdrawing, without prejudice, specified requests within the Capital Outlay area that were included in the 2020-21 Governor's Budget. The Administration is also modifying specified requests in this area that were included in the 2020-21 Governor's Budget. Modifications could include either reductions or increases to specific items or programs, or delaying substantial implementation of a new program or activity. Withdrawn requests are included on **Attachment 1 (See rows 1 through 44)**. Additional details on modified requests are listed below and on **Attachment 1 (See rows 45 through 56)**. To the extent there are corresponding Budget Bill language or statutory changes to withdrawn or modified proposals, these are detailed in **Section 1 of Attachment 2**. Although these proposals have substantial merit and may be resubmitted for future consideration, we must pivot to prioritize immediate COVID-19 related needs.

As noted above, pursuant to Budget Letter 20-08, the Department of Finance conducted a thorough assessment of the most critical funding needs within the general framework of workload budget, as defined in Government Code Section 13308.05, and based upon revised expected revenues. This assessment not only resulted in the changes described in the preceding paragraph, but also requires a number of new adjustments and requests that are respectfully submitted and detailed below. Funding detail for these adjustments can be found in **Attachment 1** (See rows 57 through 98), and any related Budget Bill or statutory language changes associated with these

adjustments can be found in **Section 2 of Attachment 2**. If necessary, additional information may be included in a Budget Change Proposal or other back-up documentation submitted to the Legislature.

Finally, after conducting a review of all 2020-21 Governor's Budget Proposals, a number of requests are being sustained. Funding detail for these adjustments can be found on **Attachment 1. (See rows 99 through 147)** 

# **Modified Governor's Budget Proposals:**

## Department of Forestry and Fire Protection:

- C130 Air Attack Base: Infrastructure Improvements—Various Phases. It is requested that Item 3540-301-0001 be decreased by \$11,441,000 to remove the construction appropriations that were included in the Governor's Budget for the Paso Robles, Fresno, and Ramona air attack bases. It is also requested that Item 3540-490 be amended to reappropriate design funding for these projects. The design phases for these projects were originally appropriated in the 2019 Budget Act; however, design delays have occurred due to the complexity of the projects. (See row 45 of Attachment 1)
- Minor Projects—Various Phases. It is requested that Item 3540-301-0001 be decreased by \$1,950,000 to reduce the minor project appropriation included in the Governor's Budget. The remaining appropriation amount is needed for the minor projects most critical to fire/life safety. Total project cost is \$2,650,000.
   (See row 46 of Attachment 1)
- Shasta Trinity Unit Headquarters/Northern Operations: Relocate Facility—Various Phases. It is requested that Item 3540-301-0001 be decreased by \$5,998,000 to remove working drawings funding for the Shasta Trinity Unit Headquarters/Northern Operations: Relocate Facility project included in the Governor's Budget. It is also requested that Item 3540-495 be amended to revert preliminary plans funding in the amount of \$4,329,000 appropriated in the 2019 Budget Act per workload Budget requirements. (See row 47 of Attachment 1)
- Various Technical Adjustments—Various Phases. It is requested that
  Items 3540-490 and 3540-495 be amended to provide for the reappropriation
  and reversion of eight existing General Fund and lease revenue bond funded
  projects. (See row 48 of Attachment 1)
- Ishi Conservation Camp: Replace Kitchen—Construction. It is requested that Item 3540-495 be amended to revert the General Fund construction (\$10,708,000) phase appropriation included in the 2019 Budget Act. It is further requested that Item 3540-301-0660 be amended to include a construction phase appropriation in the same amount. Replacing the kitchen that burned down at this facility is critical for continued operations. The change in fund source will allow this project to be completed without delay. (See row 49 of Attachment 1)

## Department of Parks and Recreation:

Modification of Equitable Access Program: New State Park—Various Phases.
 It is requested that Item 3790-301-0001 be decreased by \$15 million to reduce the proposal's impact to the General Fund while continuing to support equitable park access for all Californians. (See row 50 of Attachment 1)

# **Department of Corrections and Rehabilitation:**

- California State Prison, Corcoran: Medication Distribution Improvements, Phase II—Construction. It is requested that Item 5225-301-0001 be decreased by \$1,570,000 for a scope change related to a recent mission change for Housing Unit 3A4. (See row 52 of Attachment 1)
- AB 900 General Fund Reappropriation—Unallocated Phase. It is requested that Section 28 of Chapter 7, Statutes of 2007 (AB 900) be decreased by \$10,874,000 and Item 5225-491 be amended to remove the unallocated portion of the existing reappropriation. (See row 51 of Attachment 1)

## Department of Food and Agriculture:

• Anaheim Facility Purchase—Acquisition. It is requested that Item 8570-301-0001 be decreased by \$1,872,000 and Item 8570-301-3101 be added in the amount of \$1,872,000. The shift in fund source will allow the Department of Food and Agriculture to exercise the lease purchase option of the Anaheim Facility without delay. (See row 53 of Attachment 1)

### Military Department:

• Sacramento: Consolidated Headquarters Complex—Performance Criteria. It is requested that Item 8940-493 be amended to reflect an extension of liquidation for the performance criteria phase instead of the design-build phase. (See row 54 of Attachment 1)

### **Department of Veterans Affairs:**

Veterans Home of California-Yountville: Steam Distribution Renovation—
 Construction. It is requested that Item 8955-301-0001 be eliminated and
 Item 8955-301-0660 be added to reflect a change in fund source from the
 General Fund to the Public Buildings Construction Fund for the subject project.
 (See row 55 of Attachment 1)

### Capital Outlay Planning and Studies Funding:

• Statewide Planning and Studies—Study. It is requested that Item 9860-301-0001 be decreased by \$2 million. It is also requested that Item 9860-495 be added to partially revert funding included in the 2019 Budget Act per workload Budget requirements. (See row 56 of Attachment 1)

# **New Requests for May Revision:**

#### **Judicial Branch**:

• Stanislaus County: New Modesto Courthouse—Construction. It is requested that Item 0250-301-0660 be added in the amount of \$13,243,000 to fund additional

courtrooms at the New Modesto Courthouse continuing project. (See row 61 of Attachment 1)

- Stanislaus County: New Modesto Courthouse Reappropriation—Construction. It is requested that Item 0250-490 be added to reappropriate \$237,243,000 for the New Modesto Courthouse project because the construction start for this project has been delayed due to extended review periods. (See row 58 of Attachment 1)
- Riverside County: New Mid-County Civil Courthouse Reappropriation—
   Construction. It is requested that Item 0250-490 be added to reappropriate
   \$75,792,000 for the New Mid-County Civil Courthouse project because the
   construction start for this project has been delayed due to extended review
   periods. (See row 57 of Attachment 1)
- Riverside County: New Indio Juvenile and Family Courthouse Reappropriation—Construction. It is requested that Item 0250-490 be added to reappropriate \$19,764,000 for the New Indio Juvenile and Family Courthouse project because the construction start for this project has been delayed due to extended review periods. (See row 59 of Attachment 1)
- Sacramento County: New Sacramento Courthouse Reappropriation—
   Construction. It is requested that Item 0250-490 be added to reappropriate
   \$459,801,000 for the New Sacramento Courthouse project because the
   construction start for this project has been delayed due to extended review
   periods. (See row 60 of Attachment 1)

**Sonoma County: New Santa Rosa Courthouse Reappropriation—Construction.** It is requested that Item 0250-490 be added to reappropriate \$160,734,000 for the New Santa Rosa Courthouse project because the construction start for this project has been delayed due to extended review periods. (See row 62 of Attachment 1)

#### **Governor's Office of Emergency Services:**

- Relocation of Red Mountain Communications Site, Del Norte County—Working Drawings. It is requested that Item 0690-301-0001 be increased by \$979,000 to provide funding for road design to the Alder Camp site, to address soil and grade conditions at Rattlesnake Peak, and for engineering and special consultant work for sound attenuation at Rodgers Peak. (See row 63 of Attachment 1)
- Relocation of Red Mountain Communications Site, Del Norte County—Equipment. It is requested that Item 0690-491 be added to reappropriate the equipment phase of the subject project, consistent with project schedule. (See row 64 of Attachment 1)

# **Exposition Park:**

 Reversion of Legislative Investments—Various Phases. It is requested that Item 3100-495 be added to revert the unencumbered balance of 2019 Budget Act legislative investments. (See row 65 of Attachment 1)

## Department of Forestry and Fire Protection:

- San Luis Obispo Unit Headquarters Replacement Project Updates—Working Drawings and Construction. It is requested that the following changes be made to shift \$35,012,000 in lease revenue authority from Item 3540-301-0660, Budget Act of 2019 to Item 3540-301-0668 in order to be consistent with the 2015 Budget Act appropriation and to extend availability of working drawings: 1) Add Item 3540-301-0668 in the amount of \$35,012,000, 2) Amend Item 3540-490 to withdraw the reappropriation of construction proposed in the Governor's Budget, and 3) Amend Item 3540-495 to eliminate Item 3540-301-0660, Budget Act of 2019 project authority. (See row 66 of Attachment 1)
- Ventura Training Center: Renovate Facility—Working Drawings and Construction.
   It is requested that Item 3540-495 be amended to revert the working drawings (\$1,093,000) and construction (\$16,673,000) phase appropriations included in the 2018 Budget Act consistent with workload budget requirements. (See row 67 of Attachment 1)
- Potrero Forest Fire Station: Replace Facility—Working Drawings. It is requested
  that Item 3540-495 be amended to revert the working drawings (\$981,000) phase
  appropriation included in the 2019 Budget Act. Halting capital outlay that have
  not yet broken ground is consistent with workload budget requirements. (See
  row 68 of Attachment 1)

# **Department of Parks and Recreation**

Oceano Dunes SVRA: Pismo SB Sediment Track-Out Prevention—Construction. It is requested that Item 3790-301-0263 be added in the amount of \$827,000 to provide for the construction phase of this ongoing project intended to prevent sand or soil from being tracked onto public streets. (See row 70 of Attachment 1)

- Reimbursement Authority: Various Projects—Various Phases. It is requested that Item 3790-301-0392 be added to provide additional reimbursement authority to various capital outlay projects in order to make use of grants available to the Department of Parks and Recreation. Additionally, it is requested that Item 3790-496 be added to revert project funding being replaced with grant awards. (See row 73 of Attachment 1)
- Pfeiffer Big Sur State Park: Low-Cost Alternative Coastal Lodging—Working
  Drawings. It is requested that Item 3790-301-0952 be added in the amount of
  \$178,000 to develop working drawings for an ongoing project to provide for
  additional low cost coastal accommodations within this park. (See row 71 of
  Attachment 1)
- Torrey Pines SNR: Sewer and Utility Modernization—Construction. It is requested that Item 3790-301-6051 be increased in the amount of \$3,317,000 to provide for the construction phase of an ongoing project to connect the park to local sewer systems and upgrade aging water and utility infrastructure. (See row 69 of Attachment 1)

- Silver Strand SB: Low Cost Accommodations—Study. It is requested that Item 3790-301-6088 be increased by \$375,000 to fund the study phase of a project to provide increased lower cost coastal accommodations at Silver Strand State Beach. (See row 72 of Attachment 1)
- Statewide: Reappropriations—Various Phases. It is requested that Item 3790-491 be added to reappropriate funding for several ongoing projects consistent with updated project timelines. (See rows 74 through 76 of Attachment 1)
- California Indian Heritage Center—Working Drawings and Construction. It is requested that Item 3790-311-3312 and Item 3790-496 be added to revert out-year funding for working drawings and construction of the California Indian Heritage Center while the project is in preliminary plans. As future projects phases are lease revenue bond eligible, these changes will result in no project delays. (See row 77 of Attachment 1)

#### **Air Resources Board**

• Southern California Consolidation Project: Lease Revenue Bond
Reappropriation—Design-Build. It is requested that Item 3900-493 be added to
reappropriate lease revenue bond financing authority for the Southern California
Consolidated Lab. This project is currently in the design-build phase and is
scheduled to be complete by February 2022. (See row 78 of Attachment 1)

# **Department of Developmental Services:**

- Porterville Developmental Center: Upgrade Fire Alarm System—Construction. It is requested that Item 4300-301-0001 be added in the amount of \$1,345,000 to supplement the construction phase of this fire-life-safety project. Significant issues were encountered during the regulatory review process leading to a prolonged delay and increased costs. (See row 79 of Attachment 1)
- Porterville Developmental Center: Install Fire Sprinkler System—Preliminary Plans.
   It is requested that Item 4300-301-0001 be added in the amount of \$210,000 to provide for preliminary plans of a new project to correct recently identified fire-life-safety deficiencies. (See row 80 of Attachment 1)
- Porterville Developmental Center: Nitrate Removal System—Construction. It is
  requested that Item 4300-490 be added to reappropriate the construction phase
  of this project. Delays caused by the bankruptcy of the manufacturer of the
  nitrate removal equipment required modifications to working drawings. (See
  row 81 of Attachment 1)

# **Department of State Hospitals:**

• Patton: Fire Alarm System Upgrade—Construction. It is requested that Item 4440-490 be added to reappropriate the construction phase of this project. Delays in the regulatory review process have prolonged the working drawings phase. (See row 82 of Attachment 1)

• Metropolitan: Fire Alarm System Upgrade—Construction. It is requested that Item 4440-493 be added to extend the liquidation period for the subject project. (See row 83 of Attachment 1)

# Department of Corrections and Rehabilitation:

- California State Prison, Los Angeles County, Lancaster: Medication Preparation Room Unit D5—Preliminary Plans. It is requested that Item 5225-301-0001 be increased by \$300,000 for the preliminary plan phase of a new Medication Preparation Room in Housing Unit D5 at the California State Prison, Los Angeles County, Lancaster. (See row 84 of Attachment 1)
- Correctional Training Facility, Soledad: Health Care Facility Improvement Program, Specialty Care Clinic—Construction. It is requested that Item 5225-301-0660 be increased by \$2,666,000 to complete the construction phase of the Specialty Care Clinic project at the Correctional Training Facility, Soledad. This action is necessary to address cost increases caused by unforeseen building conditions at the project site. (See row 85 of Attachment 1)
- California Men's Colony, San Luis Obispo: West Facility Central Kitchen
  Replacement—Construction. It is requested that Item 5225-301-0660 be increased
  by \$8,205,000 to complete the construction phase of the central kitchen and
  satellite dining facilities projects at the California Men's Colony, West Facility.
  (See row 87 of Attachment 1)
- Various Projects: Health Care Facility Improvement Program, Increase Lease Revenue Bond Authority—Construction. It is requested that statutory language be adopted to increase the lease revenue appropriation authorized by Government Code section 15819.403 for this construction program by \$32,532,000. This program provides medical, dental, and mental health treatment or housing space at existing prison facilities. This action is necessary to address cost increases and to comply with the Receiver's Turn-Around Plan of Action related to the Plata litigation. This language also includes reporting requirements to allow the Legislature to monitor the progress in the program. (See row 86 of Attachment 1)

#### Hastings College of the Law:

 Hastings College of the Law, San Francisco: Academic Building Replacement— Design-Build. It is requested that Item 6600-493 be added to extend the liquidation period for the subject project. (See row 88 of Attachment 1)

# Board of Governors of the California Community Colleges:

• Continuing Community College Projects—Construction. It is requested that Item 6870-301-6087 be increased by \$194,675,000 in Proposition 51 General Obligations Bonds (Prop 51) to provide construction authority for 15 projects. These projects are scheduled to complete working drawings in 2020-21. (See row 89 of Attachment 1)

Siskiyou Joint Community College District, College of the Siskiyous: Theatre Arts Building Remodel/Addition—Preliminary Plans and Working Drawings. It is requested that Item 6870-301-6087 be increased by \$408,000 Prop 51 to

supplement authority proposed in the Governor's Budget for the subject project, aligning total authority with the initial Board of Governors' request. (See row 92 of Attachment 1)

- Yuba Community College District, Yuba College: Fire Alarm System Upgrade— Preliminary Plans and Working Drawings. It is requested that Item 6870-301-6087 be increased by \$377,000 Prop 51 to add the subject project. (See row 93 of Attachment 1)
- Reappropriate Various Community College Projects—Working Drawing and Construction: It is requested that Item 6870-492 be amended to add 13 projects (4 construction, 9 working drawings) to ensure districts can proceed with their respective phases without further delay, and to remove one project that the local district can no longer support. (See row 90 of Attachment 1)
- Rio Hondo Community College District, Rio Hondo College: L Tower Seismic and Code Upgrades—Construction: It is requested that Item 6870-493 be added to extend the liquidation period for the subject project. (See row 91 of Attachment 1)

#### **Department of General Services:**

• State Project Infrastructure Fund—Various Phases. It is requested that Item 7760-311-3292 be added to transfer \$754,192,000 from the State Project Infrastructure Fund to the General Fund. Costs associated with the design and construction phases of the Capitol Annex projects will be funded with lease-revenue bonds. (See row 94 of Attachment 1)

### Military Department:

- Los Alamitos: National Guard Readiness Center—Construction. It is requested that Item 8940-492 be amended to reappropriate the subject project due to delays in the federal review process. (See row 95 of Attachment 1)
- Sustainable Armory Renovation Program Projects—Various Phases. It is requested that Item 8940-495 be added to revert the unencumbered balance of 2019 Budget Act appropriations related to renovation projects at the Redding, Petaluma, and Visalia armories. (See row 96 of Attachment 1)

#### **Department of Veterans Affairs:**

- Veterans Home of California, Yountville: Skilled Nursing Facility—Design-Build. It is requested that Item 8955-301-0660 be added in the amount of \$317,093,000 to provide for the design-build phase of the subject project. (See row 97 of Attachment 1)
- Southern California Veterans Cemetery Master Development Fund—Study. It is requested that Item 8955-311-3313 be added to transfer \$24.5 million from the Southern California Veterans Cemetery Master Development Fund to the General Fund. (See row 98 of Attachment 1)
