Amendment to Various Budget Bill Items, Support, Department of Consumer Affairs

Business Modernization Cohort 2—It is requested that the following items be increased by the amounts indicated below to allow the Structural Pest Control Board, the California Architects Board (Landscape Architects Technical Committee), the Cemetery and Funeral Bureau, and the Bureau of Household Goods and Services (collectively known as Cohort 2), to begin implementation activities once their business modernization software solution is selected, consistent with the Department of Consumer Affairs' Business Modernization Plan. Funding for this project will be requested one year at a time. Additionally, it is requested that provisional language be added to the following items to provide flexibility for the Department to expend this funding once the project is approved by the California Department of Technology (see Attachment 1).

- Item 1111-001-0706 be increased by \$665,000 and 1 position
- Item 1111-001-0757 be increased by \$165,000
- Item 1111-001-0775 be increased by \$897,000
- Item 1111-001-3315 be increased by \$202,000
- Item 1111-002-0325 be increased by \$1,126,000 and 2 positions
- Item 1111-002-0717 be increased by \$902,000
- Item 1111-002-0752 be increased by \$389,000

It is also requested that Schedule (3) of Item 1111-002-0702 be increased by \$735,000 and 5 positions, and Schedule (6) be decreased by \$735,000, to reflect corresponding adjustments for information technology staff to support the project.

Business Modernization–Speech-Language Pathology and Audiology and Hearing Aid Dispensers Board—It is requested that Item 1111-001-0376 be increased by \$1,117,000 and 1 position, to allow the Board to complete planning activities and begin implementation activities related to its business modernization software solution, consistent with the Department's Business Modernization Plan. Funding for this project

will be requested one year at a time. Additionally, it is requested that provisional language be added to this item to provide flexibility for the Department to expend this funding once the project is approved by the California Department of Technology (see Attachment 2).

It is also requested that Schedule (3) of Item 1111-002-0702 be increased by \$143,000 and 1 position, and Schedule (6) be decreased by \$143,000, to reflect corresponding adjustments for information technology staff to support the project.

Augmentation for Attorney General Services (Bureau of Security and Investigative Services)—It is requested that Item 1111-002-0239 be increased by \$800,000 to provide two-year limited-term funding to support the increased use of Attorney General services resulting from Chapter 800, Statutes of 2016, which requires appeals related to firearm assessments to be referred for formal administrative hearings. This will allow the Bureau of Security and Investigative Services to continue working on alternatives to help mitigate these costs and improve the current appeals process.

Augmentation and Continuation of Resources for the Licensed Physicians and Dentists from Mexico Pilot Program—It is requested that Item 1111-001-0942 be increased by \$242,000 and 0.5 position, to align resources for this pilot program with the current implementation timeline. It is also requested that Item 1111-001-0758 be decreased by 1.1 positions to allow for technical clean-up of existing position authority, by shifting the current position need to Item 1111-001-0942. The baseline funding for this program is limited-term and will expire on June 30, 2022. This request increases funding to a total of \$362,000 in fiscal year 2021-22, and continues funding for the subsequent two fiscal years, to allow the Department to fully implement the pilot program and complete the required evaluations and reports to the Legislature. This request is only for the medical program, as no donations have been received for the dental program.

Amendment to Budget Bill Item 1750-001-3153, and Addition of Item 1750-001-3380, Support, California Horse Racing Board

It is requested that Item 1750-001-3153 be decreased by \$434,000 and 2 positions and Item 1750-001-3380 be added in the amount of \$890,000 and 2 positions to implement the horse safety measures required by Chapter 251, Statutes of 2020 (AB 1974). The 2020 Budget Act included resources for the California Horse Racing Board to establish horse safety panels across the state. This request will shift resources from the Horse Racing Fund to the newly established Horse and Jockey Safety and Welfare Account to support the horse safety panels approved in the 2020 Budget Act, and to implement the safety related measures required by AB 1974. This request will result in a net-zero funding shift by fiscal year 2023-24.

Addition of Budget Bill Items 2240-103-6069 and 2240-491, Local Assistance, Department of Housing and Community Development

Infill Infrastructure Grant Program Reallocation of Proposition 1 Funds—It is requested Item 2240-103-6069 be added in the amount of \$124.1 million from Veterans and Affordable Housing Bond of 2018 (Proposition 1) funds, to allow the Department of Housing and Community Development to make additional Infill Infrastructure Grant Program of 2007 (IIG) awards in fiscal year 2021-22 (see Attachment 1). It is also requested that Item 2240-491 be added to reappropriate \$160 million Proposition 1 funds to extend the encumbrance period of the 2020 Budget Act IIG appropriation by one year, from June 30, 2021 to June 30, 2022, to allow the Department additional time to make infill project awards (see Attachment 2).

The \$124.1 million in Proposition 1 funds requested will augment the \$250 million General Fund proposed in the Governor's Budget for Brownfield remediation and traditional IIG projects in 2021-22. The extended encumbrance period requested for the \$160 million in grant funds will allow the funds to be issued alongside the \$250 million General Fund proposed for the current year in the Governor's Budget for traditional IIG projects.

Combined with previous appropriations, this proposal would result in a total of \$1.1 billion in state funds for IIG projects over three fiscal years.
