Addition of Budget Bill Items 8120-490 and 8120-491, Local Assistance, Commission on Peace Officer Standards and Training

Distance Learning and Use of Force Training Equipment Reappropriations—It is requested that Item 8120-490 be added to extend the encumbrance availability for \$10 million included in the 2018 Budget Act and reappropriated through the 2020 Budget Act by one year, from June 30, 2021 to June 30, 2022 (see Attachment 1). This will enable the Commission on Peace Officer Standards and Training to successfully complete the Project Approval Lifecycle process in collaboration with the California Department of Technology for its Learning Management System Modernization Project and administer a related distance learning grant program.

It is further requested that Item 8120-491 be added to extend the encumbrance availability of \$300,000 included in the 2018 Budget Act for use of force training by one year, from June 30, 2021 to June 30, 2022. This will provide additional time to support the deployment of related equipment to enhance peace officer training experiences (see Attachment 2).

Consolidated Headquarters Complex: Elimination of Lease Savings—It is requested that Item 8940-001-0001 be increased by \$1,682,000 one-time to reflect the elimination of lease savings due to completion delays at the new Consolidated Headquarters Complex.
