Amendment to Budget Bill Item 3100-001-0267, Support, Exposition Park

It is requested that Item 3100-001-0267 be amended by adding provisional language authorizing up to \$11.9 million General Fund transfer authority to the Exposition Park Improvement Fund to offset unanticipated revenue loss resulting from public health-related closures related to the COVID-19 pandemic. Additionally, it is requested that provisional language be added notwithstanding Provision 2 of Item 9850-011-0001, Budget Act of 2020, to allow \$2.5 million of the General Fund available for transfer to be used in repayment of a fiscal year 2020-21 loan (see Attachment 1).

The COVID-19 pandemic has resulted in significant revenue loss for the Fund, which relies primarily on special event rentals and parking fees associated with currently prohibited public gatherings and museum visitation. Progressive extensions on public health restrictions have made it necessary to address this revenue shortfall beyond prior current year authorizations.

Add the following provisions to Item 3100-001-0267:

- 3. Notwithstanding any other law, upon order of the Department of Finance, the Controller shall transfer \$2,500,000 from the General Fund to the Exposition Park Improvement Fund for the purposes of repayment of a loan authorized under Item 9850-011-0001, Budget Act of 2020 to address unanticipated revenue loss resulting from public health-related closures of Exposition Park. The Chairperson of the Joint Legislative Budget Committee shall be notified of any transfers authorized pursuant to this provision.
- 4. Notwithstanding any other law, upon order of the Department of Finance, the Controller shall transfer up to \$4,700,000 from the General Fund to the Exposition Park Improvement Fund to offset unanticipated revenue loss resulting from public health-related closures of Exposition Park. The Chairperson of the Joint Legislative Budget Committee shall be notified of any transfers authorized pursuant to this provision.
- 5. Notwithstanding any other law, upon order of the Department of Finance, the amount available for transfer from the General Fund in Provision 4 may be increased by an additional \$4,700,000. The Chairperson of the Joint Legislative Budget Committee shall be notified of any transfers authorized pursuant to this provision.

Amendment to the School Energy Efficiency Stimulus Program, Support, Energy Resource Conservation and Development Commission

It is requested that the School Energy Efficiency Program be increased by \$250,000 annually from 2021-22 through 2023-24 for the Energy Resource Conservation and Development Commission to implement requirements associated with Chapter 372, Statutes of 2020 (AB 841). The statute requires the Commission to establish the School Energy Efficiency Stimulus Program which provides grants to local educational agencies for upgrades to heating, ventilation, air conditioning, and plumbing systems.

The additional resources are necessary to develop the School Energy Efficiency Database System, a web-based tool for screening and processing applications and tracking grants. The Governor's Budget proposed to continuously appropriate these funds, however the Budget Bill does not contain an item of appropriation for the California Energy Commission.

Amendment to Budget Bill Items 3600-001-0200, 3600-001-0890, and Reimbursements, Support, California Department of Fish and Wildlife

Dedicated Fish and Game Preservation Fund Realignment—It is requested that Item 3600-001-0200 be increased by \$3,858,000 ongoing and 19 positions to align program expenditures with the associated revenues of four dedicated accounts within the Fish and Game Preservation Fund. These resources will help the Department of Fish and Wildlife maintain structural balance and support increased workload.

Nutria Eradication Program Staffing—It is requested that Item 3600-001-0200 be increased by 17 permanent positions to replace the temporary positions used to support the Nutria Eradication and Control Program field operations.

Reimbursement and Federal Trust Fund Authority Increase—It is requested that Item 3600-001-0200 be amended by increasing reimbursements by \$8.9 million and Item 3600-001-0890 be increased by \$2.5 million to provide adequate authority for the Department to receive and expend reimbursement and federal grant funds necessary to the Department's operation. Specifically, this will enable the Department to accept federal grants from the United States Fish and Wildlife Service and other federal partners, and reimbursement from various state and private entities for the purpose of species and ecosystem conservation programs.

Amendment to and Addition of Various Budget Bill Items and Reimbursements, Support and Capital Outlay, Department of Parks and Recreation

Department of Parks and Recreation, Woolsey Wildfire Repair-Phase II (Issue 148)—It is requested that Item 3790-001-0001 be decreased by \$10 million, Item 3790-001-0392 be decreased by \$23,350,000 and amended by increasing reimbursements by \$23,350,000, and Item 3790-004-0001 be increased by \$10 million, to account for a technical adjustment needed for the Woolsey Wildfire Repair-Phase II Governor's Budget proposal. It is further requested that provisional language in Item 3790-004-0001 be amended to conform to this action (see Attachment 1).

Law Enforcement Records Management System License Renewal (Issue 133)—It is requested that Item 3790-001-0392 be increased by \$1,423,000 and 2 positions to provide for support, maintenance, and annual renewal of the Department's Record Management System (RMS) license. The Department requires an RMS to be in compliance with the National Incident-Based Reporting System/California Incident-Based Reporting System.

Oceano Dunes State Vehicular Recreation Area: Le Sage Bridge Replacement (Issue 138)—It is requested that Item 3790-301-0263 be increased by \$47,000 for the working drawings phase of the Oceano Dunes State Vehicle Recreation Area: Le Sage Bridge Replacement project. This supplemental appropriation is necessary to address natural resources permitting activities, increased engineering costs, and the need for expanded geographical information system support and data management.

Fort Ord Dunes State Park: New Campground (Issue 142)—It is requested that Item 3790-301-0392 be amended by increasing reimbursements by \$7,016,000 for the construction phase of the Fort Ord Dunes State Park: New Campground project. This supplemental appropriation is necessary to address higher than anticipated construction bids. As such, the Department has applied for a total of \$7,016,000 in federal grant funds.

El Capitan State Beach: Entrance Improvements (Issue 144)—It is requested that Item 3790-301-0392 be amended by increasing reimbursements by \$2,556,000 and Item 3790-301-6051 be added to in the amount of \$1,298,000 for the construction phase of the El Capitan State Beach: Entrance Improvements project. It is also requested that Item 3790-495 be added to revert \$2,648,000 from existing spending authority from Schedule 2 of Item 3790-301-6051, Budget Act of 2019 (see Attachment 2). This continuing project will reduce conflicts between pedestrians, bicyclists, and vehicles, improve the entrance road to accommodate larger RV's, replace the entrance kiosk, and improve circulation at the park entrance.

Old Sacramento State Historic Park: Boiler Shop Renovation (Issue 141)—It is also requested that Item 3790-301-6051 be added in the amount of \$16,960,000 and Item 3790-301-6088 be increased by \$5,626,000 for the construction phase of the Old Sacramento State Historic Park: Boiler Shop Renovation project. This is a continuing project that will provide inspiration and education for the people of California by helping to preserve, protect, and re-use one of its most valued cultural resources, the Boiler Shop and its environment. It is further requested that provisional language be added to Item 3790-301-6088 to conform to this action (see Attachment 3).

Picacho State Regional Area: Park Power System Upgrade (Issue 143)—It is requested that Item 3790-301-6088 be increased by \$387,000 and Provision 1 be amended for the preliminary plans phase of the Picacho State Regional Area: Park Power System Upgrade project (see Attachment 3). This project will evaluate the park's current and future electrical power needs, including redundant backup, and determine sustainable options for providing reliable and cost effective electrical power at this remote location. Currently, all electrical power in the park comes from two diesel-powered generators. However, given the age of the generators, location in a harsh desert environment, and the power needs of the park, the current system is insufficient.
