Amendment to and Addition of Various Budget Bill Items and Reimbursements, Support, Local Assistance, and Statutory Changes, California Department of Food and Agriculture

Carbon Sequestration Registry (SB 27)—It is requested that Item 8570-001-0001 be increased by \$125,000 one-time in 2022-23 and 1 position for the California Department of Food and Agriculture (Department) to implement Chapter 237, Statutes of 2021 (SB 27). The budget includes resources to support this effort beginning in 2023-24, but funding is needed for the Department to collaborate with relevant agencies on the Carbon Sequestration and Climate Resiliency Project Registry beginning in 2022-23.

Programmatic Environmental Impact Report Litigation Fees—It is requested that Item 8570-001-0001 be increased by \$2,275,000 one-time in 2022-23 to pay court-ordered fees associated with the Department's Programmatic Environmental Impact Report legal case. This includes funding for the Department to consult with the Attorney General's Office as it updates its Programmatic Environmental Impact Report.

Drought Resilience and Response Package: Special Assistant for Drought Response—It is requested that statutory changes be made to add Item 8570-001-3398 in the amount of \$223,000 in 2021-22 and Item 8570-001-0001 be increased by \$223,000 and 1 position ongoing beginning in 2023-24 to serve as the lead for the Department on the state's drought response, including statewide program implementation of projects related to the drought (see Attachment 1). This proposal accelerates funding to address the immediate needs of the state and aligns appropriations to the fiscal year in which the resources are available. It is also requested that provisional language be added to allow for encumbrance or expenditure of current year funding until June 30, 2023.

Continuation of the Bee Safe Program—It is requested that Item 8570-001-0001 be increased by \$477,000 ongoing and Item 8570-001-0111 be increased by \$250,000 ongoing to continue operating a statewide Bee Safe Program to promote and protect

a safe, healthy food supply through the protection of commercial honeybees. This request includes statutory changes to authorize the Department to increase the annual apiary registration fee to support program activities performed by the counties.

State Water Efficiency and Enhancement Program—It is requested that Item 8570-101-0001 be decreased by \$50 million in 2022-23, Item 8570-102-0001 be decreased by \$20 million in 2022-23, and that statutory changes be made that increases Item 8570-101-0001 by \$110 million in 2021-22 for the State Water Efficiency and Enhancement Program to help farmers reduce irrigation water use and reduce greenhouse gas emissions from agriculture pumping and aid in statewide emergency response efforts (see Attachments 2, 3, and 4). This proposal accelerates funding which enables the state to prioritize these projects moving forward at a point when the state has available resources and aligns appropriations to the fiscal year in which the resources are available. Additionally, it is requested that Provision 1 be deleted from Item 8570-101-0001 in 2022-23, Provision 7 be deleted from Item 8570-102-0001 in 2022-23, and Provision 2 of 8570-101-0001 be modified in 2021-22 to reflect additional funding for the Program in 2021-22. It is also requested that provisional language be added to allow for encumbrance or expenditure of current year funding until June 30, 2024.

Extreme Heat: Various Investments—It is requested that Item 8570-001-0001 be increased by \$850,000 in 2022-23 and 2023-24 and Item 8570-102-0001 be increased by \$1,075,000 in 2022-23 and \$1,575,000 in 2023-24 to fund activities that mitigate extreme heat impacts consistent with Chapter 258, Statutes of 2021 (see Attachment 3). This includes funding to support small, underserved farmers in implementing integrated pest management strategies, provide technical assistance to better handle unexpected animal mortality due to extreme heat, and provide origin inspection services to ensure that pests that may thrive under increased heat conditions are excluded from entering the state. It is also requested that provisional language be added to allow for encumbrance or expenditure of local assistance funding until June 30, 2025.

Nature-Based Solutions: Healthy Soils Program—It is requested that Item 8570-102-0001 be increased by \$10 million one-time in 2022-23 for the Healthy Soils Program to incentivize the implementation of conservation management that improves soil health, sequesters carbon, and reduces greenhouse gas emissions (see Attachment 3). This Program advances multi-benefit and nature-based solutions consistent with Chapter 258, Statutes of 2021. It is also requested that provisional language be added to allow for encumbrance or expenditure of this funding until June 30, 2025.

Drought Resilience and Response Package: Drought Relief for Small Farmers—It is requested that Item 8570-102-0001 be decreased by \$5 million one-time in 2022-23 and that statutory changes be made that add Item 8570-101-3398 in the amount of \$25 million one-time in 2021-22 for drought relief for small, mid-sized, and historically underserved farmers (see Attachments 3 and 5). This proposal accelerates funding which enables the state to prioritize these projects moving forward at a point when the state has available resources and aligns appropriations to the fiscal year in which the resources are available.. Additionally, it is requested that Provision 10 be deleted from Item 8570-102-0001 in 2022-23, and that provisional language be added to allow for encumbrance or expenditure of current year funding until June 30, 2024.

Program—It is requested that statutory changes be made that add Item 8570-101-3398 in the amount of \$15 million one-time in 2021-22 for the Water Efficiency Technical Assistance Program to help growers identify and implement efficiency improvements in existing irrigation systems and aid in statewide emergency response efforts (see Attachment 5). This proposal accelerates funding which enables the state to prioritize these projects moving forward at a point when the state has available resources and aligns appropriations to the fiscal year in which the resources are available.. It is also requested that provisional language be added to allow for encumbrance or expenditure of this funding until June 30, 2024.

Reappropriation of Greenhouse Gas Reduction Funding—It is requested that Item 8570-491 be added to reappropriate the unencumbered balances of Item 8570-101-3228, Budget Act of 2017 and Item 8570-101-3228, Budget Act of 2018 for methane reductions projects until June 30, 2024 (see Attachment 6). This funding supports the Alternative Manure Management Project and the Diary Digester Research and Development Program, which help the state meet its greenhouse gas reduction goals.

Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance, and Statutory Changes, California Public Utilities Commission (CPUC)

Energy Package: Residential Solar and Storage—It is requested that Item 8660-002-0001 be added in the amount of \$48.5 million in fiscal year 2022-23 and \$48.5 in 2023-24, and Item 8660-102-0001 be added in the amount of \$21.5 million in 2022-23 and \$851.5 million in 2023-24 to support a new sector in the Self Generative Incentive Program that will provide residential solar and storage system incentives for low-income households and storage-only incentives. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package. Statutory language for this proposal is forthcoming (see Attachment 1 and 2).

Energy Package: Capacity Building Grants—It is requested that Item 8660-001-0001 be added in the amount of \$30 million to provide capacity grants to community-based organizations that conduct outreach and technical assistance to foster participation in commission decision-making processes, support ongoing equity initiatives, and provide clean energy access opportunities. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package (see Attachment 3).

Universal Lifeline Telephone Service Program (California LifeLine Program)—It is requested that Item 8660-001-0471 be increased by \$901,000 ongoing and Item 8660-101-0471 be decreased by \$9,782,000 ongoing to reflect new caseload projections and an extension of COVID-19 Pandemic service protections through June 30, 2022.

Energy Package: Removal of the Fixed Charge Cap—It is requested that Statutory Changes be added to remove the current statutory cap on fixed charges that may be assessed by the CPUC on the electric investor-owned utilities' default residential electric

rate tariffs. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package. Statutory language for this proposal is forthcoming.

Energy Package: Energy Data Sharing—It is requested that Statutory Changes be added to allow the CPUC to share data with the California Independent System Operator to help with planning and reliability efforts. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package. Statutory language for this proposal is forthcoming.

Amendment to Budget Bill Item 8940-001-0001, Support, California Military Department

California Cadet Corps Restoration—It is requested that Item 8940-001-0001 be increased by \$3,074,000 and 5 positions in 2022-23, and \$4,254,000 and 10 positions annually thereafter, to expand the California Military Department's California Cadet Corps program. This request will increase program participation from 90 schools and 6,000 students to 135 schools and 9,095 students by 2026-27.

Drug Interdiction Efforts Update—It is requested that Item 8940-001-0001 be decreased by \$5 million in 2022-23 and increased by \$15 million in 2023-24 to modify the Governor's Budget proposal to expand the California Military Department's drug interdiction efforts. This adjustment changes the total one-time investment from \$20 million to \$30 million, to be spent over two years instead of one year. This proposal bolsters the Department's existing efforts to prevent drug-trafficking transnational criminal organizations throughout the state, with a particular focus on assisting federal, state, local, and tribal law enforcement agencies in combatting fentanyl.

Lease Revenue Debt Service Adjustment—It is requested that Item 8940-003-0001 be eliminated to represent a decrease of \$9,621,000, as planned lease-revenue debt service authority is no longer necessary due to the removal of the Consolidated Headquarters Project from future lease-revenue bond sales.

Amendment to Budget Bill Item 8955-001-0001, Support, and Addition of Item 8955-102-0001, Local Assistance, and Item 8955-493, Support, California Department of Veterans Affairs

California Veteran Health Initiative—It is requested that Item 8955-001-0001 be increased by \$10 million one-time and Item 8955-102-0001 be added in the amount of \$40 million one-time for the California Veteran Health Initiative to support veteran mental health and suicide awareness, treatment, and research. It is requested that provisional language be added to Item 8955-001-0001 to allow the funding to be spent for up to three years, and to specify that the funding shall be used for education and outreach about veteran mental health and to establish a multidisciplinary team of professionals and stakeholders to identify, collect, analyze, and assess veteran mental health and suicide (see Attachment 1). It is also requested that provisional language be included with Item 8955-102-0001 to specify that the funding shall be used for competitive grants to existing veteran service providers, to allow the funding to be spent for up to three years and to be transferred to the Certified Veteran Service Provider Program Fund (see Attachment 2).

Settlement Costs—It is requested that Item 8955-001-0001 be increased by \$51 million one-time to pay for settlement costs at the Veterans Home of California, Yountville related to the 2018 shooting. It is requested that provisional language be added to Item 8955-001-0001 to specify the funding can only be used for these purposes (see Attachment 3).

Reappropriation for Restroom ADA Upgrades—It is requested that Item 8955-493 be added to reappropriate \$500,000 General Fund from the 2018 Budget to provide CalVet additional time to complete restroom ADA upgrades at the Veterans Home of California, Yountville (see Attachment 4).

These funds shall be available for encumbrance or expenditure until June 30, 2025.

Provisions:

- 1. The funds appropriated in this item shall be used for grants to veteran service providers to expand the state's capacity to provide mental health support to veterans and to fill gaps in mental health services.
 - (a) The California Department of Veterans Affairs will award grants on a competitive basis.
 - (b) Applicants must be an existing certified veteran service provider to be eligible.
 - (c) Applicants will be required to provide a description of the proposed activities and how the proposed activities would advance or bolster mental health support for California veterans.
 - (d) Grantees will receive funds for up to three years. Grantees will receive the full amount of funding for their awarded grant in the first year, 75 percent of the grant in the second year, and 50 percent of the grant in the third year. It is expected that grantees make up the difference in funding from different funding sources.
- 2. Up to 5 percent of the funds appropriated in this item may be used for administrative costs.
- 3. The funds appropriated in this item shall be available for encumbrance or expenditure until June 30, 2025.
- 4. Upon order of the Department of Finance, the funds available in this item are available for transfer to the Certified Veteran Service Provider Program Fund. If transferred, the funds retain the available administrative costs provided in Provision 2 and the encumbrance and expenditure period provided in Provision 3.

Add the following provision to Item 8955-001-0001:

4. Of the amount provided in this Item, \$51,000,000 shall be used to pay for settlement costs. Any excess funds not used for this purpose shall revert to the General Fund.

Amendment to Budget Bill Item 8955-301-0001 and Addition of Items 8955-491 and 8955-496, Capital Outlay, Department of Veterans Affairs

California Construction Cost Index Increase-Construction—It is requested that Item 8955-301-0001 be increased in the amount of \$160,000 one-time for the Northern California Veterans Cemetery, Igo: Columbaria Expansion project that is proposed for construction funding in 2022-23. The national construction market has experienced significant inflation since 2021. The California Construction Cost index, which is the metric the state uses to track overall construction prices, has increased by approximately 10 percent since the Governor's Budget and 25 percent for capital projects that were proposed in the 2021-22 budget. This request will address the cost increases resulting from these inflationary pressures to ensure projects can proceed to the construction phase with adequate funding.

Veterans Home of California, Yountville: Steam Distribution System Renovation—
It is requested that Item 8955-301-0001 be increased by \$39,195,000 (\$439,000 for Working Drawings and \$38,756,000 for Construction) one-time for the Steam Distribution System Renovation project at Yountville. This project received construction bids in 2021 that were significantly higher than the state's initial estimate, largely due to the volatility in the construction market. This request will provide adequate funding to allow this important infrastructure project to proceed (See Attachment 1).

It is further requested that Item 8955-491 be added to provide for an extension of the liquidation period for Working Drawings funds appropriated in the 2017 Budget Act for this project (See Attachment 2). It is further requested that Item 8955-496 be added to revert existing construction authority (See Attachment 3). These technical adjustments are requested to reflect the revised construction costs described in the preceding paragraph.

Adjustments—It is requested that Item 9800-001-0001 be increased by \$132,202,000 in fiscal year 2022-23 and \$70,467,000 ongoing, Item 9800-001-0494 be increased by \$57,223,000 in 2022-23 and \$48,569,000 ongoing, and Item 9800-001-0988 be increased by \$28,185,000 in 2022-23 and \$23,922,000 ongoing, to reflect collectively bargained pay increases, updated health and dental rates, increased enrollment in health and dental plans, and a change in the Top 4 Health Plan composition.
