Amendment to Budget Bill Items 7502-001-0001, 7502-001-9730, 7502-001-9740, and 7502-002-0001, Support, California Department of Technology

**Broadband Infrastructure**—It is requested that Item 7502-002-0001 be increased by \$600 million one-time General Fund in fiscal year 2023-24, and \$500 million one-time General Fund in 2024-25, to support the completion of the statewide Broadband Middle-Mile Initiative. The Broadband Middle-Mile Initiative will create an open-access network to bring accessible high-speed broadband service to all Californians, with emphasis on addressing the needs of currently unserved areas of the state.

**Technology Modernization and Stabilization Funding—**It is requested that Item 7502-002-0001 be increased by \$55,711,000 and 4 positions in 2022-23, and \$711,000 and 4 positions ongoing, to support technology modernization and stabilization projects. The requested resources will support the selection and administration of projects approved through Technology Modernization Funding or recommended by California Department of Technology's (CDT) Stabilization Services Assessment team, through new Technology Stabilization Funding for preventative remediation efforts of identified information technology systems at risk of failure.

**Budget Revision for Statewide Centralized Services General Fund Request**—It is requested that Item 7502-001-0001 be increased by \$683,000, Item 7502-001-9730 be decreased by \$678,000, and Item 7502-001-9740 be decreased by \$5,000 in 2022-23 through 2024-25, to reflect the impact of employee compensation adjustments on CDT budget change proposals included in the Governor's Budget.

Amendment to Budget Bill Item 7730-001-0001 and Addition of Item 7730-490, Support, Franchise Tax Board

**Young Child Tax Credit to Households with Zero Income**—It is requested that Item 7730-001-0001 be increased by \$4,342,000 and 14.5 positions ongoing to expand the Young Child Tax Credit (YCTC) to households with zero income, allowing households with no earned income to claim the YCTC if they otherwise qualify for the California Earned Income Tax Credit.

**Foster Youth Tax Credit**—It is requested that Item 7730-001-0001 be increased by \$2,904,000 and 4.5 positions ongoing to implement the proposed Foster Youth Tax Credit (FYTC), which would be provided to current or former foster youth between the ages of 18 and 25 who are qualified for the California Earned Income Tax Credit, and who were in the foster program at the age of 13 or older.

**Payment Flexibility Program**—It is requested that Item 7730-001-0001 be increased by \$19,467,000 and 159 positions one-time to provide a tax payment flexibility program for low- and moderate-income taxpayers. Under the proposal, qualified taxpayers will have until September 30, 2023 to pay tax obligations for the 2019, 2020, and 2021 tax years without incurring penalties. Taxpayers who meet the qualifications and have already paid penalties and interest will receive refunds.

**Ongoing Litigation**—It is requested that Item 7730-001-0001 be increased by \$2,000,000 one-time to reimburse the Attorney General's Office for defense against pending litigation.

**California Earned Income Tax Credit Outreach**—It is requested that Item 7730-001-0001 be increased by \$1,800,000 and 11.5 positions ongoing to conduct targeted outreach

initiatives to promote increased awareness of the California Earned Income Tax Credit, and provide information on other state and federal anti-poverty credits.

Ongoing Earned Income Tax Credit and Voluntary Income Tax Assistance Outreach Funding—It is requested that Item 7730-001-0001 be increased by \$11,217,000 and 5 positions ongoing beginning in the 2023-24 fiscal year to provide ongoing funding for outreach and administration of the Voluntary Income Tax Assistance program, the California Earned Income Tax Credit, and the Young Child Tax Credit. These outreach efforts are currently funded on a year-to-year basis.

Reappropriation of Enterprise Data to Revenue 2 Contingency Funding—It is requested that Item 7730-490 be added to reappropriate \$5,000,000 of the unexpended Enterprise Data to Revenue 2 (EDR2) Project contingency funds appropriated in the 2021 Budget Act (See Attachment 1). As part of the EDR2 project funding plan, annual contingency funds are appropriated so FTB can accommodate fluctuations in project costs without incurring project delays.

This project will upgrade FTB's critical infrastructure and address a series of modifications and upgrades designed to improve Data Center operation, reliability, and energy efficiency.

Amendment to and Addition of Various Budget Bill Items, Reimbursements and Statutory Changes, Support and Local Assistance, Department of General Services

**Drought Resilience and Response Package: Office of Sustainability Water Conservation Grant Program**—It is requested that statutory changes be made to amend
Item 7760-001-0001 of the Budget Act of 2021 in the amount of \$26 million
one-time General Fund, available for three years, to facilitate a water conservation
grant program implementing water conservation projects at state facilities and aid in
statewide emergency response efforts. This proposal is part of a comprehensive
drought package put forth by the Administration at May Revision.

**COVID-19 Direct Response Expenditures**—It is requested that Item 7760-021-3398 be added in the amount of \$8,328,000 ongoing California Emergency Relief Fund to provide the Department of General Services (DGS) resources for COVID-19 Direct Response related expenditures.

**Increase Diversity and Inclusiveness**—It is requested that Item 7760-001-0001 be increased by \$3,868,000 one-time General Fund, available for three years, to support DGS Procurement Division's efforts to increase outreach to Small Businesses and Disabled Veteran Business Enterprises, aimed at increasing diversity in state contracting.

**Statewide Property Inventory Modernization Project Planning**—It is requested that provisional language be added to Item 7760-001-0001 to allow the Department of Finance to augment the item by up to \$2,532,000 General Fund in 2022-23, to fund planning efforts for the State Property Inventory Modernization Project (see Attachment 1).

**Division of the State Architect (DSA) Evaluation of Detectable Warnings Reappropriation**—It is requested that Item 7760-491 be added to reappropriate

\$1.3 million authorized by Item 7760-001-0006, 2021 Budget Act (see Attachment 2). This will allow DSA to complete a statutorily mandated study of detectable warning surface. These funds will expire on June 30, 2022 unless reappropriated.

**Contracted Fiscal Services Workload Increase**—It is requested that Item 7760-001-0001 be increased by \$478,000 ongoing General Fund and 3 positions, Item 7760-001-0666 be increased by \$443,000 ongoing and 5 positions, and reimbursements be increased by \$304,000 and Item 7760-001-9740 be increased by \$318,000 ongoing and 2 positions to support new and existing client agencies of the Department of General Services' Contracted Fiscal Services Unit.

**Real Estate Services Division (RESD) Excess Sites**—It is requested that Item 7760-001-0002 be increased by \$379,000 ongoing and 2 positions to support work mandated by Governor Newsom's Executive Order (EO) N-06-19. This EO tasks DGS with identifying excess sites and land where building affordable housing is feasible to help address regional underproduction and a lack of affordable housing in the state.

**Parking Administration Unit Workload Adjustment**—It is requested that Item 7760-001-0666 be increased by \$191,000 ongoing and 2 positions to support increased workload at the new Capitol Garage Annex Swing Space.

**Authorizing the Transfer of 2021-22 Funds from the Department of General Services to the Office of Public School Construction**—It is requested that statutory changes be adopted to allow specified 2021-22 funds appropriated to DGS to be transferred for administration by the Office of Public School Construction, upon order of the Director of Finance.

Addition of Budget Bill Items 7760-301-0660 and 7760-311-0001, Capital Outlay, Department of General Services

Sacramento Region: Jesse Unruh Building Renovation—It is requested that Item 7760-301-0660 be added in the amount of \$63,110,000 one-time Public Buildings Construction Fund to supplement the design-build phase of the Jesse Unruh Building Renovation project in Sacramento (see Attachment 1). Due to cost impacts related to supply chain issues, including escalation, as well as recently discovered deteriorating site conditions and seismic strengthening requirements for the building structure, this supplemental authority is necessary to advance this project to the Guaranteed Maximum Price (GMP) milestone. Because this project is authorized for the Progressive Design-Build methodology, these additional issues were discovered prior to the start of construction, thus saving on later more costly change orders.

Sacramento Region: Resources Building Renovation—It is requested that Item 7760-301-0660 be added in the amount of \$73,727,000 one-time Public Buildings Construction Fund to supplement the design-build phase of the old Resources Building Renovation project in Sacramento (see Attachment 1). Due to cost impacts related to supply chain issues, including escalation, as well as recently discovered deteriorating site conditions, this supplemental authority is necessary to advance this project to the GMP milestone. Because this project is authorized for the Progressive Design-Build methodology, these additional issues were discovered prior to the start of construction, thus preventing later more costly change orders.

Sacramento Region: 10<sup>th</sup> and O Street State Office Building – Fund Shift from Lease Revenue Bonds to General Fund—It is requested that statutory changes be made to amend Item 7760-301-0001 to the Budget Act of 2021 in the amount of \$476,738,000 one-time to convert existing lease revenue bond authority to General Fund for the design-build phase of the Sacramento Region: 10<sup>th</sup> and O Street State Office Building

(see Attachment 2). The request will allow for the payment of the interim financing loan for the project and all related administrative costs and interest. This proposal will result in significant savings from avoided interest payments related to the sale of bonds, and is part of a multi-year effort to build resiliency in the state's fiscal plan.

**State Project Infrastructure Fund**—It is requested that Item 7760-311-0001 be added in the amount of \$80 million one-time for transfer to the State Project Infrastructure Fund to support the continuation of design and pre-construction activities for the Capitol Annex projects (see Attachment 3). The May Revision also includes a statutory proposal to increase the cap on lease revenue bond funding for the projects, as defined in Government

Code 9112.5(a)(1), from \$755.6 million to \$837 million.

#### Provisions:

- 1. The Department of General Services and the State Public Works Board are authorized to execute and deliver any and all leases, contracts, agreements, or other documents necessary or advisable to consummate the sale and issuance of bonds in accordance with the State Building Construction Act of 1955 or otherwise effectuate the financing of the scheduled project.
- 2. Notwithstanding subdivision (b) of Section 13332.19 of the Government Code, the Department of General Services may utilize Design-Build phase funding for the development of the Guaranteed Maximum Price for the Unruh and Resources renovation projects.

#### Schedule:

#### Provisions:

- 1. Notwithstanding Section 13332.19 of the Government Code, the Department of General Services may utilize the design-build entity selected for the Jesse Unruh Building Renovation project to construct improvements pursuant to this appropriation. The department may also utilize a separate contractor to undertake the improvements through the design-bid-build delivery method.
- 2. Notwithstanding Government Code Section 15849.1 or any other law, the funds appropriated in Schedule (2) may be available for the repayment of loans made from the General Fund for the project identified in Schedule (2). Notwithstanding Government Code Section 13340 or any other law, any moneys remaining from the amounts appropriated in Schedule (2) after any loans from the General Fund for the project identified in Schedule (2) are repaid, are continuously appropriated without regard to fiscal year for the project and shall be made available to the Department of General Services upon approval and order of the Department of Finance.

Amendments to Various Budget Bill Items, Support and Local Assistance, California Victim Compensation Board

Innovative Pilot Program for Victim Services—It is requested that Item 7870-101-0001 be increased by \$30 million one-time to establish an innovative pilot program to expand victim services across California. It is also requested that provisional language be added to extend the encumbrance period for these funds until June 30, 2025 and authorize up to five percent of funding to be used for administrative costs. Furthermore, it is requested that provisional language be amended to specify the amount of funding previously appropriated within the Item (see Attachment 1).

**Media Outreach to Victims of Violent Crimes**—It is requested that Item 7870-001-0214 be increased by \$3 million one-time to conduct an outreach campaign to raise awareness of statewide victim support services, while targeting hard-to-reach populations. It is also requested that provisional language be added to extend the encumbrance period for these funds until June 30, 2025 (see Attachment 2).

**Federal Appropriation Augmentation**—It is requested that Item 7870-101-0890 be increased by \$4,196,000 one-time to reflect the Federal Victims of Crime Act reimbursement rate increase, and provide sufficient authority to utilize available federal funds.

**Operational Budget**— It is requested that various Budget Bill items be amended to reflect the changes to the 2022-23 operational budget of the California Public Employees' Retirement System (CalPERS) that was approved by the CalPERS Board on April 19, 2022. The budget proposed by CalPERS reflects a net increase of \$162,665,000 ongoing, primarily attributed to external investment management fees, administrative operating costs, and technology expenses. The request is comprised of the following changes:

- Item 7900-003-0830 be increased by \$158,875,000
- Item 7900-015-0815 be increased by \$134,000
- Item 7900-015-0820 be increased by \$54,000
- Item 7900-015-0830 be increased by \$4,398,000
- Item 7900-015-0833 be decreased by \$757,000
- Item 7900-015-0849 be increased by \$28,000
- Item 7900-015-0884 be decreased by \$105,000
- Item 7900-015-9251 be increased by \$38,000

# Amendment to Budget Bill Item 7920-011-0001, Support, California State Teachers' Retirement System

It is requested that Item 7920-011-0001 be increased by \$6,032,000 ongoing to reflect an increase in the state's contributions to the California State Teachers' Retirement System's Defined Benefit (DB) Program and Supplemental Benefit Maintenance Account (SBMA), as required in statute. The state's contributions to the DB program and SBMA are calculated using creditable compensation provided by the Teachers' Retirement Board (Board) for the fiscal year immediately preceding June 30th; the report is published annually by the Board by October 25th, with a subsequent report due by April 15th, displaying necessary revisions to creditable compensation. Based on the Board's April 12, 2022 creditable compensation report, the DB contribution will be increased by \$4,640,000 and the SBMA contribution will be increased by \$1,392,000, as compared to the Governor's Budget.
