**Correction for Food and Agriculture Code Section 4103.5**—It is requested that Item 3100-001-0001 be decreased by \$2,430,000 as the Phase III Project of the California Science Center will not be available for occupancy during the fiscal year 2022-23. Food and Agriculture Code section 4103.5 establishes that the State will be making debt service payments for this project starting either on October 1, 2022 or the date on which the Phase III facilities are certified available for use and occupancy, whichever is later. It is currently estimated the facility will be certified available for use and occupancy in 2023-24.

**Amendment to Various Budget Bill Items, and Addition of Item 3340-002-0001, Support, California Conservation Corps**

**Nonresidential Center, Los Angeles: Acquire Existing Facility**—It is requested that Item 3340-001-6088 be decreased by \$2.7 million one-time to reflect the shift of funding from support to capital outlay to support the acquisition of the existing, leased non-residential facility in Los Angeles. The increase is reflected in the California Conservation Corps capital outlay finance letter.

**Nature Based Solutions: Local and Tribal Corps**—It is requested that Item 3340-002-0001 be added in the amount of \$35 million in 2022-23, and \$17 million in 2023-24, to expand educational and economic opportunities for youth climate leaders through the Local and Tribal Nature-Based Solutions Corps, consistent with Chapter 258, Statutes of 2021 (see Attachment 1).

**Minimum Wage Adjustment**—It is requested that Item 3340-001-0001 be increased by \$553,000, Item 3340-001-0318 be increased by \$195,000, Item 3340-001-3228 be increased by \$52,000, and Item 3340-002-3228 be increased by \$48,000 in 2022-23 to account for the increase in minimum wage from \$15.00 to \$15.50 per hour starting in January 2023 for corpsmembers. Under current law, this accelerated increase in the state's minimum wage is triggered as a result of growth in inflation of more than 7 percent.

**Amendment to Various Budget Bill Items, Support and Local Assistance, Energy Resources Conservation and Development Commission (CEC)**

**Energy Package: Distributed Electricity Backup Assets**—It is requested that statutory changes be made to add Item 3360-008-0001 in the amount of \$55,000,000 one-time General Fund in 2021-22 and add Item 3360-108-0001 in the amount of \$495,000,000 one-time General Fund in 2021-22 to support incentives for clean backup generation and emissions control on large backup generators. It is also requested that Item 3360-008-0001 be increased in the amount of \$40,000,000 one-time General Fund in 2023-24 and Item 3360-108-0001 be increased in the amount of \$360,000,000 one-time General Fund in 2023-24 for the same programmatic purposes. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package. This proposal accelerates funding for energy investments to address the immediate needs of the state at a point when the state has available resources and can align appropriations to the fiscal year in which the resources are available. Statutory language for this proposal is forthcoming (see Attachments 1 and 2).

**Climate Innovation Grants**—It is requested that Item 3360-007-0001 be added in the amount of \$10,000,000 General Fund one-time in 2022-23, \$32,500,000 in 2023-24 and 2024-25, and \$30,000,000 in 2025-26, and Item 3360-107-0001 be added in the amount of \$90,000,000 General Fund one-time in 2022-23, \$292,500,000 in 2023-24 and 2024-25, and \$270,000,000 in 2025-26 to support research activities that help California achieve its climate goals with grant recipients being required to be headquartered in California. Statutory language for this proposal is forthcoming (see Attachments 3 and 4).

**Relief Package: Acceleration of Zero-Emission Vehicle Projects**—It is requested that statutory changes be added to increase Item 3360-001-0001 by \$88,103,000 in 2021-22 and Item 3360-101-0001 by \$1,051,897,000 in 2021-22, with associated reductions of

\$400,000,000 in 2022-23, \$320,000,000 in 2023-24, \$300,000,000 in 2024-25, and \$120,000,000 2025-26, to accelerate various Zero-Emission Vehicle projects that were funded in the 2021 Budget Act and were proposed in the Governor's Budget. Accelerated projects include investments to build more passenger vehicle charging stations, medium and heavy duty vehicle infrastructure, and support for emerging opportunities. This acceleration provides relief to Californians facing high gas prices and helps move California toward clean transportation options that reduce the state's overall dependence on gas and fossil fuels (see Attachment 6 and 7).

**Energy Package: Demand Side Grid Support**—It is requested that statutory changes be made to add Item 3360-008-0001 in the amount of \$200,000,000 one-time General Fund in 2021-22 and Item 3360-008-0001 be added in the amount of \$95,000,000 one-time General Fund in 2023-24 to provide resources for demand side grid support technologies and mitigation activities. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package. This proposal accelerates funding for energy investments to address the immediate needs of the state at a point when the state has available resources and can align appropriations to the fiscal year in which the resources are available. Statutory language for this proposal is forthcoming (see Attachment 1).

**Energy Package: Carbon Removal**—It is requested that Item 3360-007-0001 be increased by \$5,000,000 General Fund one-time in 2022-23 and 2023-24, and Item 3360-107-0001 be increased one-time by \$45,000,000 General Fund in 2022-23 and 2023-24 to provide resources to support technologies that will help with carbon capture. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package. Statutory language for this proposal is forthcoming (see Attachments 3 and 4).

**Lithium Valley Package**—It is requested that Item 3360-006-0001 be increased by \$5,000,000 General Fund one-time in 2022-23 and statutory changes be added to support the development of Lithium Valley. This funding will support the County of Imperial and community based organizations in the county in engaging and reviewing geothermal energy development and lithium recovery, processing, production, and related manufacturing activities within the county. The statutory changes added will include support for community benefits from lease revenue of geothermal facilities, an excise tax on lithium recovered, streamlined delegation to counties for geothermal facilities, an expansion of the small power plant exemption threshold for geothermal facilities, the use of lithium tax proceeds to support operations, maintenance and restoration of the Salton Sea and grants to support disadvantaged communities, and a new lithium sector Sales Tax Exclusion within the California Alternative Energy and Advanced Transportation Financing Authority. This proposal is part of the Administration's Lithium Valley Package. Statutory language for this proposal is forthcoming (see Attachment 5).

**Electric Program Investment Charge (EPIC) Program Administration Cap Increase**—It is requested that Item 3360-001-3211 be increased by 23.5 positions and \$5,388,000 ongoing, Item 3360-101-3211 be decreased by \$5,388,000 ongoing, and Item 3360-001-0465 be decreased by 8.5 positions and \$1,275,000 ongoing to reflect an increase in the

administrative cap for the Electric Program Investment Charge Program from 10 percent to 15 percent approved by the Public Utilities Commission. This proposal also shifts resources previously funded by the Energy Resources Program Account Fund to the Electric Program Investment Charge Fund.

**Energy Package: Energy Data Analysis**—It is requested that Item 3360-005-0001 be increased by \$5,000,000 General Fund one-time in 2022-23 to provide resources to support the data warehousing and analysis of customer-level energy data CEC has acquired from investor-owned and publicly-owned utilities, which aid in the Commission's modeling of the clean energy transition. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package (see Attachment 8).

**Energy Package: Opt-in Permitting**—It is requested that statutory changes be added to support a new permitting option at the CEC that prioritizes the development of projects needed to enhance energy reliability while also providing opportunities for public, tribal, and local government engagement and environmental review. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package. Statutory language for this proposal is forthcoming (see Attachment 9).

**Energy Package: Planning Reserve Margin**—It is requested that statutory changes be added to support CEC updating its energy planning standards to further promote electricity reliability by overseeing that all load serving entities that are members of the CAISO adequately incorporate the impacts of climate change and extreme weather into their planning reserve margins. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package. Statutory language for this proposal is forthcoming.

**Energy Package: Voluntary Offshore Wind and Coastal Resources Protection Program**—It is requested that statutory changes be added to support the establishment of a program to be administered by CEC for the purposes of supporting state activities that complement and are in furtherance of federal offshore wind laws, including offshore wind lease conditions of the Bureau of Ocean Energy Management. The program shall award moneys to public and private entities through various mechanisms, including, but not limited to, grants. This proposal is part of the Administration's Energy Reliability, Relief and Clean Energy Package. Statutory language for this proposal is forthcoming.

**Amendment to Budget Bill Item 3480-001-3046, Support, and Items 3480-101-0001, 3480-102-0001, Local Assistance, Department of Conservation**

**Nature-Based Solutions: Climate Smart Land Management**—It is requested that Item 3480-101-0001 be increased by \$14 million in fiscal year 2022-23 and \$6 million in 2023-24 to provide support for land managers implementing climate smart land management through a consolidated capacity and technical assistance program (see Attachment 1).

**California Climate Information System (CalCIS)**—It is requested that Item 3480-001-3046 be amended by increasing reimbursements by \$370,000 ongoing and 2 positions to provide project management support for the design and implementation for the CalCIS project. The CalCIS project will be a cloud-based system to provide critical data resources and data management products for the state to better achieve its climate and biodiversity goals.

**Drought Resilience and Response Package: Multi-benefit Land Repurposing**—It is requested that Item 3480-102-0001 be decreased by \$40 million in 2022-23 and statutory changes be made to increase Item 3480-102-0001 by \$40 million in 2021-22 to support regional capacity to repurpose agricultural land that can no longer be irrigated sustainably to reduce reliance on groundwater. This acceleration supports the immediate needs of the state and aligns appropriations to the fiscal year in which the resources are available. This includes provisional language to authorize up to 5 percent for administrative costs. (see Attachment 1)

All eligible projects shall identify a California use of the hydrogen or liquid fuel to be created and have a lifecycle analysis of the carbon emitted and sequestered from the project, including any emissions from related transportation needs of bringing the feedstock materials to the facility and delivering resulting fuels and carbon dioxide to its end uses. The Department of Conservation shall notify the Joint Legislative Budget Committee of proposed projects to be funded 30 days prior to the funds being issued.
- 2.5. Of the amount appropriated in this item, \$14,000,000 shall be available for technical assistance to support Climate Smart Land Management programs.
- 2.6. Not more than 5 percent of the amount appropriated in this item may be used for administrative costs.
3. The amounts appropriated in this item shall be available for encumbrance or expenditure until June 30, 2025, and available for support or local assistance."

Provisions:

1. The funds appropriated in this item shall be available to the Department of Conservation, in consultation with the Department of Water Resources, the Department of Fish and Wildlife, the State Water Resources Control Board, and the Department of Food and Agriculture, to implement the Multi-benefit Land Repurposing Program for groundwater sustainability projects that reduce groundwater use, repurpose irrigated agricultural land, and provide wildlife habitat. Projects may support implementation of the Sustainable Groundwater Management Act (Part 2.74 (commencing with Section 10720) of Division 6 of the Water Code). Eligible project expenditures include, but are not limited to, the following:

- (a) Projects that create or restore permanent wildlife habitat.
- (b) Projects that create or restore seasonal wetland habitat that provides aquifer replenishment.
- (c) Projects that improve groundwater supply, including groundwater recharge, improved base flows in rivers and streams, and groundwater supply improvement for fish and wildlife habitat.
- (d) Projects that convert land to less intensive water uses while maintaining natural and working lands.

2. Any groundwater recharge achieved under this item shall be subtracted from any calculation by the groundwater sustainability agency of groundwater available for extraction by water users for the duration of benefits paid for by the program. Payments shall be linked to achievement and delivery of defined conservation outcomes and the duration of those outcomes

3. The Department of Conservation shall prioritize achievement of disadvantaged community benefits when implementing this program.

4. The provisions of this item apply to critically overdrafted groundwater basins or parts of those basins managed under an approved groundwater sustainability plan or alternate plan, or high and medium priority groundwater basins where a state emergency drought declaration has been declared.

5. Not more than 5 percent of the amount appropriated in this item may be used for administrative costs."

**Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance, and Statutory Changes, Department of Forestry and Fire Protection (CAL FIRE)**

**May Revision Update: Emergency Surge Capacity and Response Enhancements**—It is requested that Item 3540-001-0001 be increased by \$8,037,000 and 34 positions in fiscal year 2022-23, \$7,639,000 in 2023-24 and 2024-25, and \$968,000 and five positions ongoing to reflect the staffing components of the 2022-23 Governor's Budget proposals to (1) purchase 4 additional Fire Hawk helicopters and (2) contract for 10 exclusive use helitankers each year for the next three years. It is also requested that Provision 12 be added to extend the encumbrance and expenditure period to June 30, 2025 for the funding proposed in the 2022-23 Governor's Budget for the purchase of four additional helicopters (see Attachment 1).

**CAL FIRE Staffing to Support California Conservation Corps (CCC) and California Military Department (CMD) Fire Crews**—It is requested that Item 3540-001-0001 be increased by \$104,358,000 and 238 positions in 2022-23 and \$49,932,000 and 270 positions ongoing to provide the CAL FIRE staffing component of the 2022-23 Governor's Budget proposals to add 8 new year-round CCC and CMD fire crews (four crews each) and convert 16 existing seasonal CCC and CMD crews to year-round crews (6 CCC and 10 CMD). This proposal also includes one-time funding for facility improvements necessary to support these crews, and it is requested that Provision 13 be added to extend the encumbrance and expenditure date of this facility improvements funding to June 30, 2025 (see Attachment 1).

**Direct Mission Support – Total Force**—It is requested that Item 3540-001-0001 be increased by \$29,259,000 in 2022-23, \$27,502,000 ongoing, and 190 positions; reimbursements be increased by \$7,538,000 in 2022-23 and \$7,179,000 ongoing; and Item 3540-002-3228 be increased by \$995,000 in 2022-23 and 948,000 ongoing to enhance staffing, improve operational effectiveness, and provide critical administrative

and program support necessary to sustain CAL FIRE's direct mission functions in an increasingly complex environment. CAL FIRE operates on a "total force" concept in that all areas of the department provide support to make the whole work. Providing sufficient administrative and program support resources is a critical first step to helping CAL FIRE's two regions and 21 units sustain the existing level of direct mission services to the public.

**Staffing and Operational Enhancements Set-Aside**—It is requested that Item 3540-001-0001 be decreased by \$400 million ongoing to remove a set-aside included in the 2022-23 Governor's Budget to improve the health and wellness of CAL FIRE firefighters and appropriately staff CAL FIRE to meet the evolving demands of wildland firefighting. The cumulative \$141,654,000 General Fund in 2022-23 and \$78,402,000 ongoing from the three preceding proposals in this letter partially offset this reduction, and the remainder of this set-aside continues to be carried in a statewide item related to employee compensation issues.

**July through December Fire Protection Augmentation**—It is requested that Item 3540-001-0001 be increased by \$83,065,000 one-time in 2022-23 to augment CAL FIRE's fire protection resources from July to December 2022 given current drought conditions, increasing fire severity and size, and declining inmate camp populations. This funding will support the continuation of 16 firefighter I fire crews, chainsaw operators to support CMD force package fire crews, expanded training center capacity to accommodate these crews, additional vehicle repair/maintenance funding, and associated administrative costs. It is also requested that Provision 14 be added to exempt CAL FIRE from specified contracting requirements to facilitate quickly implementing these resources (see Attachment 1).

**Incremental Increase to Governor's Budget Proposals to Reflect Updated Pay Scales**—It is requested that Item 3540-001-0001 be increased by \$729,000 ongoing, \$357,000 General Fund and \$372,000 reimbursements, to reflect incremental increases to several 2022-23 Governor's Budget proposals resulting from updated pay scales that were not available until after the release of the Governor's Budget. These proposals include the CAD/AVL Program Hardware and Service Refresh, Community Wildfire Preparedness and Mitigation Package (AB 9, AB 642, and SB 63), Office of Wildfire Technology Research and Development (SB 109), and Oroville full service local government agreement.

**May Revision Update: Wildfire and Forest Resilience Package**—It is requested that the following amendments be made:

It is requested that Item 3540-001-0001 be decreased by \$2 million in 2022-23 and 2023-24 to reflect the shift of this funding to the University of California's budget for its Fire Advisors Program, consistent with the intent of the 2022-23 Wildfire and Forest Resilience package.

It is requested that Item 3540-001-001 be decreased by \$10 million in 2022-23, and statutory changes be made to increase Item 3540-001-0001 by \$10 million in 2021-22, to accelerate funding for forest health and resources management projects, which

enables the state to prioritize these projects moving forward at a point when the state has available resources and aligns appropriations to the fiscal year in which the resources are available. It is also requested that Provision 11 be added to Item 3540-001-0001 in 2022-23 and Provision 17 be added to Item 3540-001-001, Budget Act of 2021 to exempt CAL FIRE from specified contracting requirements for procurement, contracting, or subcontracting with vendors for forest health, fire prevention, fuels reduction, vegetation management, or environmental review for fire prevention or post-fire vegetation restoration projects funded from the amounts appropriated in these items (see Attachments 1 and 2).

It is requested that Item 3540-101-001 be decreased by \$70 million in 2022-23, and statutory changes be made to increase Item 3540-101-0001 by \$70 million in 2021-22, to accelerate funding for forest health and resources management projects, which enables the state to prioritize these projects moving forward at a point when the state has available resources and aligns appropriations to the fiscal year in which the resources are available. It is also requested that Provision 3 be added to Item 3540-101-0001 in 2022-23 and Provision 4 be added to Item 3540-101-001, Budget Act of 2021 to exempt CAL FIRE from specified contracting requirements for procurement, contracting, or subcontracting with vendors for forest health, fire prevention, fuels reduction, vegetation management, or environmental review for fire prevention or post-fire vegetation restoration projects funded from the amounts appropriated in these items (see Attachments 3 and 4).

It is requested that 48 positions be authorized to support implementation of programs and projects funded within the resources previously proposed in the 2022-23 Wildfire and Forest Resilience package.

It is requested that statutory changes be made to extend and expand the California Environmental Quality Act exemption for forest health and wildfire resilience projects conducted on federal land with state funding or projects that span both federal and state land that have a National Environmental Policy Act document.

**Nature-Based Solutions: Wildland Grazing (Fire Prevention Grant Program)**—It is requested that Item 3540-101-0001 be increased by \$5 million in 2022-23 and 2023-24 for wildland grazing projects within the Fire Prevention Grant Program that advance multi-benefit and nature-based solutions. This proposal includes provisional language to provide extended encumbrance and expenditure through June 30, 2025 (see Attachment 4).

**Extreme Heat: Green Schoolyards (Urban Forestry)**—It is requested that Item 3540-102-0001 be added in the amount of \$25 million in 2022-23 and 2023-24 to support green school campuses and transportation corridors and scale relevant maintenance training. These funds will be administered to support low-income schools vulnerable to extreme heat through CAL FIRE's Urban and Community Forestry program. This approach will leverage the program's scientific and technical expertise and relationships with local agencies. This proposal includes provisional language to provide extended encumbrance and expenditure through June 30, 2025 (see Attachment 5).

**Reappropriation of the 2019-20 and 2020-21 Appropriations for Acquisition of New Helicopters**

—It is requested that Item 3540-492 be added to reappropriate, until June 30, 2025, the balances of the 2019-20 and 2020-21 appropriations provided for the acquisition of S70i Fire Hawk helicopters to replace CAL FIRE's Vietnam-era helicopters. Completion of these acquisitions has been delayed by a point-in-time contractual issue between the state and its vendor that has since been resolved (see Attachment 6).

The effect of my requested action is reflected on the attachment.

**Amendments to Budget Bill Item 3540-301-0001 and Item 3540-301-0660, Capital Outlay, Department of Forestry and Fire Protection**

**Training Center Study**—It is requested that Item 3540-301-0001 be increased by \$150,000 one-time to conduct a study for the Department of Forestry and Fire Protection Training Center located in Lone. This adjustment is necessary for the development of an infrastructure master plan for future capital outlay projects to upgrade the facility (see Attachment 1).

**California Construction Cost Index Increases-Construction**—It is requested that Item 3540-301-0001 be increased by \$5,929,000 one-time and Item 3540-301-0660 be increased by \$3,254,000 one-time for eight previously approved projects that are either proposed for construction funding or expected to go to bid for construction in 2022-23. The national construction market has experienced significant inflation since 2021. The California Construction Cost Index (CCCI), which is the metric the state uses to track overall construction prices, has increased by approximately 10 percent since the Governor's Budget and 25 percent for capital projects that were proposed in the 2021 Budget Act. This has resulted in funding shortfalls of approximately 6 percent and 15 percent, respectively, for the overall construction phases. This request will address recent inflationary pressures in the construction market to ensure projects can proceed to the construction phase with adequate funding (see Attachments 1 and 2).

- As part of this proposal, it is requested that the construction appropriation requests be added one-time for the following projects by the specified amounts to account for the increase of the CCCI:

0001—General Fund

Potrero Forest Fire Station: Replace Facility—\$1,014,000

Statewide: Replace Communications Facilities, Phase III—\$427,000

Statewide: Replace Communications Facilities, Phase V—\$2,609,000  
Paso Robles Air Attack Base: Infrastructure Improvements—\$230,000  
Chico Air Attack Base: Infrastructure Improvements—\$269,000  
Lake/Napa Unit Autoshop and Warehouse: Replace Facility—\$1,380,000

**Various Cost Increases and Fund Shift**—It is requested that Item 3540-301-0001 be increased by \$1,375,000 one-time to fund cost increases and a fund shift as follows (see Attachment 1):

- **Potrero Fire Station: Replace Facility**—\$125,000 one-time for the working drawings phase of this project to address increased personnel costs for the design team. While the project was halted during the pandemic, billing rates for staff continued to increase.
- **Perris Emergency Command Center: Remodel Facility**—\$300,000 one-time for the working drawings phase of this project to account for additional structural deficiencies, staffing level increases, and technological upgrades.
- **Self-Generating Power Projects in Tehama-Glenn and Fresno-Kings**—\$950,000 one-time for the preliminary plans phase of this project. The Governor's Budget already included an appropriation of \$50,000 General Fund for the preliminary plans phase of this project. However, it was discovered that the \$950,000 that is currently being requested was erroneously allocated to the construction phase of the project. This funding redirection addresses that issue and results in no change to the total estimated cost of the project.

**Fund Shift from Lease Revenue Bonds to General Fund**—It is requested that Item 3540-301-0660 be decreased by \$33,661,000 one-time (see Attachment 2) and Item 3540-301-0001 be increased by \$36,018,000 (see Attachment 1) to transition the Hemet-Ryan Air Attack Base: Replace Facility project from the Public Buildings Construction Fund to the General Fund. The change in fund source is requested as the state does not own the site, making it problematic to bond fund. The net increase of \$2,357,000 General Fund accounts for increased costs due to the rise in the CCCI.

It is requested that construction appropriations be added one-time to Item 3540-301-0001 of the 2021 Budget Act for the following projects by the specified amounts to convert the funding from the Public Buildings Construction Fund to the General Fund:

The proposal includes a total increase of \$97,249,000 General Fund to the 2021 Budget Act (see Attachment 3).

The above fund swaps include all applicable interest and administrative fees. The fund shifts from lease revenue bonds to the General Fund will allow the state to capture savings from reduced future debt service.

**Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance,  
California Department of Fish and Wildlife**

**Drought Resilience and Response Package: Various Investments—**

- It is requested that Item 3600-001-0001 be increased by \$2,816,000 and 6 positions ongoing to coordinate expedited permitting of priority large-scale habitat restoration projects.
- It is requested that Item 3600-001-0001 be increased by \$3.3 million one-time in fiscal year 2022-23 to support an Interagency Fish Passage Steering Committee. It is also requested that provisional language be added to allow for encumbrance or expenditure of this funding until June 30, 2024 (see Attachment 1).
- It is additionally requested that Item 3600-001-0001 be increased by 20 positions ongoing to support the State's ongoing efforts to address drought and long-term water resilience.
- It is requested that statutory changes be made to increase Item 3600-001-0001 by \$100 million one-time in 2021-22 for efforts to protect salmon, add Item 3600-001-3398 in the amount of \$17 million one-time in 2021-22 for climate-induced hatchery upgrades, and to add Item 3600-101-3398 in the amount of \$15 million one-time in 2021-22 for improving drought resiliency on state owned land for bird habitat (see Attachments 2, 3, and 4). It is also requested that provisional language be added to allow for encumbrance or expenditure of this funding until June 30, 2024.
- It is requested that Item 3600-006-0001 be decreased by \$75 million in 2022-23, and statutory changes be made to add Item 3600-001-3398 in the amount of \$75 million in 2021-22, for fish and wildlife protection (see Attachments 3 and 5). This funding was previously approved as part of the 2021-22 Water Resilience Package and supports programs and projects that improve environmental conditions to promote protection of fish and wildlife. It is also requested that Provision 2 be removed from Item 3600-006-0001 in 2022-23, and provisional language be added to

Item 3600-001-3398 in 2021-22, to allow funds to be available for encumbrance or expenditure until June 30, 2025.

This proposal accelerates funding to support the immediate needs of the state and aligns appropriations to the fiscal year in which the resources are available

**Hatcheries and Inland Fisheries Fund (HIFF) Realignment**—It is requested that Item 3600-001-3103 be increased by \$5 million and 15 positions ongoing. This request aligns HIFF's expenditure authority with revenues and helps the Department maintain stability, structural balance, and supports associated workload.

**Nature-Based Solutions: Various Programs**—It is requested that Item 3600-007-0001 be increased by \$40 million one-time in 2022-23 for Wildlife Corridors and that Item 3600-102-0001 be added in the amount of \$90 million one-time in 2022-23 for the Wetlands Restoration Program and Natural Community Conservation Program Planning and Land Acquisition (see Attachments 6 and 7). These programs and activities advance multi-benefit and nature-based solutions, consistent with Chapter 258, Statutes of 2021.

**Wireless In-Car Camera Systems**—It is requested that Item 3790-001-0001 be increased by \$2.2 million one-time General Fund to purchase wireless in-car camera systems for peace officers to support transparency and to improve public safety outcomes (see Attachment 1).

**General Fund Reimbursement Authority**— It is requested that Item 3790-001-0001 add \$3,000,000 in reimbursement authority from General Fund to allow for improved processing of reimbursement transfers received from the General Fund. This authority will be used for costs associated with natural disasters such as wildfires, landslides, and any other statewide emergency where General Fund reimbursement is anticipated (see Attachment 1).

**Office of Grants and Local Services (OGALS) Support Staffing**—It is requested that Item 3790-001-0001 be increased by one position, Item 3790-001-6088 be increased by four positions, and Item 3790-001-0890 be increased by five positions ongoing. The Department's OGALS is experiencing significant workload increases due to various grant programs. The ten additional positions will improve the Department's program delivery obligations and funding for the positions can be absorbed through existing program delivery funds from General Fund, Proposition 68, and Federal Trust Fund.

**K-12 and Interpretive Program Enrichment**—It is requested that Item 3790-003-0001 be increased by \$15 million one-time General Fund for outdoor environmental education and access programming through the expansion of existing K-12 after school and distance learning programs (see Attachment 2).

**African American History and Engagement in California State Parks**—It is requested that Item 3790-003-0001 be increased by \$15 million one-time General Fund to partner with the California African American Museum to better tell the inclusive story of black history in state parks (see Attachment 2).

**India Basin**—It is requested that Item 3790-101-0001 be increased by \$25 million one-time General Fund for the India Basin project in San Francisco. Additionally, provisional language is requested to specify the use of the funds (see Attachment 3).

The expanded project scope and associated costs are the result of district, interpretive, and stakeholder outreach meetings with the design team in the early planning phase of the project. Additionally, provisional language is requested to allow up to \$24 million of the amount appropriated for this project to be available for state operations or capital outlay (see Attachment 6).

**California Construction Cost Index Increases—Construction** —It is requested that Items 3790-301-0001 (Attachment 6), 3790-301-0263 (Attachment 7), 3790-301-0392 (Attachment 8), 3790-301-6051 (Attachment 9) and 3790-301-6088 (Attachment 10) be increased by \$14.5 million one-time from various funds for the design phase and construction phases of various capital outlay projects. The national construction market has experienced significant inflation nationally since 2021. The May Revision requests to augment these projects accordingly. This request will address recent inflationary pressures in the construction market to ensure projects can proceed to the construction phase with adequate funding.

**Local Assistance: Off-Highway Vehicle Trust Fund**—It is requested that Item 3790-101-0263 be increased by \$34 million Off-Highway Vehicle Trust Fund for local assistance grants. The OHV local assistance program administered by the Off-Highway Motor Vehicle Recreation Division supports the planning, acquisition, development, maintenance, administration, operation, enforcement, restoration, and conservation of trails, trailheads, areas, and other facilities associated with the use of off-highway motor vehicles and programs involving off-highway motor vehicle safety or education (see Attachment 11).

**Equitable Access Program: New State Park, Reappropriation**—It is requested that Item 3790-491 be added to reappropriate \$5 million for the Equitable Access Program: New State Park for acquisition and development of the 1,600 acre Dos Rios property at the confluence of the San Joaquin and Tuolumne Rivers currently owned by the non-profit River Partners. Additionally, provisional language is requested for encumbrance until June 30, 2025 and for the fund to be available for acquisition, study, preliminary plans, working drawings, and construction (see Attachment 12).

**Cannabis Watershed Protection Program Positions**—It is requested that Item 3790-001-0392 be increased by 61 positions ongoing. These positions will support the Cannabis Watershed Protection Program implementation addressing immediate needs, including statewide efforts to prevent illegal cannabis cultivation in state parks, remediation of environmental impacts, and restoration of natural habitats and lands impacted by cannabis cultivation. This request will be supported by the Department's Cannabis Tax Fund allocation designated for these purposes.

**State Parks Minimum Wage Increase**—This request includes \$23,000 General Fund and \$11,000 State Parks and Recreational Funds to account for annual minimum wage increases for the Department of Parks and Recreation. This request is due to the California Minimum Wage Phase-In Requirements which indicates that for hourly minimum wage employers with employees of 25 or more, future rates may be increased due to changes in the consumer price index.

Interest charges may be waived pursuant to subdivision (e) of Section 16314 of the Government Code. For purposes of the budgetary and legal bases of accounting and budgeting, the principal amount of any loans made pursuant to this provision shall not be considered part of the balance of the fund that receives the loan, nor shall it be deducted from the balance of the fund from which the loan is made. These loans are considered cashflow loans for temporary cash shortages and shall not constitute budgetary loans, revenues, or expenditures. The Department of Finance shall make the final determination of the budgetary and accounting transactions and treatments to ensure proper implementation of this provision pursuant to Section 13344 of the Government Code.

**Amendment to and Addition of Various Budget Bill Items and Statutory Changes,  
Support, Local Assistance, Capital Outlay, Department of Water Resources**

**Energy Package: Strategic Reliability Reserve**—It is requested that statutory changes be made to increase Item 3860-001-0001 by \$1.5 billion in 2021-22, and Item 3860-001-0001 be increased by \$445 million in 2022-23 and 25 positions ongoing, \$971 million in 2023-24, and \$667 million in 2024-25 and 2025-26, to support a strategic reliability reserve to further bolster the state's energy grid reliability as part of the Administration's Energy Reliability, Relief and Clean Energy Package. This proposal accelerates funding for energy investments to address the immediate needs of the state. This proposal accelerates funding which enables the state to prioritize these projects moving forward at a point when the state has available resources and aligns appropriations to the fiscal year in which the resources are available. It is also requested that provisional language be added to both items to make funds available for encumbrance or expenditure until June 30, 2027 (see Attachments 1 and 2).

**National Flood Insurance Program Continued Implementation and Support**—It is requested that Item 3860-001-0001 be increased by \$4 million in 2022-23, and \$3 million ongoing to support and implement the various requirements associated with the National Flood Insurance Program and the development of compliance tracking tools to meet annual reporting requirements.

**Urban Flood Risk Reduction Projects**—It is requested that Item 3860-001-0001 be increased by \$10 million one-time and Item 3860-301-0001 be increased by \$22 million one-time to support the completion of two existing projects to reduce the risk of flooding, loss of life, property, and major damages for urban areas in the Central Valley.

**Water Use Efficiency and Drought Resilience**—It is requested that Item 3860-001-0001 be increased by \$5 million and 1 position ongoing to support various statutory requirements

within the Water Use Efficiency Program to manage drought and water shortage preparedness, among other activities.

**Drought Resilience and Response Package: Various Investments**—It is requested that the following various amendments be made:

- **Expediting Large Scale Habitat Restoration**—It is requested that Item 3860-001-0001 be increased by \$1,752,000 and 7 positions ongoing to expedite planning, permitting, and implementation of large scale habitat restoration.
- **Support for Local Conservation Measures**—It is requested that Item 3860-001-0001 be decreased by \$5 million in 2022-23, and statutory changes be made to add Item 3860-001-3398 in the amount of \$5 million in 2021-22, for local conservation measures and aid in statewide emergency efforts. It is also requested that Provision 2 be removed from Item 3860-001-0001 in 2022-23, and provisional language be added to Item 3860-001-3398 in 2021-22, to make the funds available for encumbrance or expenditure until June 30, 2024 (see Attachments 2 and 3).
- **Technical Assistance**—It is requested that Item 3860-001-0001 be decreased by \$5 million in 2022-23, and statutory changes be made to add Item 3860-001-3398 in the amount of \$5 million in 2021-22, to support technical assistance provided to communities for drought response and aid in statewide emergency efforts. It is also requested that Provision 2 be removed from Item 3860-001-0001 in 2022-23, and provisional language be added to Item 3860-001-3398 in 2021-22, to make the funds available for encumbrance or expenditure until June 30, 2024 (see Attachments 2 and 3).
- **Central Valley Flood Protection Plan**—It is requested that Item 3860-001-0001 be increased by \$2.1 million one-time in 2022-23, to support updates and associated project management for the Central Valley Flood Protection Plan.
- **Reintroduction of Salmon Study**—It is requested that Item 3860-001-0001 be increased by \$4 million one-time in 2022-23, to support salmon reintroduction efforts across the state.
- **Administrative Positions**—It is increased that Item 3860-001-0001 be increased by 20 positions ongoing to aid in supporting the state's ongoing efforts to address drought and long-term water resilience.
- **Critical Data Collection**—It is requested that Item 3860-001-0001 be increased by \$16,750,000 ongoing beginning in 2023-24, and statutory changes be made to add Item 3860-001-3398 in the amount of \$16,750,000 in 2021-22, to support statewide data collection efforts. It is also requested that provisional language be added to Item 3860-001-3398 to make the funds available for encumbrance or expenditure until June 30, 2024 (see Attachment 3).
- **Drought Salinity Barrier**—It is requested that statutory changes be made to add Item 3860-001-3398 in the amount of \$27 million in 2021-22, for the installation and removal of drought salinity barriers to support drought resilience and response as well as aid in statewide emergency response efforts. It is also requested that provisional language be added to make the funds available for encumbrance or expenditure until June 30, 2024 (see Attachment 3).
- **Water Storage Tanks**—It is requested that statutory changes be made to add Item 3860-001-3398 in the amount of \$21 million in 2021-22, to support the

purchase of water storage tanks to support drought response and aid in statewide emergency efforts. It is also requested that provisional language be added to make funds available for encumbrance or expenditure until June 30, 2024 (see Attachment 3).

- Water Transfers Pilot Project—It is requested that statutory changes be made to add Item 3860-001-3398 in the amount of \$20 million in 2021-22, for a water transfers pilot project that supports drought resilience and aids in emergency response efforts. It is also requested that provisional language be added to make the funds available for encumbrance or expenditure until June 30, 2024 (see Attachment 3).
- County Level Drought Planning Support—It is requested that statutory changes be made to add Item 3860-001-3398 in the amount of \$15 million in 2021-22, to support drought planning and response at the local level as well as aid in statewide emergency efforts. It is also requested that provisional language be added to make the funds available for encumbrance or expenditure until June 30, 2024 (see Attachment 3).
- Urban Water District Drought Relief—It is requested that Item 3860-101-0001 be decreased by \$60 million in 2022-23, and statutory changes be made to add Item 3860-101-3398 in the amount of \$200 million in 2021-22, to support direct drought relief to local communities and aid in statewide emergency response efforts. It is also requested that provisional language be amended in Item 3860-101-0001 in 2022-23 to reflect these changes, and provisional language be added to Item 3860-101-3398 in 2021-22, as specified (see Attachments 4 and 5).
- Small Community Drought Relief—It is requested that Item 3860-101-0001 be decreased by \$60 million in 2022-23, and statutory changes be made to add Item 3860-101-3398 in the amount of \$100 million in 2021-22, to support direct drought relief to small communities and aid in statewide emergency response efforts. It is also requested that provisional language be amended in Item 3860-101-0001 in 2022-23 to reflect these changes, and provisional language be added to Item 3860-101-3398 in 2021-22, as specified (see Attachments 4 and 5).
- Conservation for Urban Suppliers—It is requested that Item 3860-101-0001 be decreased by \$75 million in 2022-23, and statutory changes be made to add Item 3860-101-3398 in the amount of \$75 million in 2021-22, to support conservation efforts in urban communities and aid in statewide emergency response efforts. It is also requested that provisional language be amended in Item 3860-101-0001 in 2022-23 to reflect these changes, and provisional language be added to Item 3860-101-3398 in 2021-22, as specified (see Attachments 4 and 5).
- Conservation for Small Suppliers— It is requested that Item 3860-101-0001 be decreased by \$25 million in 2022-23, and statutory changes be made to add Item 3860-101-3398 in the amount of \$25 million in 2021-22, to support conservation efforts in small communities and aid in statewide emergency response efforts. It is also requested that provisional language be amended in Item 3860-101-0001 in 2022-23 to reflect these changes, and provisional language be added to Item 3860-101-3398 in 2021-22, as specified (see Attachments 4 and 5).
- Turf Replacement—It is requested that Item 3860-101-0001 be decreased by \$75 million in 2022-23, and statutory changes be made to add



Item 3860-101-3398 in the amount of \$75 million in 2021-22, to support replacement of ornamental turf. It is also requested that provisional language be amended in Item 3860-101-0001 in 2022-23 to reflect these changes, and provisional language be added to Item 3860-101-3398 in 2021-22, as specified (see Attachments 4 and 5).

- Groundwater Recharge—It is requested that Item 3860-101-0001 be decreased by \$30 million in 2022-23, and statutory changes be made to increase Item 3860-101-0001 by \$56 million in 2021-22, to support projects contributing to implementation of the Sustainable Groundwater Management Act. It is also requested that provisional language be amended in Item 3860-101-0001 in 2022-23 to reflect these changes, and provisional language be added to Item 3860-101-0001 in 2021-22, as specified (see Attachments 4 and 6).
- Agriculture Drought Response Program and Delta Drought Response Pilot— It is requested that statutory changes be made to add Item 3860-101-3398 in the amount of \$60 million in 2021-22, to support two drought response programs that provide additional relief to farmers affected by the drought. It is also requested that provisional language be added to make the funds available for encumbrance or expenditure until June 30, 2025 (see Attachment 5).
- Migratory Bird Habitat—It is requested that statutory changes be made to add Item 3860-101-3398 in the amount of \$10 million in 2021-22, to support flooding of working landscapes to offset the impact of drought on various species. It is also requested that provisional language be added to make the funds available for encumbrance or expenditure until June 30, 2025 (see Attachment 5).
- Aquatic Habitat and Drought Resilience—It is requested that statutory changes be made to increase Item 3860-101-0001 by \$122 million in 2021-22, to support habitat restoration and aquatic habitat projects. It is also requested that provisional language be added to make the funds available for encumbrance or expenditure until June 30, 2024 (see Attachment 6).
- Solar Demonstration Projects—It is requested that statutory changes be made to increase Item 3860-101-0001 by \$30 million in 2021-22, for solar demonstration projects to support the determination of potential future viability. It is also requested that provisional language be added to make the funds available for encumbrance or expenditure until June 30, 2024 (see Attachment 6).
- Contingency Funding—It is requested that statutory changes be made to amend Control Section 11.85 of the Budget Act of 2021, to increase the amount to \$96 million in 2021-22, to support additional contingency funding needed to address the drought emergency and aid in statewide emergency efforts, and to make the funds available for encumbrance or expenditure until June 30, 2023 (see Attachment 9).

This proposal accelerates funding to address the immediate needs of the state and enables the state to prioritize critical projects moving forward at a point when the state has available resources and aligns appropriations to the fiscal year in which the resources are available.

**Water Resilience and Drought Package: Various Investments**—It is requested that the following various amendments be made:

- SGMA Implementation—It is requested that Item 3860-101-0001 be decreased by \$60 million in 2022-23, and statutory changes be made to increase Item 3860-101-0001 by \$60 million in 2021-22, to support implementation of the Sustainable Groundwater Management Act. It is also requested that provisional language be amended in Item 3860-101-0001 in 2022-23 to reflect these changes, and provisional language be added to Item 3860-101-0001 in 2021-22, as specified (see Attachments 4 and 6).
- Water Conveyance—It is requested that Item 3860-101-0001 be decreased by \$100 million in 2022-23, and statutory changes be made to increase Item 3860-101-0001 by \$100 million in 2021-22, to support water conveyance projects around the state. It is also requested that provisional language be amended in Item 3860-101-0001 in 2022-23 to reflect these changes, and provisional language be added to Item 3860-101-0001 in 2021-22, as specified (see Attachments 4 and 6).
- Salton Sea—It is requested that Item 3860-102-0001 be decreased by \$100 million in 2022-23, and statutory changes be made to increase Item 3860-102-0001 by \$100 million in 2021-22, to support habitat restoration efforts at the Salton Sea. It is also requested that provisional language be added to Item 3860-102-0001 in 2021-22, to make funds available for encumbrance or expenditure until June 30, 2025 (see Attachments 7 and 8).
- Urban Streams and Rivers—It is requested that Item 3860-102-0001 be decreased by \$6,660,000 in 2022-23, and statutory changes be made to increase Item 3860-102-0001 by \$6,660,000 in 2021-22, to support urban streams restoration efforts. It is also requested that provisional language be added to Item 3860-102-0001 in 2021-22, to make funds available for encumbrance or expenditure until June 30, 2025 (see Attachments 7 and 8).

This proposal accelerates funding which enables the state to prioritize these programs and projects moving forward at a point when the state has available resources and aligns appropriations to the fiscal year in which the resources are available.

The funds appropriated in Schedules (1)(a), (1)(b), and (1)(c) shall be available for, but are not limited to, public agencies, public utilities, special districts, colleges and universities, mutual water companies, nonprofit organizations, regional water management groups as defined in Section 10539 of the Water Code, federally recognized California Native American tribes, and non-federally recognized Native American tribes on the contact list maintained by the Native American Heritage Commission for the purposes of Chapter 905 of the Statutes of 2004. These funds are available for projects or activities in all counties regardless of whether the county falls under an active state-proclaimed drought state of emergency.

8. Up to 5 percent of the amount appropriated in this item may be used for administrative costs.

9. Any guidelines adopted to implement projects or activities funded by Schedules (1)(a), (1)(b), and (1)(c) are not subject to Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government Code.

10. A contract entered into pursuant to funding provided in Schedules (1)(a), (1)(b), and (1)(c) is exempt from Chapter 2 (commencing with Section 10290) of Part 2 of Division 2 of the Public Contract Code. The Department of Water Resources may award a contract under this section on a noncompetitive bid basis as necessary to implement projects or activities funded in these schedules.

11. The funds appropriated in Schedule (1)(d) shall be available for competitive grants that support implementation of the Sustainable Groundwater Management Act (Part 2.74 (commencing with Section 10720) of Division 6 of the Water Code).

12. Of the funds appropriated in Schedule (1)(d), \$60,000,000 shall be directed to projects that benefit groundwater basins in the San Joaquin Valley, and for the following purposes: (a) geophysical investigations of groundwater basins to identify recharge potential; (b) early implementation of existing regional flood management plans that incorporate groundwater recharge; and (c) projects in the San Joaquin Valley that would complement efforts of a local groundwater sustainability plan, that provide for floodplain expansion to benefit groundwater recharge or habitat. To expedite the execution of projects described in Schedule (1)(d), funds may be awarded through grants or direct expenditures to a public agency or a nongovernmental organization. Of the \$60,000,000, the department shall commit \$40,000,000 of these funds to projects by September 15, 2022."

(c) The aggregate amount of California Emergency Relief Fund appropriation increases provided under this section during the fiscal year may not exceed \$71,000,000.

(c) The Department of Finance shall notify the Joint Legislative Budget Committee of the amount augmented within 10 days after the augmentation is made.

(d) The appropriations cited in this section may occur until June 30, 2023.
