Amendment to and Addition of Various Budget Bill Items, Support, and Statutory Changes, Department of Consumer Affairs

Bureau of Private Postsecondary Education – Funding Shift—It is requested that Item 1111-002-0305 be decreased by \$2,754,000 and Item 1111-002-0960 be added in the amount of \$2,754,000 ongoing to address the insolvency of the Bureau of Private Postsecondary Education Administration Fund through fiscal year 2026-27 (see Attachment 1). The Bureau also requests statutory changes to effectuate this funding shift, which will move administrative claim workload costs associated with Student Tuition Recovery Fund and costs related to the Office of Student Assistance and Relief, from the Bureau's Administration Fund to the Student Tuition Recovery Fund. This will provide relief to the Bureau's Administration Fund until fee increases can be discussed as part of the Bureau's 2026 sunset review.

Pro Rata Adjustment for Technical May Revision Changes—It is requested that the following Items be increased or decreased as indicated below to redistribute the Department of Consumer Affairs' existing baseline Pro Rata costs to boards and bureaus based on the changes to the Department's budget related to Control Section 4.05 and 4.12 efficiencies. Amendment to Budget Bill Item 1115-001-3288 and Statutory Changes, Support, Department of Cannabis Control

Shift of Enforcement Expenditure Authority to the Cannabis Tax Fund—It is requested that statutory changes be made to allow the Department of Cannabis Control's illicit enforcement activities and California Track-and-Trace program costs to be funded from the Cannabis Tax Fund. Without the proposed changes, the Cannabis Control Fund would be unable to support additional enforcement activities without increasing fees on existing licensees.

To effectuate the shift of costs, it is requested that Item 1115-001-3288 be decreased by \$56,327,000 and 167.5 positions in fiscal year 2025-26, \$68,028,000 and 158 positions in 2026-27, \$66,911,000 and 151 positions in 2027-28, and \$66,967,000 and 151 positions in 2028-29 and ongoing, and provisional language be amended associated with the California Cannabis Track-and-Trace program (see Attachment 1). It is further requested that the Cannabis Tax Fund (Allocation 1) disbursements per Revenue and Tax Code section 34019(a)(1)(B) be increased by \$63,445,000 and 176.5 positions in 2025-26, \$73,021,000 and 178 positions in 2026-27, and \$73,009,000 and 178 positions in 2027-28 and ongoing. The additional resources across the Cannabis Control Fund and the Cannabis Tax Fund will support additional inspections and investigations by adding 27 staff over the next three years.

Statutory Changes to Strengthen Enforcement—It is requested that statutory changes be made to authorize the Department of Cannabis Control to close businesses that are found to be conducting illegal activity on premises being inspected by existing compliance and enforcement staff. Additionally, it is requested that statutory changes be made to authorize the Board of State and Community Corrections' (BSCC) Proposition 64 Public Health and Safety Grant Program, which is funded through Allocation 3 of the Cannabis Tax Fund, to award grants to local governments that prohibit cannabis cultivation if they authorize retail cannabis sales and requires the BSCC to prioritize grants to be directed to local illicit cannabis enforcement efforts. These changes will provide additional enforcement tools to the Department of Cannabis Control, expand collaboration with local law enforcement, and encourage retail participation to stabilize the legal market and promote consumer safety.

Amendments to Budget Bill Item 1700-001-0001, Support, Civil Rights Department

Housing Equity Outreach and Enforcement Budget Reinstatement—It is requested that Item 1700-001-0001 be increased by \$1,692,000 and 8 positions ongoing to correct a technical error and reflect funding and positions previously approved as ongoing in the 2021 Budget Act.

California vs. Hate Contract Exemption—It is requested that provisional language be added to Item 1700-001-0001 to exempt the Civil Rights Department from certain specified state contracting requirements for \$2,383,000 million one-time General Fund included in the Governor's Budget for continuation of the California vs. Hate Resource Line. This exemption will support continuity for the resource line in fiscal year 2025-26 and avoid gaps or delays in service (see Attachment 1).

It is requested that Item 1750-001-3153 be decreased by \$308,000 and 3 positions in fiscal year 2025-26 and \$369,000 in 2026-27 and ongoing to align operational expenditures with a loss of regulatory activities associated with the permanent closure of the Golden Gate Fields racing and training facility. Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance, Department of Housing and Community Development

Statewide Homelessness Accountability and Compliance—It is requested that Item 2240-001-0001 be increased by \$902,000 and 3 positions in fiscal year 2025-26 and 2026-27, \$560,000 in 2027-28 and ongoing, to support Department of Housing and Community Development (HCD) for various accountability activities, including codes and standards activities; litigation; Accessory Dwelling Unit compliance-monitoring workload; and public records act compliance.

Various Technical Adjustments—It is requested that Item 2240-101-6069 be added in the amount of \$20,470,000 to enable HCD to expend remaining balances of Infill Infrastructure Grant Proposition 1C bond funds (see Attachment 1). It is also requested that Item 2240-103-9736 be added in the amount of \$24,019,000 to enable HCD to expend remaining balances of Transit-Oriented Development Proposition 1 and 1C bond funds. For both items, it is requested that provisional language be added to make funds available for encumbrance and liquidation through June 30, 2030, with the ability to extend the liquidation as needed to facilitate project completion (see Attachment 2).

Additionally, it is requested that Item 2240-492 be added to extend the liquidation period for \$237 million included in the 2021 Budget Act for the Infill Infrastructure Grant Program to provide grantees with the additional time needed to complete construction of infill infrastructure and housing projects (see Attachment 3).

Community Development Block Grant–Disaster Recovery Resources—It is requested that Item 2240-102-0890 be added in the amount of \$416,597,000 one-time to align with federal Community Development Block Grant–Disaster Recovery resources that will be available to HCD beginning in 2025-26 to support long-term recovery efforts related to 2023 and 2024 natural disasters. It is also requested that provisional language be added to make funds available for encumbrance or expenditure through June 30, 2032, consistent with federal spending authority and to authorize the transfer of funds for state operations to support program administration (see Attachment 4).

General Fund Solution: Reversion of Unexpended Affordable Housing Program Funding—It is requested that Item 2240-495 be added to revert \$31,731,000 General Fund appropriated in the 2021, 2022, and 2023 Budget Acts for the Infill Infrastructure Grant Program, Commercial Property Pilot Program, and the Infill Infrastructure Grant Catalytic Program that has not been expended (see Attachment 5).
