Amendments to and Addition of Various Budget Bill Items, Support and Local Assistance, and Statutory Changes, State Water Resources Control Board

California Environmental Protection Agency (CalEPA) Bond and Technical Adjustments:

Administrative Hearings Office—It is requested that Item 3940-001-0001 be amended by making a net-zero transfer of \$572,000 and 2.2 positions from the Water Rights Program (3570) to the Administrative Hearings Office Program (3571). It is also requested that Item 3940-001-3058 be amended by making a net-zero transfer of \$2,820,000 and 10.8 positions from the Water Rights Program (3570) to the Administrative Hearings Office Program (3571). These changes are intended to separately and clearly display the budget for the Board's Administrative Hearings Office (see Attachments 1 and 2).

**Legal Resources to Respond to Federal Actions**—It is requested that Items 3940-001-0193, 3940-001-0306, 3940-001-0439, and 390-001-3058 be increased by \$200,000 each for a total of \$800,000 ongoing and 3 permanent positions to support increased litigation in response to federal legal challenges to environmental laws and regulations.

Monterey County Primacy Delegation Agreement Termination—It is requested that Item 3940-001-0306 be increased by \$2,720,000 ongoing and 12 permanent positions to provide regulatory oversight of public small water systems in Monterey County. Oversight of 284 water systems is anticipated to be transferred from the County to the Water Board in August 2025, and the state is legally mandated to administer this regulatory program.

California Environmental Protection Agency (CalEPA) Bond and Technical Adjustments: Proposition 13 (2000)—It is requested that Item 3940-101-6013 be added in the amount of \$1,512,000 one-time, and that Item 3940-101-6022 be added in the amount of \$1,133,000 one-time with extended encumbrance periods to allow additional time for design, bid, construction, and project monitoring for newly executed projects that provide watershed and coastal water quality benefits (see Attachments 3 and 4).

Replacing, Removing or Upgrading Underground Storage Tanks (RUST) Program

**Augmentation**—It is requested that Item 3940-101-8026 be increased by \$23 million one-time to provide sufficient expenditure authority to meet current funding demand for the removal or replacement of petroleum underground storage tanks. It is also requested that statutory changes be added to enable administrative efficiencies that allow tank owners to begin projects while waiting for a final funding agreement to be executed. These changes will maximize compliance with the requirement to remove single-walled tanks by December 31, 2025, and help prevent groundwater contamination.

- 1. Notwithstanding any other law, the Director of Finance may authorize the temporary or permanent redirection of funds from this item for purposes of emergency fire suppression and detection costs and related emergency revegetation costs.

- (a) Any appropriation from the Greenhouse Gas Reduction Fund shall be subject to the restrictions specified in subdivision (b).
- (b) No department shall encumber or commit more than 75 percent of any appropriation prior to the fourth cap and trade auction in the 2025-26 2024-25-fiscal year. Upon determination of the final amount of auction proceeds after the fourth cap and trade auction, the Department of Finance shall make a final determination for the expenditure of the remaining available auction proceeds. The Department of Finance shall notify the Joint Legislative Budget Committee no later than 30 days after its final determination if there are decreased auction proceeds that require a modification to the expenditure of funds.
- (c) Subparagraph (A) of paragraph (3) of subdivision (b) of Section 39719 of the Health and Safety Code requires 5 percent of annual proceeds to be transferred to the Safe and Affordable Drinking Water Fund. The Director of Finance may transfer to the Safe and Affordable Drinking Water Fund an additional amount equal to the difference between the amount transferred in a quarter pursuant to subparagraph (A) of paragraph (3) of subdivision (b) of Section 39719 of the Health and Safety Code and \$32,500,000 per quarter of the 2023–24 fiscal year.
- (d) The Administrative Procedure Act (Chapter 3.5 (commencing with Section 11340) of Part 1 of Division 3 of Title 2 of the Government Code) does not apply to guidelines or other standards adopted and used by a state agency in administering an allocation of moneys from the Greenhouse Gas Reduction Fund.
- (e) The following amounts shall not be included in determining the amount of annual proceeds of the fund for purposes of the calculation in Section 39719 of the Health and Safety Code:
- (1) Amounts appropriated by subparagraph (A) of paragraph (3) of subdivision (g) of Section 6377.1 of the Revenue and Taxation Code.

- (2) Amounts described in Sections 4210 to 4214, inclusive, of the Public Resources Code to replace the revenues generated by the State Responsibility Area fire prevention fee authorized by Section 4212 of the Public Resources Code, which is suspended, pending repeal, pursuant to Section 4213.05 of the Public Resources Code.
- (f) The following provisions apply to specified Greenhouse Gas Reduction Fund appropriations, including Items 0540-001-3228, 2660-101-3228, 3360-001-3228, 3360-001-3228, 3600-001-3228, 3640-101-3228, 3760-102-3228, 3860-001-3228, 3860-101-3228, 3860-301-3228, 3940-102-3228, and 8660-101-3228.
- (1) The funds shall be used for the purpose of facilitating the achievement of reductions of greenhouse gas emissions in this state in accordance with the requirements of Section 39712 of the Health and Safety Code or to improve climate change adaptation and resiliency, or environmental quality and public health, of California's communities, with an emphasis on disadvantaged communities, as defined in Section 39711 of the Health and Safety Code, or low-income households or communities, as defined in Section 39713 of the Health and Safety Code, consistent with Division 25.5 (commencing with Section 38500) of the Health and Safety Code.
- (2) A state agency may also comply with the requirements of paragraphs (2) and (3) of subdivision (a) of Section 16428.9 of the Government Code by describing how each proposed expenditure will improve climate change adaptation and resiliency, or environmental quality and public health, of disadvantaged communities or low-income households or communities.
- (3) For the purposes of subdivision (b) of Section 16428.9 of the Government Code and Section 39720 of the Health and Safety Code, the State Air Resources Board, in consultation with the relevant state agency, may develop methodologies and collect metrics or other information related to the description provided pursuant to paragraph (2) from the state agency."
