Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance, Employment Development Department

**Continuation of Operating System License Agreement**—It is requested that Item 7100-001-0185 be increased by \$4,141,000 ongoing and Item 7100-001-0588 be increased by \$1,455,000 ongoing to support the continuation of EDD's Microsoft 365 enterprise license agreement.

**Workforce Innovation and Opportunity Act Allocations**—It is requested that Items 7100-001-0869 and 7100-021-0890 be increased by \$22,848,000 one-time and Items 7120-101-0869 and 7100-101-0890 be increased by \$96,720,000 one-time to align Workforce Innovation and Opportunity Act funding authority with estimated federal allocations.

**Unemployment Insurance Loan Interest Payment**—It is requested that Item 7100-002-0001 be increased by \$8,529,000 one-time to reflect an updated Unemployment Insurance loan interest payment estimate. In conjunction with the amount proposed at Governor's Budget, this will be used to fund the estimated interest payment of \$642,822,000.

**EDDNext Reappropriation**—It is requested that Item 7100-490 be added to reappropriate \$163,415,000 Unemployment Compensation Disability Fund included in the 2024 Budget Act for the EDDNext modernization projects to make funds available for an additional year, through June 30, 2026 (see Attachment 1). This is needed to correct a technical error reflected in the 2024 Budget Act and align the encumbrance availability with the corresponding General Fund appropriation for EDDNext.

Amendment to Budget Bill Item 7120-001-0001 and Addition of Items 7120-490 and 7120-495, Support and Local Assistance, California Workforce Development Board

**Continuing Grant Workload**—It is requested that Item 7120-001-0001 be increased by \$1.5 million one-time to support the continuation of California Workforce Development Board grant administration and evaluation activities in fiscal year 2025-26. It is further requested that Item 7120-495 be added to revert \$1.5 million included in the 2021 Budget Act (see Attachment 1).

**Extensions of Liquidation for Grant Funding**—It is requested that Item 7120-490 be added to extend the liquidation periods for the following items to allow grantees impacted by wildfires and other unanticipated delays to have additional time for program implementation and service delivery (see Attachment 2).

- \$6,062,000 in Item 7120-101-0001, Budget Act of 2021, for the Prison to Employment program. The requested reappropriation will extend the liquidation period through June 30, 2028.
- \$64,230,000 in Item 7120-101-0001, Budget Act of 2022, for workforce development programs focused on health and human services, well capping, and reentry. The requested reappropriation will extend the liquidation period through June 30, 2028.
- \$2,723,000 in Item 7120-102-0001, Budget Act of 2023, for the Breaking Barriers to Employment Initiative. The requested reappropriation will extend the liquidation period through June 30, 2029.

**California Department of Technology Rate Increases**—It is requested that Item 7350-001-0223 be increased by \$1,030,000 ongoing to fund additional costs associated with California Department of Technology rates based on the Department of Industrial Relations' (DIR's) current utilization of systems and services.

**Apprenticeship Training Grant Augmentation**—It is requested that Item 7350-001-3022 be increased by \$18,242,000 one-time to support the expansion of building and construction trade apprenticeship grants in fiscal year 2025-26. Add the following provision to Item 7350-001-3078:

5.
