This Budget Letter addresses increases in 2004-05 for special or non-governmental cost fund appropriations only and increases in 2005-06 for special, nongovernmental cost and federal fund, or reimbursement appropriations for attorney services provided to departments and agencies by the Department of Justice (DOJ).

A. Background

Control Section 5.30

Control Section 5.30 of the 2004 Budget Act authorizes the augmentation of special fund and non-governmental cost fund appropriations as necessary to fund any rate increase by the DOJ for attorney services provided to State entities during the 2004-05 fiscal year. An augmentation approved by the Department of Finance (Finance) may be made not sooner than 30 days after notification to the Joint Legislative Budget Committee. The augmentation may only be made if the fund has a sufficient reserve balance to cover the augmentation without a fee increase.

Standard Attorney General Legal Services Rates

Government Code 11044 authorizes the Attorney General to charge an amount sufficient to recover the costs incurred in providing legal services to State agencies. Effective July 1, 2004, the Attorney General increased the rate to \$139 per hour for standard attorney services and \$91 per hour for paralegals. The rates will increase to \$146 per hour for attorneys and \$92 per hour for paralegals beginning July 1, 2005. Departments receiving services from the DOJ under a memorandum of understanding are subject to these rates.

Augmentations in 2004-05 and 2005-06

In order to provide departments with additional expenditure authority in the current and budget years for DOJ legal services costs, Finance must determine the amount by which projected DOJ charges exceed the amounts budgeted. Departments must ensure that sufficient fund balances are available to accommodate the requested augmentation. Upon Finance's verification of a sufficient fund balance, augmentations will be built into the 2005-06 Governor's Budget.

B. Instructions

Attachment I reflects attorney hours projected by DOJ for 2004-05 and 2005-06, based on the historical average. The hours are DOJ's estimate of all billable hours, regardless of fund source.

Attachment II contains a worksheet to calculate the total costs associated with the rate increases in the current and budget years and to indicate funding allocation. Attachment III illustrates how departments should reflect the requested adjustments in their Schedule 10s. Attachment IV is necessary in order to process a budget Executive Order for current year augmentations. Attachment V reflects current and budget year baseline adjustments that will be entered on Line 0700 in the Planning Estimates. Using the projected hours and supplying the amounts budgeted for AG legal services, departments need to determine the level of billable hours that are funded from special funds, non-governmental cost funds, federal funds or reimbursements, and General Fund. Federal funds and reimbursements can be adjusted for 2005-06, but they are not eligible to receive an augmentation through Control Section 5.30. Therefore, any current year increase in expenditure authority for those funding sources can be addressed through the authority in Section 28.00 and Section 28.50 of the 2004 Budget Act. For any billable hours that are funded from the General Fund, departments will not be eligible to receive an augmentation for either 2004-05 or 2005-06, the fund balance must be sufficient to cover the augmentation without a fee increase.

Should departments submit a funding amount in Attachment II that is based on a greater amount of hours than reflected in Attachment I, departments must provide their Finance Budget Analyst with both supporting documentation and an explanation justifying the higher request.

Attachment III provides an example to illustrate how departments are to post these allocations to their current year Schedule 10s.

C. Due Date

Departments are required to return all legal service rate worksheets to their respective Finance Budget Analysts as soon as possible but **no later than November 30, 2004.**
