 - Provide new and correct existing addresses.
 - Census Address List Improvement Act of 1994 (PL 103-430).

LUCA: Feedback and Appeals

Background

An Act

To amend title 13, United States Code, to improve the accuracy of census address lists, and for other purposes.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

This Act may be cited as the “Census Address List Improvement Act of 1994”.

H. R. 5084—2

“(3) The Bureau should respond to each recommendation made by a census liaison concerning the accuracy of address information, including the determination (and reasons therefor) of the Bureau regarding each such recommendation.

SEC. 3. DEVELOPMENT OF APPEALS PROCESS BY ADMINISTRATOR OF THE OFFICE OF INFORMATION AND REGULATORY AFFAIRS.

The Administrator of the Office of Information and Regulatory Affairs, acting through the Chief Statistician and in consultation with the Bureau of the Census, shall develop an appeals process for those States and local units of general purpose government which desire to appeal determinations of the Bureau of the Census pursuant to section 16(a)(2) or (b)(3) of title 13, United States Code. Appeals under such process shall be resolved before the decennial census date. The Chief Statistician shall publish the proposed appeals process for a period of public comment before finalizing such process.

Some examples of records that were not processed include the following: addresses submitted with blank or invalid action codes, added records submitted without geospatial information (e.g. census tract and census block codes), added records submitted with 9-digit numeric MAFIDs, action codes other than "A" used on records without MAFIDs, and non-city style addresses submitted without map spots or latitude and longitude coordinates.

LUCA: Appeals

Appeals Process Under Development

- Office of Management and Budget
- Partners will have 45 days to file their appeals
- Partners can appeal reject codes where their submitted address/correction was not accepted and added into the Census:
 - **Action Rejected: Address is not in the 2020 Census:** The Census Bureau rejected the user action and will not include this address in the 2020 Census enumeration universe for your jurisdiction.
 - **Address Removed: Address is not in the 2020 Census:** The partner did not update this address, but the Census Bureau removed the address from the 2020 Census enumeration universe for your jurisdiction in a separate census operation.



New Construction Program

- The New Construction Program provides a voluntary opportunity for designated representatives of tribal, state, and local governments to update the Census Bureau's residential address list with new city-style addresses.
- Participation in the 2020 LUCA Operation **IS NOT** a prerequisite for participation in the 2020 New Construction program.
- Construction of new living quarters must be **in progress during or after March 1, 2018** with completion expected by Census Day, April 1, 2020.
 - Completion is defined as closing the structure to the elements.

New Construction Program

- Group Quarters and Transient Locations are eligible addresses - **NEW for the 2020 New Construction Program.**
- No Title 13 protected data.
- Participants have 45 calendar days to complete their review – **NO EXTENSIONS!**

Eligible Governments

- Governments with blocks included in **Type of Enumeration Area (TEA) 1 – Self Response** are eligible for New Construction participation.
- TEA 1 – Self Response includes 137,542,007 Housing Units (95.33% stateside coverage).
- Address updates in blocks not included in TEA 1 will be rejected.

- Basic Digital Option.
 - Geographic Update Partnership Software (GUPS).
- Advanced Digital Option.
 - Partnership Shapefiles.
 - Address ADD Template.
- Reference PDF Maps on CD/DVD with Digital Address ADD Template.
- Data available via GUPS, Partnership Shapefiles and PDF Maps will indicate which blocks are included in TEA 1 (e.g. 'NCELIGIBLE').
- No Paper Option.

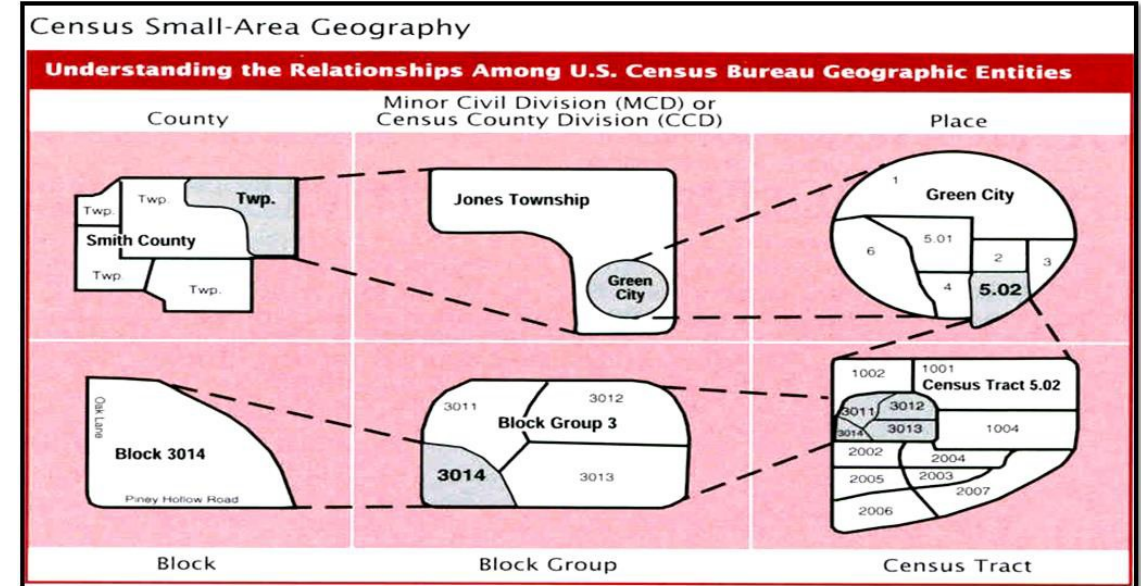
New Construction Program Schedule

PSAP Geographies

- Standard statistical geographies.
 - Census tracts.
 - Block groups.
 - Census designated places (CDPs).
 - Census county divisions (CCDs) in select states.
- Tribal statistical geographies.
 - Tribal census tracts.
 - Tribal block groups.
 - Census designated places (CDPs).
 - Alaska Native village statistical areas (ANVSAs).
 - Oklahoma tribal statistical areas (OTSAs).
 - OTSA tribal subdivisions.
 - Tribal designated statistical areas (TDSAs).
 - State designated tribal statistical areas (SDTSAs).

New for 2020 Census PSAP

- The 2010 statistical geographies were reviewed and updated by the Census Bureau for **proposed** 2020 statistical geographies (PreSAP).
- Geographic Update Partnership Software (GUPS).
- Secure Web Incoming Module (SWIM).
- Parcel boundaries can be used for statistical area boundaries.
- Tribal Statistical Areas Program (TSAP) now part of 2020 PSAP.

Invitation Phase

- Currently sending out and processing registration materials.
- Regional Geographers will be contacting non-responding entities to increase registration.
- **October 31, 2018 is the registration deadline.**

Delineation Phase

- Census Bureau will create and distribute materials to participants – **January 2019.**
- Registered participants will have the following options:
 - Accept the Census Bureau's 2020 Census proposed statistical areas defined during PreSAP.
 - Update the 2020 Census proposed statistical areas.
 - Use the 2010 Census statistical area geography as a base to make updates.
- Participants will have 120 calendar days to complete review and updates and return their submission.

PSAP Schedule

| July 2019 | Participants notified of delineation phase closeout. |
| January 2020 | Verification phase begins. Participants have 90 calendar days to review updates. |
| October 2020 | Participants notified of program closeout. |



Boundary and Annexation Survey (BAS)

- Annual opportunity for invited governments to:
 - Review boundaries, names, and governmental status.
 - Make corrections and updates to these boundaries, names, and status.

Three options available to review and update boundaries:

- Free digital software.
- Free shapefiles.
- Free paper maps.

Documentation:

- Required for new annexed land or incorporations (e.g., ordinance number).
- Not required for spatial boundary corrections.

BAS Schedule and Deadlines

| Timeframe | Activity |
|---------------|--|
| Every January | Invitation letter/e-mail sent to Highest Elected Official and BAS point of contact. |
| Every March 1 | Deadline to submit updates for all subsequent censuses, surveys, and estimates published for that year. |
| Every May 31 | Final deadline to submit updates for the following year's BAS materials. |

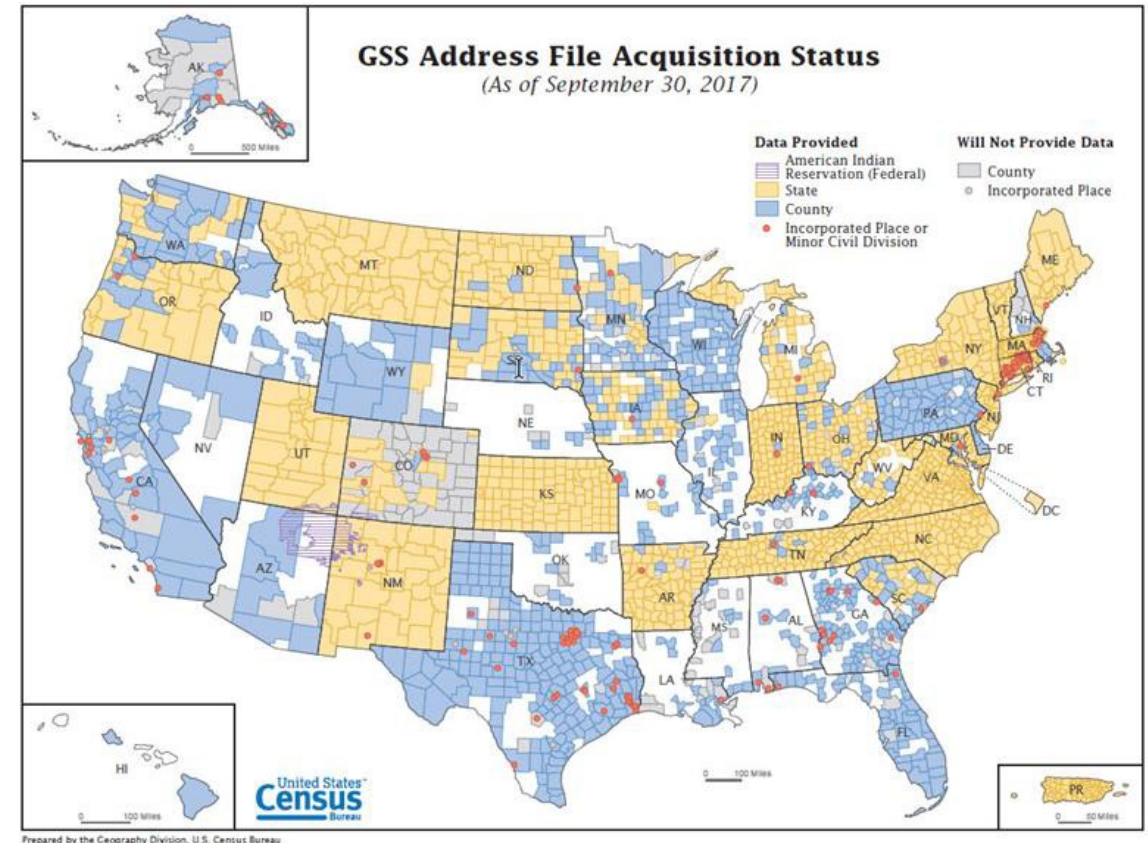
- Required for new annexed land or incorporations (e.g., ordinance number).

Spatial, Address, and Imagery Data (SAID) Program

- Annual opportunity for **invited** tribal, state, and local governments and other partners to provide:
 - Address point files
 - Street centerline files
 - Imagery

Formerly known as the Geographic Support System (GSS) Partnership Program



SAID Background

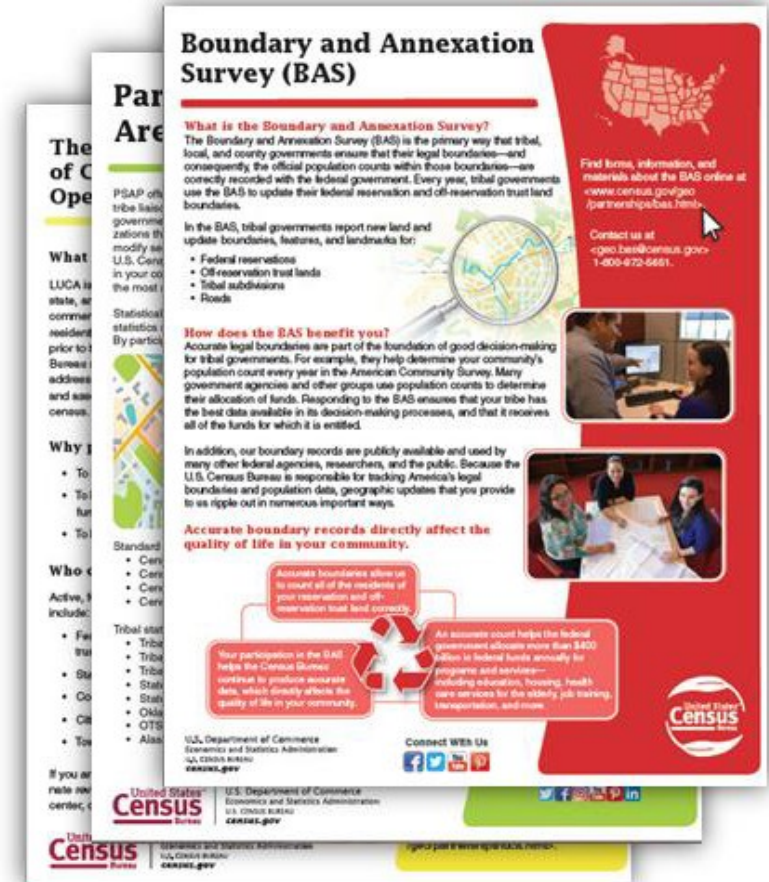
- Maintain and update the geographic framework for data collection, tabulation, and dissemination.
- Integrated program to:
 - Improve address coverage.
 - Conduct continuous spatial feature updates.
 - Collect updated imagery.
 - Enhance quality assessment and measurement of the MAF/TIGER System.
- Strengthen ongoing partnerships throughout the decade.

SAID Schedule

| Timeframe | Activity |
|--|---|
| Every Fall-Spring Beginning after October 1 | <i>Invite</i> tribal, state, and local governments and other partners to submit address files, street centerline files, and imagery. |
| Every Spring-Fall Ending by September 30 | <i>Process</i> updates received from partners and <i>Update</i> the MAF/TIGER Database. |
