Amendment to Budget Bill Item 2720-301-0660, Capital Outlay, California Highway Patrol

Continuing Area Office Replacement Projects–Fund Shift from General Fund to Lease Revenue Bonds—It is requested that Item 2720-301-0660 be increased by \$201,369,000 one-time, as follows:

- Add Quincy: Area Office Replacement \$54,170,000 (an increase of \$3,040,000 over existing appropriation)
- Add Baldwin Park: Area Office Replacement \$74,095,000 (an increase of \$8,883,000 over the existing appropriation)
- Add Santa Fe Springs: Area Office Replacement \$73,104,000 (an increase of \$5,126,000 over the existing appropriation)

This request is consistent with the 2023 Governor's Budget proposal to shift the projects' authority from General Fund to Lease Revenue Bonds. The Governor's Budget included a General Fund reversion item with the intent to provide fiscal year 2022-23 Lease Revenue Bond funding. However, a 2022-23 mechanism to do so has not been identified yet, thus precipitating this request. The increased amounts reflect cost impacts related to supply chain issues and delays because the projects cannot proceed to the design-build phase until fiscal year 2023-24 (see Attachment 1).

San Bernardino Area Office Replacement—It is requested that Item 2720-301-0660 be increased by \$7,407,000 one-time to supplement the design-build phase of the San Bernardino Area Office Replacement project. This additional funding will address cost increases related to supply chain issues and delays associated with restarting the project (see Attachment 1).

Amendment to Budget Bill Item 2740-001-0044 and Addition of Item 2740-490, Support, Department of Motor Vehicles

It is requested that Item 2740-001-0044 be increased by \$3,433,000 one-time, and provisional language be added to continue the Enterprise Content Management (ECM) Information Technology project that will simplify how employees access the Department of Motor Vehicles' (DMV) multiple data repositories (see Attachment 1). This project will automate record retention rules and increase data security. The provisional language is requested because although DMV is expected to complete the Project Approval Lifecycle (PAL) in fiscal year 2022-23, completion of the PAL may be pushed into early 2023-24.

It is also requested that Item 2740-490 be added to reappropriate \$395,000 of the previously approved \$5,457,000 in Motor Vehicle Account funds from the 2022 Budget Act to continue project activities originally scheduled in 2022-23 for the ECM project mentioned above (see Attachment 2). The delay and subsequent reappropriation is the result of extensive testing with developers.

Amendment to Budget Bill Item 2740-301-0660 and Addition of Budget Bill Item 2740-491, Capital Outlay, Department of Motor Vehicles

Inglewood: Field Office Replacement-Fund Shift from General Fund to Lease Revenue Bonds—It is requested that Item 2740-301-0660 be increased by \$21,962,000 one-time for the construction phase of the Inglewood project, an increase of \$1,034,000 over the existing appropriation (see Attachment 1).

This request is consistent with the 2023 Governor's Budget proposal to shift construction authority from General Fund (GF) to Lease Revenue Bonds (LRB). The Governor's Budget included a GF reversion item with the intent to provide fiscal year 2022-23 LRB funding. However, a 2022-23 mechanism to do so has not been identified yet, thus precipitating this request. The increased amounts reflect cost impacts related to supply chain issues and delays because the project cannot proceed to the construction phase until fiscal year 2023-24.

Headquarters: Elevator Modernization-Reappropriate Working Drawings—It is requested that Item 2740-491 be added to reappropriate the working drawings phase of this project (see Attachment 2). The reappropriation is necessary due to a delay in securing a project manager, creating the potential that working drawings will not be encumbered in the current year. We note that if this request is approved, the project scope will change from 11 elevator replacements to 8. The department determined that the three elevators in Headquarters Building West were in such disrepair that replacement needed to be accelerated and funded out of existing support funds.
