Amendment to and Addition of Various Budget Bill Items and Reimbursements, Support and Local Assistance, Judicial Branch

Allocation for Employee Compensation and Staff Benefits—It is requested that Item 0250-001-0001 be increased by \$22,000 ongoing to revise the Item 9800 employee compensation adjustment to reflect recently approved salary increases for Staff Attorneys.

Community Assistance, Recovery, and Empowerment (CARE) Court—It is requested that Item 0250-001-0001 be increased by \$1,139,000 in fiscal year 2023-24, \$549,000 in 2024-25, and be decreased by \$73,000 in 2025-26 and ongoing; Item 0250-101-0001 be increased by \$15,620,000 in 2023-24, \$29,285,000 in 2024-25, and \$33 million in 2025-26 and ongoing, Items 0250-111-0001 and 0250-101-0932 be increased by \$8,913,000 in 2023-24 and \$4,699,000 in 2024-25, to revise CARE Court funding proposed in the Governor's Budget. This adjustment provides additional resources to support early implementation of CARE Court in Los Angeles County and doubles the number of hours per participant for legal services from 20 hours to 40 hours. It is requested that provisional language be amended to update amount references, and to add language to extend the encumbrance period of balances of CARE planning grants allocated in 2022-23 through June 30, 2024. It is also requested that provisional language be amended and added to specify the allocation methodology of funding for legal services (see Attachment 1, 2, and 3).

Federal Byrnes State Crisis Intervention Program Grant—It is requested that Item 0250-001-0001 be amended to increase reimbursement authority by \$695,000 in 2023-24, \$470,000 in 2024-25, and \$485,000 in 2025-26; and Item 0250-101-0001 be amended to increase reimbursement authority by \$5,204,000 in 2023-24, 2024-25, and 2025-26. These adjustments are necessary to support an interagency agreement with the Board of State and Community Corrections to implement federal funds from the Byrne State Crisis Intervention Program. The Judicial Council will implement a statewide

project that improves execution of firearm relinquishment orders, and expands and enhances collaborative courts by providing funding, training, and technical assistance.

State Court Facilities Construction Fund Solvency—It is requested that Item 0250-015-0001 be decreased by \$34 million one-time in 2023-24 to reduce the General Fund backfill to the State Court Facilities Construction Fund proposed in the Governor's Budget. This adjustment reflects updated revenue estimates that have increased due to one-time revenues from the sale of the West Los Angeles Courthouse.

Ability-to-Pay Backfill Adjustment—It is requested that Item 0250-103-0001 be decreased by \$20,651,000 in 2023-24, and \$30 million ongoing, to reflect updated estimates of revenue losses due to the implementation of the Ability-to-Pay program. The associated revenue loss for all courts is lower than expected and is estimated to total \$26,371,000 in 2023-24, and \$28,430,000 ongoing.

Filing Fee Waiver Backfill Adjustment—It is requested that Item 0250-103-0001 be decreased by \$16,374,000 ongoing to reduce the General Fund backfill for the revenue loss related to the expansion of filing fee waivers in the 2022 Budget Act.

Technical Provisional Language Adjustment—It is requested that provisional language in Item 0250-101-0001 be amended to correct an error in the amount of funding available for the administrative costs of a grant program to provide legal services for indigent persons (see Attachment 4).

Extended Availability of Pretrial Funding—It is requested that provisional language be added to Item 0250-101-0001 to authorize the trial courts to carryover funding for pretrial services appropriated in the 2021 and 2022 Budget Acts to Los Angeles County, until June 30, 2024. This language is necessary to provide Los Angeles County additional time to establish its pretrial program (see Attachment 5).

Court-Appointed Special Advocate Program—It is requested that Item 0250-111-0001 and Item 0250-101-0932 maintain \$20 million in 2023-24 and 2024-25 for the Court-Appointed Special Advocate Program. The Governor's Budget proposed to revert these funds in statewide Control Section 4.06. The May Revision restores this reversion and maintains funding for this program.

Trial Court Employee Benefit Adjustment—It is requested that Item 0250-111-0001 and Item 0250-101-0932 be decreased by \$21,437,000 ongoing to reflect the updated health benefit and retirement rate changes for trial court employees.

Trial Court Trust Fund Backfill—It is requested that Item 0250-113-0001 be decreased by \$4,173,000 ongoing to reflect updated revenue shortfalls based on the most current estimates of the Trial Court Trust Fund revenues for fiscal year 2023-24.

Reappropriation of CARE Court Funding—It is requested that Item 0250-493 be added to reappropriate up to \$1,750,000 provided in the 2022 Budget Act, for information technology enhancements related to the implementation of the CARE Act. This is

necessary to provide the Judicial Council additional time to redesign the existing court case management system to incorporate CARE Act reporting (see Attachment 6).

Early Reversion of Various Proposals—It is requested that Item 0250-496 and Item 0250-011-0932 be added to revert the remaining balances of proposals in previous Budget Acts including savings from trial court employee benefits, and proposals from previous Budget Acts for court reporters in family law and civil cases, increased transcript rate costs, Pretrial Pilot Projects, and implementation of Chapter 993, Statutes of 2018 (AB 1793) (see Attachment 7 and 8).

Technical Adjustment to Shift Reversion of 2021 Balances (Deferred Maintenance)— It is requested that Item 0250-497 be added to revert \$49.5 million of appropriations to fund deferred maintenance projects in the Judicial Branch provided by the 2021 Budget Act. The Governor's Budget reverted these funds in statewide Control Section 4.06. This is a technical adjustment to provide transparency at the department level by shifting the reversions from the statewide control section to the applicable departmental budget (see Attachment 9).

Amend Provision 21 of Item 0250-001-0001 as follows:

- "21. Of the amount appropriated in Schedule (3), \$293,000 \$1,432,000 is available for the Judicial Council for administrative costs related to allocating resources for legal services to implement the Community Assistance, Recover, and Empowerment Act. shall be distributed by the Judicial Council to the Legal Services Trust Fund Commission of the State Bar of California for administrative costs related to allocating resources for legal services to implement the Community Assistance, Recovery, and Empowerment (CARE) Act.
 - (a) The Legal Services Trust Fund Commission will be responsible for collecting outcome data from each county's public defender office, qualified legal services projects, and support centers. The State Bar of California shall annually provide to the Judicial Council a report that includes funding allocations, annual expenditures, and program outcomes by service area, and service provider.

 Data shall be reported using the reporting framework developed by the Legal Services Trust Fund Commission. The Judicial Council shall include this report in the annual report pursuant to Section 5985 of the Welfare and Institutions Code."

Amend Provision 19 of Item 0250-101-0001 as follows:

- "19. Of the funds appropriated in this item Schedule (5), \$5,850,000 \$20,400,000 is available for legal services to implement the Community Assistance, Recovery, and Empowerment (CARE) Act, and shall be distributed by the Judicial Council through the Legal Services Trust Fund Commission of the State Bar of California as grants to qualified legal services projects, as defined in Section 6213 to 6214.5, inclusive, of the Business and Professions Code, to provide legal counsel pursuant to subdivision (c) of Section 5976 of the Welfare and Institutions Code for representation in CARE Act proceedings, matters related to CARE agreements, and CARE plans by October 1, 2023.
 - (a) Notwithstanding the competitive nature of these grants, the Legal Services Trust Fund Commission shall use a formula to determine the amount of funding to provide representation in CARE Act proceedings, matters related to CARE agreements, and CARE plans in each county.
 - (b) These grants are to serve the seven counties listed in subdivision (a) of Section 5970.5 of the Welfare and Institutions Code and the County of Los Angeles. The Legal Services Trust Fund Commission shall provide any funds not awarded to qualified legal services projects for representation in CARE Act proceedings, matters related to CARE agreements, and CARE plans in each county to that county's public defender office to provide those services."

Add Provision 20 to Item 0250-101-0001 as follows:

20. Of the funds appropriated in Schedule (5), up to \$1,020,000 is available to provide legal training and technical assistance related to the implementation of the Community Assistance, Recover, and Empowerment (CARE) Act. These funds shall be distributed by the Judicial Council through the Legal Services Trust Fund Commission of the State Bar of California as grants to qualified support centers in order to provide representation by October 1, 2023. The Legal Services Trust Fund Commission shall provide any funds not awarded to qualified support centers for representation in CARE Act proceedings, matters related to CARE agreements, and CARE plans in each county to that county's public defender office to provide those services by October 1, 2023.

Add Provision 38 to Item 0250-101-0932 as follows:

38. Notwithstanding Section 77203 of the Government Code, trial courts may carry any unexpended balances of the \$2,828,000 that was specifically appropriated in the 2022 Budget Act, Item 0250-101-0932 and identified in Provision 36 of that item for implementation of the Community Assistance, Recovery, and Empowerment (CARE) Act, to June 30, 2024. Any unexpended funds shall revert to the General Fund.

Amend Provision 36 of Item 0250-101-0932 as follows:

"36. Of the funds appropriated in Schedule (1), \$20,536,000 \$29,449,000 is available for the implementation of the Community Assistance, Recovery, and Empowerment (CARE) Act."

Amend Provision 1 and 2 of Item 0250-101-0001

- "1. In order to improve equal access and the fair administration of justice, \$35,392,000 of the funds appropriated in Schedule (5) are to be distributed by the Judicial Council through the Legal Services Trust Fund Commission to qualified legal services projects and support centers as defined in Sections 6213 to 6215, inclusive, of the Business and Professions Code, to be used for legal services in civil matters for indigent persons. The Judicial Council shall approve awards made by the commission if the council determines that the awards comply with statutory and other relevant guidelines. Up to 10 percent of the funds appropriated for purposes of this provision shall be for joint projects of courts and legal services programs to make legal assistance available to proper litigants and not less than 90 percent of the funds appropriated for purposes of this provision shall be distributed consistent with Sections 6216 to 6223, inclusive, of the Business and Professions Code. Any funding not allocated for joint projects shall be redistributed consistent with Sections 6216 to 6223, inclusive, of the Business and Professions Code. The Judicial Council may establish additional reporting or quality control requirements consistent with Sections 6213 to 6223, inclusive, of the Business and Professions Code. Of the amount appropriated for purposes of this provision, not more than \(\frac{1}{2}\).5 percent shall be available, upon order of the Department of Finance, for administrative costs of the Judicial Council and the State Bar.
- 2. In order to improve equal access and the fair administration of justice, \$5,000,000 shall be annually appropriated in Schedule (5) by the Judicial Council to the California Access to Justice Commission for grants to civil legal aid nonprofits, including qualified legal services projects and support centers as defined in Sections 6213 to 6215, inclusive, of the Business and Professions Code, to be used to support the infrastructure and innovation needs of legal services in civil matters for indigent persons. Of this amount, not more than 1-2.5 percent shall be available for administrative costs of the California Access to Justice Commission associated with distributing and monitoring the grants."

Add Provision 21 to Item 0250-101-0001 as follows:

21. Notwithstanding Section 77203 of the Government Code, trial courts may carry any unexpended balances of the funding that was specifically appropriated in Provisions 9 and 10 of Item 0250-101-0001, 2021 Budget Act, and in Provision 8 of Item 0250-101-0001, 2022 Budget Act, for pretrial services in Los Angeles County, to June 30, 2024. Any unexpended funds shall revert to the General Fund.

Add Item 0250-493 as follows:

0250-493—Reappropriation, Judicial Council. The balances of the appropriations provided in the following citations are reappropriated for the purposes provided in those appropriations and shall be available for encumbrance or expenditure until June 30, 2024:

0001—General Fund

(1) Up to \$1,750,000 of the amount appropriated in Schedule (3), Item 0250-001-0001, Budget Act of 2022 (Chs. 43, 45 and 249, Stats. 2022), for implementation of the Community Assistance, Recovery, and Empowerment Act.

Add Item 0250-496 as follows:

0250-496—Reversion, Judicial Council. As of June 30, 2023, the balances specificed below, of the appropriations provided in the following citations shall revert to the balances in the funds from which the appropriations were made.

Addition of Budget Bill Item 0250-495, Capital Outlay, Judicial Branch

Monterey County: New Fort Ord Courthouse—It is requested that Item 0250-495 be added to revert \$25 million in savings from the acquisition phase of the Fort Ord courthouse project (see Attachment 1). The full amount of funding for the acquisition phase from the 2021 Budget Act appropriation is not needed because the land will be donated to the Judicial Branch instead of being purchased. Approximately \$10.6 million of the original appropriation will be retained to conduct necessary evaluations of the site, to bring various utility connections to the site, and to draft and execute documents related to the transfer.

Amendment to State Retirement Contributions to the Judges' Retirement System II, Support and Local Assistance, Judges' Retirement System

It is requested that state retirement contributions to the Judges' Retirement System (JRS) II, be increased by a total of \$2,188,000 ongoing. These changes comply with the statutory requirement per Government Code section 75600.5, that the state retirement contribution to JRS II be appropriated based on the contribution rate submitted by the California Public Employees' Retirement System (CalPERS) Board of Administration. On February 14, 2023, the CalPERS Board approved a JRS II contribution rate of 23.58 percent for 2023-24, up from the 23.23 percent rate in 2022-23. The contribution rate increase is due mainly to the amortization of the unfunded accrued liability generated by investment losses in fiscal year 2021-22.

Amendment to and Addition of Various Budget Bill Items and Reimbursements, Support and Local Assistance, and Statutory Changes, Governor's Office of Business and Economic Development

Local Economic Development Plan (SB 846)—It is requested that Item 0509-001-0001 be increased by \$10 million one-time for local economic development efforts pursuant to Chapter 239, Statutes of 2022 (SB 846). It is also requested that provisional language be added to allow the funds to be available for encumbrance or expenditure until June 30, 2027 (see Attachment 1).

Outsmart Disaster Program—It is requested that Item 0509-001-0001 be amended to increase reimbursement authority by \$350,000 one-time to allow the Office of the Small Business Advocate (CalOSBA) to administer a federal grant, in coordination with the California Academy for Economic Development, for the Outsmart Disaster Program. This program is a statewide awareness campaign focused on providing California businesses and communities with the resources they need to adequately prepare for and recover from all types of disasters and business interruptions.

State Small Business Credit Initiative Technical Assistance Program—It is requested that Item 0509-001-0890 be increased by \$25.3 million one-time, to be spent over five years, for CalOSBA to provide technical assistance to small businesses, including businesses owned by socially and economically disadvantaged individuals, applying for State Small Business Credit Initiative capital programs. It is also requested that provisional language be added to allow the funds to be available for encumbrance or expenditure until June 30, 2028 (see Attachment 2).

Small Agricultural Business Relief Grants—It is requested that Item 0509-102-0001 be increased by \$25 million one-time to expand the existing California Small Agricultural Business Drought Relief Grant Program to provide direct assistance to eligible agriculture-related businesses that have been affected by recent storms. It is requested that provisional language be added to allow the funds to be available for

encumbrance or expenditure until December 30, 2024 (see Attachment 3). It is also requested that statutory changes be made to expand the existing program to include a round of grants for these businesses. The statutory changes will be posted on the Department of Finance website.

City of Fresno Public Infrastructure Plan—It is requested that provisional language be added to Item 0509-101-0001 to allocate \$50 million in 2023-24 to support the City of Fresno's Public Infrastructure Plan to invest in the downtown area. This plan includes projects to build a High Speed Rail Station and parking structures, develop green space, improve walkability, and for water infrastructure. In total, this request includes \$50 million in 2023-24, and \$100 million in 2024-25 and 2025-26, to be allocated to the City of Fresno to support these efforts. It is also requested that provisional language be added to specify the use of these funds in Item 0509-101-0001 (see Attachment 4).

Local Government Budget Sustainability Fund Program—It is requested that provisional language be amended in Item 0509-101-0001 to reduce the amount available for this program to \$50 million in 2023-24 (see Attachment 5). This request also reduces the amount available for this program by \$100 million in 2024-25 and 2025-26.

Immigrant Integration and Economic Development Grants Reappropriation—It is requested that Item 0509-490 be added to reappropriate up to \$2 million available in the 2022 Budget Act for competitive grants to service providers to develop export training programs and curriculum aimed at underserved business owners. It is also requested that these funds be available for encumbrance or expenditure until June 30, 2025 (see Attachment 6). The 2022 Budget Act inadvertently did not include an extended period of availability for this funding that would have aligned this grant program with the related competitive grants to local governments included in the Immigrant Integration and Economic Development proposal.

Technical Statutory Changes to Extend Program Sunset Dates—It is requested that statutory changes be made to extend the sunset dates for several grant programs administered by CalOSBA to allow additional time to award grants and for program closeout activities. The requested statutory changes will be posted on the Department of Finance website.

Reduction of 2023-24 Appropriation—It is requested that Item 0509-112-0001 be reduced by \$25 million one-time for financing for clean energy transmission projects. The Governor's Budget reduced this appropriation in Control Section 4.07. This is a technical adjustment to shift the reduction from the statewide control section to an item in the department's budget. It is also requested that provisional language be amended to reflect this reduction (see Attachment 7).

Restoration of Funding for the Climate Catalyst Fund for Forest Resilience Projects—It is requested that \$25 million be restored from the proposed reversion included in the Governor's Budget for the Climate Catalyst Fund to support Forest Resilience Projects. The Governor's Budget included a total reversion of \$41 million for these projects in Control Section 4.06. This request restores \$25 million to support additional forest resilience projects that are in the final stages of the review process. This brings the total

proposed reversion to \$16 million (see Attachment 7). This action also conforms to the May Revision proposals to delete Control Section 4.07 and to amend Control Section 3.94.

Reversion of 2021 Balances—It is requested that Item 0509-495 be added to revert the unexpended balance of appropriations made for the California Small Business COVID-19 Relief Grant Program in the 2021 Budget Act. As a result of lower revenue projections and a resulting increase in the budget problem, the May Revision proposes adjustments to this program to assist in closing the projected shortfall and ensuring the submission of a balanced budget plan. The Governor's Budget also included a reversion of \$92 million for this program, bringing the total proposed reversion to \$142 million for this program (see Attachment 8).

Technical Adjustment to Shift Reversion of 2021 and 2022 Balances—It is requested that Item 0509-495 be added to revert the unexpended balance of appropriations made in the 2021 and 2022 Budget Acts. The Governor's Budget reverted these funds in statewide Control Section 4.06. This is a technical adjustment to provide transparency at the department level by shifting reversions from the statewide control section to the applicable department budget (see Attachment 8).

Amendment to Budget Bill Item 0521-131-0001 and Addition of Item 0521-131-0042, Local Assistance, California State Transportation Agency

California State Transportation Agency (CalSTA): Reduction of 2023-24 Appropriation (Ports and Goods Movement)—It is requested that Item 0521-131-0001 be reduced by \$550 million one-time to reflect a shift in the source of funding for ports and goods movement projects. The Governor's Budget reduced various items of appropriations in the 2023-24 fiscal year in Control Section 4.07. Of the total adjustment requested for this item, \$400 million is a technical adjustment to provide transparency at the agency level by shifting the reductions from the statewide control section to items of appropriation in the applicable departmental budgets.

Additionally, \$150 million of the total adjustment requested for this item is a result of lower revenue projections and a resulting increase in the budget problem, the May Revision proposes a further reduction to this item to assist in closing the projected shortfall and ensuring the submission of a balanced budget plan. It is also requested that Item 0521-131-0042 be increased by \$150 million to offset the General Fund reduction and shift the funding appropriation to the State Highway Account, State Transportation Fund.

Preschool Development Grant Authority Increase (Issue 061)—It is requested that Item 0530-001-0890 be increased by \$4,684,000 one-time federal funds from the Preschool Development Grant Fund that supports early childhood services for children birth to age five. This program supports needs assessment, strategic planning, family engagement, quality improvement, workforce compensation and direct services for young children. CalHHS will use these contracting funds to provide overall grant implementation management with consultants and existing staff, analyses of services for quarterly state and federal reports, and coordination of cross-agency workgroup meetings.

California Emergency Medical Services Authority (Issue 062)—It is requested that Item 0530-001-9745 be increased by \$665,000 one-time from the California Health and Human Services Automation Fund and 3.0 ongoing positions to provide project management support to the Emergency Medical Services Authority for the California Emergency Medical Services Data Resource System Project planning efforts under the California Health and Human Services Agency. Technical Adjustment to Shift the Reduction of 2023-24 Appropriations (Various Climate and Resources Investments)—It is requested that Item 0540-001-0001 be reduced by \$15 million in 2023-24 for the Ocean Protection Council and Item 0540-101-0001 be reduced by \$115 million in 2023-24 for state-owned lands and urban greening (see Attachments 1 and 2). Additionally, it is requested that Item 0540-102-0001 be eliminated in 2023-24 and 2024-25 for Ocean Protection Council SB 1 Implementation. The Governor's Budget reduced various items of appropriations in the 2023-24 fiscal year in Control Section 4.07. Amendments to and Addition of Various Budget Bill Items and Reimbursements, Support and Local Assistance, and Statutory Changes, Office of Planning and Research

Information Technology Unit—It is requested that Item 0650-001-0001 be increased by \$5,347,000 and 15 positions ongoing to establish an information technology unit within the Office of Planning and Research (OPR). This request is necessary to support internal departmental oversight and administration of information technology needs.

Transition to State Civil Service Positions and Reductions to Governor's Budget Proposals—It is requested that Item 0650-001-0001 be reduced by \$2,001,000 and 10.0 positions in 2023-24, decreasing to \$1,544,000 and 10.0 positions in 2026-27 and ongoing, to address declining General Fund Revenues and to begin the process of transitioning OPR to a more traditional department with state civil service positions. Specifically, this request reduces the new proposals included in the Governor's Budget from a total of \$9.2 million and 26 positions to \$7.2 million and 16 positions, of which 13 will be established as civil service positions. This request adjusts the following Governors Budget proposals: California Climate Adaptation Strategy, General Plan Guidance Updates, Legislative and Legal Staffing, CEQANet, Tribal Liaison, and the Statewide Extreme Heat Ranking System, and the Racial Equity Commission and Youth Empowerment Commission.

Technical Adjustment to Shift the Reversion of 2021 and 2022 Balances—It is requested that Item 0650-495 be added to include reversions related to the specified balances of appropriations made in the 2021 and 2022 Budget Acts (see Attachment 1). The Governor's Budget reverted these funds in statewide Control Section 4.06. This is a technical adjustment to provide transparency at the department level by shifting the reversions from the statewide control section to the applicable departmental budget.

Reversion of 2022 Balances—It is requested that Item 0650-495 be added to revert the unexpended balance of an appropriation made for the Regional Climate Resilience Program in the 2022 Budget Act (see Attachment 1). As a result of lower revenue

projections and a resulting increase in the budget problem, the May Revision proposes adjustments to the Regional Climate Resilience program to assist in closing a projected shortfall and to ensure the submission of a balanced budget plan.

Technical Adjustment to Shift the Reduction of 2023-24 Appropriations—It is requested that Item 0650-001-0001 be reduced by \$40 million one-time, and Item 0650-101-0001 be reduced by \$235 million one-time. The Governor's Budget reduced various items of appropriations in the 2023-24 fiscal year in Control Section 4.07. This is a technical adjustment to provide transparency at the department level by shifting the reductions from the statewide control section to items of appropriation in the applicable departmental budgets. It is also requested that provisional language be removed to reflect these changes (see Attachments 2 and 3).

Reduction of 2023-24 Appropriations—It is requested that Item 0650-001-0001 be reduced by \$100 million one-time for the Transformative Climate Communities program. It is also requested that Item 0650-101-0001 be reduced by \$75 million in 2023-24 and \$85 million in 2024-25 for the Community Resilience Centers grant program. As a result of lower revenue projections and a resulting increase in the budget problem, the May Revision proposes adjustments to these programs to assist in closing the projected shortfall and to ensure the submission of a balanced budget plan.

Office of Local Defense Community Cooperation Federal Grant—It is requested that Item 0650-001-0001 be amended to reflect increased reimbursement authority of \$500,000 one-time to account for an anticipated federal Office of Local Defense grant award. Reimbursement authority is necessary given that OPR is expected to be a subrecipient of this federal grant awarded to the University of California, Davis.

U.S. EPA Environmental Justice Government to Government Grant—It is requested that Item 0650-101-0890 be increased by \$350,000 in 2023-24, and \$400,000 in 2024-25 and 2025-26, to account for an anticipated federal United States Environmental Protection Agency Environmental Justice Government-to-Government grant award. This funding will be used to partner with community-based organizations within disproportionately impacted areas to pilot activities that address climate change, disaster resiliency, and emergency preparedness.

Various Statutory Changes—It is requested that the following statutory changes be made. The requested statutory changes will be posted on the Department of Finance website:

- CEQA Lead Agency Exemption—Statutory changes to specify that OPR shall not be considered the lead/responsible agency for projects in which OPR awards funding to and in which the project is subject to the California Environmental Quality Act (CEQA) review. This change is necessary to promote impartiality on behalf of OPR for projects in which the department awards grants.
- Community Resilience Centers Advance Pay—Statutory changes to include the Community Resilience Centers within the statewide Advance Payment Pilot Program pursuant to Chapter 159, Statutes of 2022 (AB 156). This change is

necessary to fix a drafting error in AB 156, which referenced the incorrect section in statute.

Various Provisional Language Changes—It is requested that the following provisional language changes be made:

- Transformative Climate Community Administrative Carveout Increase—Add provisional language to Item 0650-001-0001 to increase the percentage available for administrative costs for the Transformative Climate Communities program, funded in the 2022 Budget Act, from up to 5 percent to up to 10 percent (see Attachment 2). This request is necessary to support additional technical assistance for local jurisdictions that intend to apply for federal grants that fund projects similar to the Transformative Climate Communities program.
- Youth Corps Program—Add provisional language to Item 0650-001-0001 to provide a set-aside for tribal communities, and to prioritize undocumented youth for participation in the youth workforce development program administered by California Volunteers (see Attachment 2). This request is necessary to promote tribal and undocumented youth participation within the program.
- Integrated Climate Adaptation Planning Program Set-Aside—Add provisional language to Item 0650-001-0001 to provide a set-side of funding for tribal communities and under resourced communities to promote participation within the Integrated Climate Adaptation Planning Grant Program.

Various Technical Adjustments—It is requested that Item 0650-101-0001 be increased by \$14 million one-time, and Item 0650-001-0001 be reduced by \$14 million one-time, to appropriately reflect limited-term funding for an extreme heat outreach campaign included in the 2022 Budget Act, which is administered by the Office of Community Partnerships and Strategic Communications.

Statewide Disaster Warehousing Operations—It is requested that Item 0690-001-0001 be increased by \$43,258,000 and 15 positions for ongoing resources to support northern and southern California emergency response warehousing operation, including funding for long-term leasing and operation of the Dixon warehouse and to procure the life-cycle management of personal protective equipment consistent with the state's SMARTER Plan. The resources will enable the Office of Emergency Services (Cal OES) to continue warehousing operations and have appropriate resources available across the state for all emergencies.

Gun Buyback Event—It is requested that Item 0690-001-0001 be increased by \$25 million one-time to reallocate to Cal OES the amount appropriated to the Board of State and Community Corrections in the 2022 Budget Act to support gun buyback competitive grant programs structured to reduce firearm violence. Amendment to and Addition of Various Budget Bill Items and Reimbursements, Support and Local Assistance, and Statutory Changes, Clean Energy Reliability Investment Plan—Various Departments.

This proposal includes resources for various departments related to implementing the Clean Energy Reliability Investment Plan (CERIP) prepared and adopted by the California Energy Commission and presented to the Legislature on March 1, 2023, pursuant to Chapter 239, Statutes of 2022 (SB 846). The CERIP supports programs and projects that accelerate the deployment of clean energy resources, support energy demand response, increase energy reliability, and assist ratepayers. This proposal allocates resources that were included in the Governor's Budget, but not yet distributed to the various departments, per the adopted CERIP.

CERIP Various Programs—It is requested that Item 3360-008-0001 be decreased by \$47 million in 2023-24, increased by \$400 million in 2024-25, and increased by \$495 million in 2025-26 to implement the CERIP. The decrease in 2023-24 reflects the adopted CERIP allocating \$53 million of the \$100 million available in 2023-24 to the California Energy Commission, with the remainder allocated as described below. It is also requested that statutory changes be added to effectuate the programs in the CERIP. This funding will focus on enabling investments, scaling demand-side and supply-side resources, and augmentations for extreme events (see Attachment 1).

CERIP Central Procurement Function—It is requested that Item 3860-001-0001 be increased by \$32 million in 2023-24 one-time and provisional language be added to implement the CERIP program to support the implementation of a central procurement function at the Department of Water Resources (see Attachment 2).

CERIP Energy Development, Permitting and Interconnection—It is requested that Item 0509-101-0001 be increased one-time by \$15 million in 2023-24, and \$5 million in 2025-26 and provisional language be added for the Governor's Office of Business and Economic Development to implement a CERIP program to address barriers throughout

the energy resource development process for local agencies, including navigating through permitting processes and requirements (see Attachment 3).

The effect of my requested actions is reflected on the attachment.

"3360-008-0001 – For support of State Energy Resources Conservation and Development Commission 205,000,000-158,000,000

Schedule:

- (1) 2380010-Power Plant Site Certification and Transmission Line Corridor Designation Program....... 105,000,000
- (2) 2390010-Renewable Energy.......100,000,000-53,000,000

Provisions:

- 1. The funds appropriated in this Item Schedule (1) shall be allocated as follows:
 - a. \$100,000,000 shall support the Clean Energy Reliability Investment Plan created in Chapter 239, Statutes of 2022 (SB 846).
 - b. \$95,000,000 shall be used to support incentives for demand side grid support and associated mitigation costs.
 - c. \$10,000,000 shall be used for administrative costs to support distributed electricity backup assets and utility scale assets including incentives for clean backup generation.
- 2. The funds appropriated in this item shall be available for encumbrance or expenditure by the State Energy Resources Conservation and Development Commission until June 30, 2027, and shall be available for liquidation until June 30, 2031

The funds appropriated in Schedule (2) shall be allocated as follows:

- a. \$33,000,000 shall be used to implement a Clean Energy Reliability Investment
 Plan program to support near-term electric system reliability through additional
 funding for the Demand Side Grid Support Program and the Distributed Electricity
 Backup Assets Program.
- b. \$10,000,000 shall be used for administrative costs to support implementation of the Clean Energy Reliability Investment Plan.
- c. \$8,000,000 shall be used to implement a Clean Energy Reliability Investment Plan program to improve processes and provide resources that support engagement and technical assistance for communities of concern.
- d. \$2,000,000 shall be used to implement a Clean Energy Reliability Investment Plan program for critical planning studies, such as Transmission Corridor Planning, and implementing recommendations in the permitting roadmap for offshore wind resources.
- 3. The funds appropriated in this Item shall be available for encumbrance or expenditure by the State Energy Resources Conservation and Development Commission until June 30, 2027, and shall be available for liquidation until June 30, 2031."

Add the following provision to Item 3860-001-0001:

4. Of the funds in this item, \$32,000,000 shall be used to support a Central Procurement Function for diverse clean energy resources. The funds shall be available for encumbrance or expenditure until June 30, 2028, and shall be available for liquidation until June 30, 2030. If a determination is made by the California Public Utilities Commission that the Department will not perform this function, the remaining funds in this provision shall be transferred to the California Energy Commission upon order of the Director of Finance.

Add Provision 2 to Item 0509-101-0001

2. Of the amount appropriated in Schedule (1), \$15,000,000 shall be used to address barriers throughout the energy resource development process for local agencies, including navigating permitting processes and requirements. Notwithstanding any other law, these funds may be transferred to Item 0509-001-0001 upon order of the Department of Finance. The funds shall be available for encumbrance or expenditure until June 30, 2026, and liquidation until June 30, 2028.
