Population Balancing Equation

- Last Year's (revised) Population
 - + Births
 - + Domestic In-Migrants
 - + International Immigrants
 - (authorized and unauthorized)
 - Deaths
 - Domestic Out-Migrants
 - Emigrants
 - = Current Population

How Do We Estimate Housing and Population?

- Sub-County Estimates use a Housing Unit Method (HUM)
 - $\circ~$ Housing units benchmarked to the latest decennial Census
 - Net change in housing units by type are collected through surveying all 482 cities and 58 counties in California
 - A Census/ACS derived vacancy rate and person per household are applied to yield a household population
 - The household population is controlled to the independently calculated county population estimate
 - Finally, the group quarters estimate is added to give a total population for each jurisdiction



Housing Unit Survey (HUS)

- We survey 482 cities and 58 counties for data at the city and unincorporated county level
 - \circ Building Departments
 - **O Planning Departments**
 - Community Development Departments
 - \odot Private Contractors hired by the City and County
- Most years we can expect a 100% participation rate



HUS Data Sources

Completed Housing Units

Completed between **1/1 – 12/31** based on Final Inspections, Certificates of Occupancy, Completion Certificates, or Utility Releases

Permits

Permits adjust estimate completions based on different time frames

ADUs & Single Family: Backdate 6 Months Multi-Family: Backdate Full Year

*Data source must be consistent with prior years for accurate estimates



Housing Categories

3 Categories

- 1. Single Family Housing Units
 - 3 Single Family Types
- 2. Multi-Family Housing Units
 - 2 Multi-Family Types
- 3. Accessory Dwelling Units (ADUs)
 - 2 ADU Types

Single Family Multi-Family unit structure attached to 2-4 Units: A structure with 2, 3, or 4 units 1. not classified as a single-unit attached structure, individual heating and plumbing 5+ Units: A structure with 5 or more 2. housing units. 2* Share attic space, and heating and plumbing systems four sides that often possesses an

3. Mobile Home Units: 1-unit structure originally constructed to be towed on its own chassis








2 Types of ADUs

1. **Attached:** Structure shares a wall and/or shares utility systems with the original housing unit

• Commonly shared utilities: water/sewer lines

2. **Detached:** Structure containing the ADU is a stand-alone structure with no shared walls to the original unit


- EX: Converted pool houses and detached garages
- EX: Mobile homes placed in the backyard of a Single Family unit





CA ADU Growth





2022 The highest ADU growth reported last year in the HUS with the addition of 20,683 ADUs.

How many Housing Units gained by category type

- Newly Constructed Units
- Converted Units Gained
- Non-Permitted Units Gained

How many Housing Units <u>lost</u> by category type

- Demolition, Fire, and other Natural Disaster
- Converted Units Lost
- Non-Permitted Units Lost

*Additional question added in 2022 asking units lost due to wildfires

How many Affordable Housing Units were <u>gained/lost</u> by category type



Group Quarters Estimate

- Military
- College Dormitories and Apartments
- County Jails, State and Federal Prisons
- State and Federal Veteran Homes
- State Hospitals
- Federal Job Corps Centers
- Other Group Quarters



Methods of GQ Data Collection

- Available GQ Reports
 - County jails, State and Federal prisons, juvenile institutions
 - \odot State Veteran Homes
 - \odot State Hospitals
 - \circ Federal Job Corps Centers
 - O University of California and California State University dormitories and apartments
- GQ Surveys
 - Military GQ and Family Military
 - \circ Federal Veteran Homes
 - \circ California Community Colleges



Civilian Group Quarters

- Non-household residential facilities
- Residents living in these facilities have no permanent residence elsewhere
- HUS focuses on availability of beds and facility changes (Annexed, Detached, Opened, Closed, or Changed)
- Between 2010 and 2020, this type increased from 38% to 46% of the total GQ population in California

Types of Group Quarters Facilities

- Nursing and convalescent homes
- Orphanages
- Shelters
- Convents
- Private dormitories
- Local facilities for the mentally and physically disabled.



GQ Collection and 2020 Census

- The COVID-19 lockdowns led to many difficulties in data collection
- Lockdowns began right when Census forms were sent out
- Confusing guidance with College Dorms
- Resulted in overcount of 18-24 Age Group



2020 GQ Benchmark

- New Method for Benchmarking GQ
- Hybrid Benchmark
- Combination of Census Results and Administrative Data
- "Other GQ" from Census
- Rest from Admin Data
