Biodiesel provisions include the use of in-use requirements to preclude NOx emissions, reporting and recordkeeping requirements. A premise for this rulemaking is to establish a remedy as a result of a court ruling on the Low Carbon Fuel Standard that found deficiencies related to the California Environmental Quality Act (CEQA) and the Administrative Procedures Act.
