Enclosed is the University of California's report of *Instruction and Research Space Summary and Analysis*, 2015-20. This report responds to the Legislative request set forth in the Education code as follows:

67502. (a) On or before November 1 of each year, the Regents of the University of California are requested to provide to the Joint Legislative Budget Committee and the Department of Finance a summary of all instructional and research space in the university system. The summary shall consist of campus-by-campus data indicating existing space available to each department of instruction and research, including a seven-year projection of space needs for departments of instruction and research. The data shall include, but not be limited to, classrooms, upper and lower-division class laboratories, teaching assistant offices, and faculty offices. The summary shall correlate assignable square foot capacities to full-time-equivalent student enrollments and faculty positions for both existing space and projected space needs.

The space analysis is based on space planning guidelines developed by the California Postsecondary Education Commission (CPEC) in 1990 to replace the 1955 CCHE/Restudy standards.

We are providing complete copies of the space analysis tables to Mr. Constantouros in your office and to the Department of Finance for use in their analysis of the University's capital program. Please let me know if you or members of the Joint Legislative Budget Committee wish to receive a copy of the report.

^{1.} Some of the "actual" classroom space (both current and projected) displayed in the table include interchangeable rooms that, under CPEC, would be classified as teaching laboratory space. However, Merced's Registrar's office schedules these spaces as classrooms (and are listed under "Classroom" category as a result) because their primary use is for class lectures, despite hosting numerous activities that are more associated with Teaching Labs. With Merced's use of interchangeable space, the space needs are better analyzed when combining the classroom and teaching laboratory categories. When combined, the Merced campus is at 83.87% of the allowed space by 2020 (see calculation below).

^{2.} Currently the ratio of graduate students to Principal Investigator (PI) is 2.3. In addition, on average there are slightly less than 1 research staff (non-academic appointments) per PI who work under the PIs in the laboratories, for a total of 3.3 research staff and graduate student to each PI. The space in excess of the allowed amount is due primarily to having sized the research laboratories to support 5 researchers (research staff+graduate students) in order to permit research productivity (grants) per PI to grow after 2020.
