# Addition of Budget Bill Items 0250-301-3037 and 0250-497, Capital Outlay, Judicial Branch

It is requested that Item 0250-301-3037, State Court Facilities Construction Fund, be added to provide \$7,237,000 for acquisition and preliminary plans for the Contra Costa County, New Antioch Area Courthouse project. This project will provide a four-room courthouse to meet courthouse needs in the Antioch area.

Also add provisional language to Item 0250-301-3037 as follows:

1. Notwithstanding any other provision of law, the Pittsburg-Delta court facility shall transfer to the state prior to the release of funds identified in Schedule (1) of this item.

It is requested that Item 0250-497 be added to revert \$619,000 of funds to the State Court Facilities Construction Fund. Item 0250-301-3037, Budget Act of 2004 (Chapter 208, Statutes of 2004) included funds for acquisition and preliminary plans for two projects: one trial court to serve Sierra and Plumas counties, and another to serve Placer and Nevada counties. The Administrative Office of the Courts conducted a study on each of these projects and has determined that these projects are not cost beneficial. More cost-appropriate alternatives are being explored, and until other options are developed, these funds should be reverted.

Amendment to Provision 2 of Budget Bill Item 0530-001-0632, Support; Addition of Budget Bill Item 0530-491, Reappropriation; and Trailer Bill Language, Health and Human Services Agency

Case Management Information and Payrolling System (CMIPS) Provisional Language (Issue 001)—It is requested that Item 0530-001-0632 be amended by replacing existing Provision 2 with the language included in Attachment A for the (CMIPS) project. The requested provisional language would allow funding for project implementation to be augmented once a vendor has been selected and a contract amount has been negotiated. The language will also ensure that the Department of Finance has the opportunity to provide oversight of the project by reviewing the contract with the selected vendor and the associated project documents.

Reappropriation of Project Funds (Issue 002)—It is requested that Item 0530-491 be added to reappropriate project resources required for expenditure in fiscal year 2005-06. The projects are proposed to be continued in the Health and Human Services Agency as part of the consolidation of the state's data centers.

The Governor's Budget proposes to consolidate the state data centers. Included in that proposal is a request to transfer several automation projects from the Health and Human Services Agency Data Center to the Health and Human Services Agency. The proposed reappropriation language should have been included in the Budget Bill as a part of the consolidation proposal. The language, outlined in Attachment B, is substantially similar to the language that was included in the 2004 Budget Act for the Health and Human Services Agency Data Center and conforms to language in the Department of Social Services' budget (Budget Item 5180-491). The purpose of the proposed language is to allow project funding to be reappropriated from one fiscal year to the following fiscal year so that the projects can maintain their overall level of approved funding while maintaining the flexibility required to manage evolving information technology projects.

Trailer Bill Language to Transfer the Systems Integration Division of the California Health and Human Services Agency Data Center to the California Health and Human Services Agency (Issue 003)—It is requested that the Trailer Bill language outlined in Attachment C be adopted to transfer the Systems Integration Division of the Health and Human Services Agency Data Center to the Health and Human Services Agency.

As part of the proposal to consolidate the state data centers, it is requested that several automation projects be transferred from the Health and Human Services Agency Data Center to the Health and Human Services Agency. The projects are large and complex, and they also require interaction among various departments. Placing the projects in the Health and Human Services Agency would enhance the ability to manage the complexities of the projects and ensure collaboration among the various departments involved. In order to effect this change, it is necessary to amend Government Code Section 12803.

(2) Notwithstanding any other provision of law, upon request of the Health and Human Services Agency, the Department of Finance may augment the amount available for expenditure in this item to pay for new contract costs for the In-Home Supportive Services/Case Management Payrolling System. The augmentation may be made no sooner than 30 days after notification in writing of the committee in each house of the Legislature that considers appropriations and the Chairperson of the Joint Legislative Budget Committee, or not sooner than whatever lesser time the chairperson of the joint committee may in each instance determine. The amount of funds augmented pursuant to the authority of this provision shall be consistent with the amount approved by the Department of Finance based on its review and approval of the new contract and Special Project Report, or equivalent document to be submitted at the conclusion of procurement activities.

#### Attachment B

Add the following language to new Item 0530-491:

0530-491--Reappropriation, Secretary for California Health and Human Services. The balance of the appropriation provided in the following citations is reappropriated for expenditure pursuant to Provision 1 and is available for encumbrance or expenditure until June 30, 2006: 0632 — California Health and Human Services Agency Center Revolving Fund (1) Item 4130-001-0632, Budget Act of 2004 (Ch. 208, Stats. 2004) Provisions:

1. It is the intent of this item to continue funding approved activities for the automation projects that, due to schedule changes, result in unexpended appropriations for one year and the need for additional funding in the following year. Therefore, notwithstanding any other provision of law, the balance of the appropriations for these automation projects may, upon approval of the Department of Finance, be reappropriated for transfer to and in augmentation of the corresponding items in this act. The funds reappropriated by this provision shall be made available consistent with the amount approved by the Department of Finance based on an approved special project report or equivalent document not sooner than 30 days after providing notification in writing to the chairperson of the fiscal committee of each house of the Legislature and the Chairperson of the Joint Legislative Budget Committee.

## Proposed Trailer Bill Language:

SEC. 4. Section 12803.3 is added to the Government Code to read:

41803.3(a) The Systems Management Services of the California Health and Human Services Agency Data Center is hereby transferred to the California Health and Human Services Agency, which is the successor to, and is vested with, all of the duties, powers, purposes, responsibilities, and jurisdiction of the Systems Management Services of the California Health and Human Services Agency Data Center.

- (b) No contract, lease, license, or any other agreement to which the Systems Management Services of the California Health and Human Services Agency Data Center is a party shall be void or voidable by reason of this section, but shall continue in full force and effect, with the agency assuming all of the rights, obligations, and duties of the Systems Management Services of the California Health and Human Services Agency Data Center. That assumption of rights, obligations and duties shall not in any way affect the rights of the parties to the contract, lease, license, or agreement.
- (c) All books, documents, records, and property of the Systems Management Services of the California Health and Human Services Agency Data Center shall be transferred to the agency.
- (d) Any officer or employee of the former Systems Management Services of the California Health and Human Services Agency Data Center shall be transferred to the agency. The status, position, and rights of any officer or employee of the Systems Management Services of the California Health and Human Services Agency Data Center shall not be affected by the transfer and all officers or employees shall be retained by the agency pursuant to the State Civil Service Act (Part 2 (commencing with Section 18500) of Division 5), except as to a position that is exempt from civil service.
- (e) On and after the effective date of this chapter, the balance of all money available for expenditure by the Systems Management Services of the California Health and Human Services Agency Data Center shall be transferred to the California Health and Human Services Agency.

It is requested that Item 0820-001-0001 be increased by \$9 million and 57.9 positions (54.9 personnel years) as follows:

- \$4,156,000 and 29.5 positions (28.0 personnel years) to handle increased medical malpractice/deliberate indifference cases received from the California Department of Corrections
- \$2,019,000 and 13.1 positions (12.4 personnel years) to address workload performed on behalf of the Department of Justice and the state
- \$2,235,000 and 15.3 positions (14.5 personnel years) to handle increased state and federal *habeas corpus* litigation
- \$1 million for a one-time purchase of laboratory equipment for the Bureau of Forensic Services
- A reduction of \$410,000 for the Registry of Charitable Trusts Program, which is proposed to be funded by the Registry of Charitable Trusts Fund

It is requested that Item 0820-001-0017 be decreased by \$3.8 million to align expenditure authority with available resources. This augmentation was included in the 2005-06 Governor's Budget to provide funding for the Department of Justice (DOJ) to collect and process information, fingerprints and fees associated with the hazardous materials endorsement provision of the USA PATRIOT Act, which is administered by the California Department of Motor Vehicles (DMV). As a result of implementation delays, the DMV must utilize a federal Transportation Security Administration agent to collect the information, thus removing the DOJ's involvement in this provision.

It is requested that Item 0820-001-0890 be increased by \$7,728,000 to reflect new and amended federal grant awards as follows:

- \$3,201,000 for the California Methamphetamine Strategy Program
- \$2,590,000 for the Threat, Analysis, Reporting, and Geographic Evaluation Tool information system
- \$1,981,000 for the Single-Point Information Collection and Evaluation System
- A reduction of \$44,000 for excess authority related to the National Sex Offender Registry program

It is requested that Item 0820-001-3087 be increased by \$913,000 and 6.6 positions (6.3 personnel years) for workload associated with the Unfair Competition Law (Proposition 64).

It is requested that Item 0820-001-3088 be increased by \$2,104,000 and 6.6 positions (6.3 personnel years) to address workload in the Registry of Charitable Trusts Program. It is further requested that the attached Trailer Bill Language be adopted to establish the Registry of Charitable Trusts Fund (Attachment I).

It is requested that Item 0820-001-9731 be decreased by \$9,996,000 as follows:

- A reduction of \$906,000 to align expenditure authority with available resources for the Registry of Charitable Trusts Program, which is proposed to be funded by the new Registry of Charitable Trusts Fund. Fees formerly collected as reimbursements will be deposited in the new Registry of Charitable Trusts Fund. The reduction to this Item is necessary because the reimbursement authority was inappropriately scheduled in the Legal Services Revolving Fund in the 2005-06 Governor's Budget.
- A reduction of \$9,090,000 to align expenditure authority with available resources. This
  augmentation was included in the 2005-06 Governor's Budget to reflect the DOJ's
  increased legal services billing rates. This augmentation exceeds the total level of
  authority needed, based on services that the DOJ expects to provide to its client
  agencies in fiscal year 2005-06.

It is requested that reimbursement authority be decreased by \$4 million to reflect the expiration of various Memoranda of Understanding and reductions in grant awards.

It is also requested that technical adjustments are approved to transfer \$270,000 from the Public Rights Division to the Division of Gambling Control to correct a posting error in the 2005-06 Governor's Budget, and redirect \$989,000 and 12.0 positions from the Division of Legal Support and Technology to the Executive Programs Division to consolidate and streamline the DOJ's training resources.

Amendment to Budget Bill Item 0840-001-0001 and Addition of Provisional Language to Budget Bill Item 0840-001-0001, Support, State Controller's Office

It is requested that Item 0840-001-0001 be increased by \$1,215,000 General Fund and 2.0 permanent and 1.0 one-year limited term positions be provided to install a web-based system that enables local governments to enter mandated cost claims directly into the Controller's database via the Internet, using electronic forms and digital signatures. This funding includes \$505,000 for ongoing costs and \$710,000 for one-time costs. This project will increase the accuracy of mandated cost claims and is expected to result in significant savings and cost avoidances for the state beginning in 2006-07.

It is requested that provisional language be added to Item 0840-001-0001. Participation in the Property Tax Postponement Program is expected to increase due to a higher income threshold and the abolishment of the Senior Citizens Homeowners Assistance Program. However, the extent of the increase cannot be accurately estimated at this time. Suggested Budget Bill language follows below.

Add the following provision to Item 0840-001-0001:

12. The Director of Finance may authorize expenditures in excess of the amount appropriated in this item by an amount necessary to fund unanticipated workload increases associated with increased participation in the Property Tax Postponement program. Expenditures pursuant to this authorization shall not be made prior to 30 days after the Department of Finance notifies the Joint Legislative Budget Committee of the amounts necessary or not sooner than such lesser time as the Chairperson of the Joint Legislative Budget Committee may determine.

# Amendment to Various Budget Bill Items and Reimbursements, Support, Board of Equalization

## Out-of-State Legal Representation—Issue 001

It is requested that the Board of Equalization's (Board) budget be increased by \$1,862,000, as follows:

- Item 0860-001-0001 be increased by \$1,430,000
- Reimbursements for Item 0860-001-0001 be increased by \$400,000
- Item 0860-001-0004 be increased by \$1,000
- Item 0860-001-0230 be increased by \$17,000
- Item 0860-001-0623 be increased by \$14,000

This action will provide the Board with resources to contract with outside counsel for representation in out-of-state legal cases. This funding will also allow the Board to hire 4.0 staff to monitor these contracts and to track the progress of the cases in question.

This request is necessitated by the fact that the Department of Justice has notified the Board that it will no longer represent the Board in out-of-state legal cases.

## Consumer Use Tax Section Revenue Augmentation—Issue 002

It is requested that the Board's budget be increased by \$415,000, as follows:

- Item 0860-001-0001 be increased by \$270,000 General Fund
- Reimbursements for Item 0860-001-0001 be increased by \$145,000

This action will allow the Board to add 7.0 two-year, limited-term positions to the Consumer Use Tax Section. Of the requested positions, 6.0 will be assigned to the Vehicle, Vessel and Aircraft Program. The Board states these positions will generate a benefit-to-cost ratio of 8.1 to 1 in 2005-06 and 21.3 to 1 in 2006-07. The remaining position will be assigned to the United States Customs Program. The Board states it will generate a benefit-to-cost ratio of 13.6 to 1 in 2005-06 and 32.7 to 1 in 2006-07.

The requested positions are expected to help address the tax gap by generating General Fund revenues of \$3.0 million in 2005-06 and \$6.1 million in 2006-07.

## Alternative Cigarette Tax Stamp Project Funding—Issue 003

It is requested that the Board's budget be decreased by \$4,495,000, as follows:

- 0860-001-0001 be decreased by \$516,000
- 0860-001-0004 be decreased by \$103,000
- 0860-001-0230 be decreased by \$1,292,000
- 0860-001-0623 be decreased by \$2,584,000

This action reflects savings associated with the information technology project that supports the new tax stamp. These savings are attributable to changes in the project scope stemming from a revised Special Project Report issued in 2004.
