Amendment to Government Code Sections 85802 and 83122, Support, Fair Political Practices Commission

It is requested that Government Code Sections 85802 and 83122 be increased by \$57,000 and \$409,000 respectively, to reverse the proposed Budget Balancing Reduction for the two statutory appropriations. These statutory appropriations were created by the voters through an initiative process related to the Political Reform Act. As such, we do not have the authority to reduce the appropriations without the approval of the voters.

Amendment to Budget Bill Item 8855-001-0001, Support, Bureau of State Audits
