**Amendment to Budget Bill Items 8570-001-0001 and 8570-001-0890, Support,
California Department of Food and Agriculture**

It is requested that Item 8570-001-0890 be increased by \$1.0 million and 2.0 temporary positions, and that Item 8570-001-0001 be amended to reflect this change. This will provide an increase in authority for federal funds for the Asian Citrus Psyllid (ACP) Project. This funding is critical to detect, eradicate, and control the ACP, a vector of Huanglongbing citrus disease, which places California's citrus industry at risk. If the ACP is not addressed, California citrus production costs will increase, quarantines on citrus nurseries will be imposed, and additional pesticides will be forced into the environment. The California Department of Food and Agriculture entered into a cooperative agreement with the United States Department of Agriculture to receive \$4,474,152 in federal funding for the ACP Project, and \$3,474,152 has been proposed for expenditure in fiscal year 2008-09 through a Section 28 application.

Amendment to Budget Bill Item 9620-001-0001, Support, Payment of Interest on General Fund Loans

It is requested that funding for Item 9620-001-0001 be increased by \$50.0 million (from \$100.0 million to \$150.0 million) to cover anticipated General Fund internal cash flow borrowing costs. It is also requested that this Item be revised by adding provisional language to include costs associated with the issuance, or consideration of issuance, of registered warrants (IOUs), and late payment penalties incurred by the State Controller's Office in the event General Fund payments must be delayed due to a cash shortage (Attachment 1).

For your information, it is estimated that General Fund external cash flow borrowing costs will increase by \$250.0 million (from \$350.0 million to \$600.0 million) in the 2009-10 fiscal year.

Add the following provision to Item 9620-001-0001:

- X. In the event that the Controller must implement a payment delay plan to manage emergency cash needs with the concurrence of Department of Finance, there is hereby appropriated any amount necessary, in excess of the amount appropriated by this item, to pay the interest expenses, late payment penalties, and other costs incurred by the Controller which, as approved by the Department of Finance, are necessary to implement the payment delay plan. Amounts appropriated pursuant to this provision shall be transferred, upon approval of the Department of Finance, to augment Item 0840-001-0001 of this act. Funds appropriated by this item shall not be transferred or expended prior to 30 days after the Department of Finance notifies the Joint Legislative Budget Committee of the amounts necessary or not sooner than such lesser time as the Chairperson of the Joint Legislative Budget Committee may determine.

Amend the following provision to Item 9620-001-0001:

- "3. In the event that Revenue Anticipation Warrants (RAWs) or Registered Warrants (IOUs) are issued, or considered to be issued, there is hereby appropriated any amount necessary, in excess of the amount appropriated by this item, to pay the expenses incurred by the Controller, Treasurer, Attorney General, and the Department of Finance in providing for the preparation, sale, issuance, advertising, legal services, credit enhancement, liquidity facility, or any other act which, as approved by the Department of Finance, is necessary for such issuance. Funds appropriated by this item shall not be expended prior to 30 days after the Department of Finance notifies the Joint Legislative Budget Committee of the amounts necessary or not sooner than such lesser time as the Chairperson of the Joint Legislative Budget Committee may determine."
