**Addition of Various Budget Bill Items, Local Assistance and Capital Outlay, California Tahoe Conservancy**

**Lake Tahoe Environmental Improvement Program**

It is requested that Item 3125-490 be added to extend the liquidation period of various bond funded Environmental Improvement Program (EIP) local assistance grants (see Attachment I).

It is also requested that Item 3125-491 be added to extend the liquidation period of various bond funded EIP capital outlay projects (see Attachment II).

The EIP is an agreement between California, Nevada, the federal government, and local governments. The program identifies acquisitions, wetland restoration projects, and water quality improvement projects to enhance and improve environmental quality in the Lake Tahoe Basin. Bond funds appropriated in previous Budget Acts have been encumbered for specific EIP projects. However, because of the Pooled Money Investment Board's decision to suspend interim financing for bond funded projects, the California Tahoe Conservancy (Conservancy) is unable to fully liquidate the encumbered amounts. Therefore, it is necessary to extend the liquidation periods to allow the Conservancy to fulfill its obligations for bond funded projects once disbursements are able to commence.

**Amendment to Budget Bill Item 3340-001-0318, Support, California Conservation Corps  
Emergency Response Expenditure Authority**

It is requested that Item 3340-001-0318 be amended by adding Budget Bill language to revise Provision 2, which authorizes the Department of Finance (Finance) to augment the Collins-Dugan California Conservation Corps (Corps) Reimbursement Account to reflect increases in Reimbursements from other state agencies without a Section 28.50 notification letter. This proposal would expand Finance's authority to augment the Corps expenditure authority in two ways: (1) by allowing increases pursuant to Section 28.00 as well as Section 28.50 without a letter, and (2) by expanding the sources of additional Reimbursements to include local governments, the federal government, and nonprofit organizations. The expanded sources of funds would only be allowed when the reimbursing entity has requested emergency services from the Corps. (See Attachment I.) This proposal will allow the Corps to respond to service requests from all state and non-state agencies without delay, which is critical in emergency response situations.

**Amendment to Various Budget Bill Items, Support and Local Assistance, Department of Conservation**

**Land Resource Protection Program**

It is requested that Item 3480-001-0141 be decreased by \$1,382,000, Item 3480-001-0867 be increased by \$500,000 and that Item 3480-001-0001 be amended to reflect these changes, and Item 3480-101-0867 be decreased by \$1.0 million. These actions are necessary to address declining revenues in the Soil Conservation Fund, which generates revenue from Williamson Act cancellation fees. Because of the decline of the real estate market over the past year, there has been a significant decrease in housing and commercial development throughout the state. Consequently, the demand to develop on farmland has declined and reduced the number of Williamson Act contract cancellations. This proposal will make necessary reductions to the administration of the Williamson Act, the California Farmland Conservancy Program, the Farmland Mapping and Monitoring Program, and the Statewide Watershed Program to align expenditures with available revenues.

Additionally, it is requested that Item 3480-101-0005 be decreased by \$11,000 to accurately reflect the amount that is available in the Proposition 12 bond allocation for farmland conservancy grants.

**Information Technology Infrastructure Lifecycle Support**

It is requested that Item 3480-001-0133 be increased by \$80,000, Item 3480-001-0336 be increased by \$13,000, Item 3480-001-3046 be increased by \$39,000, and Item 3480-001-0001 be amended to reflect these changes to provide funding for information technology infrastructure maintenance. This proposal is necessary to enable the Department of Conservation to maintain the useful life of its information technology network and equipment.

**Amendment to and Addition of Various Budget Bill Items and Reimbursements, Support and Local Assistance, Department of Forestry and Fire Protection**

**California Emergency Management Agency Coordinator**

It is requested that Item 3540-001-0001 be amended by increasing Reimbursements by \$155,000 to enable the Department of Forestry and Fire Protection (CAL FIRE) to receive Emergency Response Initiative funding from the California Emergency Management Agency (Cal-EMA) to provide additional dispatching services at Cal-EMA's Emergency Command Center. CAL FIRE's current dispatching staffing level is insufficient to provide adequate year-round support.

**Mobile Command Center Prototype**

It is requested that Item 3540-001-0001 be amended by increasing Reimbursements by \$1,350,000 to enable CAL FIRE to receive a grant from Cal-EMA to build a prototype Mobile Communications Center (MCC). CAL FIRE uses a MCC as the communications hub at an emergency incident as well as the back-up system for its stationary Emergency Command Centers. The new MCC will allow CAL FIRE to provide MCC coverage for the South Coast region.

**Fuels Treatment: Federal Grant**

It is requested that Item 3540-001-0890 be increased by \$3,261,000 and that Item 3540-001-0001 be amended to reflect this change to enable CAL FIRE to receive a fuel treatment grant from the U.S. Forest Service. This grant is being provided in response to the recent wildfires in California, and CAL FIRE will only be able to use the funds for fuel treatment projects in San Bernardino, Riverside, and San Diego counties, as well as areas affected by the Fire Siege of 2008.

**Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance,  
Department of Fish and Game**

**Facilities Health and Safety Compliance**

It is requested that Item 3600-001-0200 be increased by \$741,000 and that Item 3600-001-0001 be amended to reflect this change to enable the Department of Fish and Game (DFG) to enter into a lease at a new facility. The facility currently leased by the DFG in San Diego is not in compliance with the Americans with Disabilities Act, seismic and energy efficiency requirements, and is also insufficient to house existing staff.

**Environmental Review Support**

It is requested that Item 3600-001-0001 be amended by increasing Reimbursements by \$500,000 to allow the DFG to enter into contracts with Sempra Energy, Tejon Ranch, and the Orange County Transportation Authority. This proposal will provide environmental expertise to these entities and accelerate the permitting process.

**Bond Fund Realignment**

It is requested that Item 3600-001-0005 be decreased by \$542,000 Item 3600-001-0404 be decreased by \$58,000 and that Item 3600-001-0001 be amended to reflect these changes. The reduction to the Safe Neighborhood Parks, Clean Water, Clean Air, and Coastal Protection Bond Act of 2000 (Fund 0005) is necessary because funding for certain land conservation, habitat acquisition, and non-native vegetation removal programs expires at the end of fiscal year 2008-09, but the funding was erroneously left in the February 2009 Budget Act. The Safe, Clean, Reliable Water Supply Act of 1996 (Fund 0404) reduction is necessary because funding for fish and wildlife restoration activities consistent with the Central Valley Project Improvement Act has been exhausted, but was not entirely removed from the February 2009 Budget Act.

It is also requested that Item 3600-497 be added to revert \$10.0 million of Water Security, Clean Drinking Water, Coastal and Beach Protection Act of 2002 (Proposition 50) bond funds (see Attachment 1). Proposition 50 funding for the Bay-Delta Ecosystem Restoration Program has been over-subscribed by this amount, making the reversion necessary.

**Delta Fish Agreement**

It is requested that Item 3600-001-0001 be amended by increasing Reimbursements by \$1.0 million to enable the DFG to receive funds from the Department of Water Resources (DWR) to implement the Delta Fish Agreement 2008 Amendment, which requires environmental restoration work to offset direct fish losses that result from pumping in the Delta. The 2008 Amendment mitigation actions include monitoring, restoration of aquatic and seasonally flooded wetland habitats, and other habitat restoration. Funding will be provided by the DWR from State Water Project funds.

**Ecosystem Water Quality**

It is requested that Item 3600-001-0001 be amended by increasing Reimbursements by \$7,596,000 to enable the DFG to receive funds from the DWR to implement Ecosystem Restoration Program projects that will improve water quality. Two of the main water quality problems in the Delta are low levels of dissolved oxygen and methyl mercury discharges. The DFG has identified a number of projects to address these issues. Funding will be provided by the DWR from State Water Project funds.

**Technical Budget Adjustments**

It is requested that Item 3600-001-0320 be increased by \$880,000 and that Item 3600-001-0001 be amended to reflect this change. It is also requested that Item 3600-101-0320 be decreased by \$880,000 and that a series of intra-schedule transfers be made to ensure funds are budgeted in the appropriate program categories. A limited-term augmentation to the Oil Spill Prevention and Administration Fund local assistance item was inadvertently taken out of the state operations support item, and this proposal will make the necessary technical correction. The intra-schedule transfers are part of the DFG's ongoing reorganization effort to better align budgeted resources with specific programmatic activities. This proposal will not result in a change to the DFG's operations.

#### **General Fund Reversion—Wetland and Riparian Habitat Conservation Projects**

It is requested that Item 3640-495 be added to revert \$1,535,000 General Fund. (See Attachment I.) These funds were appropriated in the 2006 Budget Act for the California Riparian Habitat Conservation Program and the Inland Wetlands Conservation Program. Because of the significant fiscal constraints on the General Fund, this action is necessary.

#### **Reappropriation and Extension of Liquidation for Various Funds**

It is requested that Item 3640-491 be added to reappropriate the unencumbered balances from: (1) the Habitat Conservation Fund (HCF), (2) the Wildlife Restoration Fund, and (3) a fund transfer from Water Security, Clean Drinking Water, Coastal and Beach Protection Act of 2002 (Proposition 50) funds to the HCF provided in the Budget Acts of 2006 and 2008. **Amendment to and Addition of Various Budget Bill Items and Reimbursements, Capital Outlay, State Coastal Conservancy**

**Increase of Reimbursement Authority**

It is requested that Reimbursements be increased by a total of \$6.2 million and that Items 3760-301-0262, 3760-301-0371, 3760-301-0593, 3760-301-6051, and 3760-301-6076 be amended to reflect these changes. The State Coastal Conservancy (Conservancy) frequently implements its capital outlay projects in partnership with other state, local, and non-profit entities and requires these entities to provide cost-share matching funds. This proposal will provide the necessary reimbursement authority to enable the Conservancy to collect funds from its project partners in fiscal year 2009-10.

**Reversion: Proposition 50 Funds**

It is requested that Item 3760-495 be added to revert \$500,000 Water Security, Clean Drinking Water, Coastal and Beach Protection Act of 2002 (Proposition 50) funds. The funds were appropriated in the Budget Act of 2006 for Conservancy programs. It is necessary to revert the funds to support the Conservancy's approved 2009-10 baseline budget. (See Attachment I)

**Technical Correction: Proposition 84**

It is requested that Item 3760-301-6051 be amended to accurately reflect the appropriate Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006 (Proposition 84) allocations for Conservancy programs. Proposition 84 allocates a total of \$450.0 million for multiple Conservancy programs. Various Budget Acts have appropriated most of the Proposition 84 funds to the Conservancy. Chapter 1, Statutes of 2007, Second Extraordinary Session (SB 1), appropriated an additional \$10.0 million Proposition 84 funds to the Conservancy for the Santa Ana River Parkway Program. Because of this legislative appropriation, this technical correction is necessary to avoid the Santa Ana Proposition 84 allocation from being oversubscribed. After the technical correction, the total amount available for Conservancy programs in 2009-10 will remain the same.

**Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance,  
Department of Parks and Recreation**

**Technical Adjustments: Reappropriations and Baseline Reductions**

It is requested that Item 3790-490 be added to reappropriate: (1) \$3,074,000 General Fund and \$876,000 Off-Highway Vehicle Trust Fund (OHV Fund) for the public safety dispatch system improvement project, and (2) \$5.6 million OHV Fund grants. (See Attachment I.)

Due late enactment of the 2008 Budget Act, the Department of Parks and Recreation (Parks) was unable to release the Request for Proposal to purchase the hardware, software, and license agreements necessary for its public safety dispatch system upgrade. Also, the late budget enactment delayed Parks' ability to enter into grant and cooperative agreements for OHV route designation planning and implementation projects as originally scheduled. Therefore, it is necessary to reappropriate these funds to enable Parks to continue the upgrade of its public safety dispatch system and OHV projects.

It is also requested that Item 3790-001-0001 be decreased by \$1,420,000 and Item 3790-001-0263 be decreased by \$333,000. This baseline adjustment is necessary to reflect the removal of one-time costs, and is consistent with the multi-year expenditure plan for the public safety dispatch system upgrade project.

**Extension of Liquidation: Various Bond Funds**

It is requested Item 3790-492 and 3790-494 be added to extend the liquidation periods of various bond funds for support and local assistance projects. (See Attachments II and III respectively.)

Bond funds appropriated in previous Budget Acts have been encumbered for specific projects under Parks' support and local assistance programs. However, because of the Pooled Money Investment Board's decision to suspend interim financing for bond funded projects, Parks will be unable to fully liquidate the encumbered amounts prior to the close of their liquidation periods. Therefore, it is necessary to extend the liquidation periods to allow Parks to fulfill its obligations for bond funded projects.

### **Proposition 12 Funding for Local Park Grants**

It is requested that Item 3790-101-0005 be added in the amount of \$39,795,000 to provide funding from the Safe Neighborhood Parks, Clean Water, Clean Air, and Coastal Protection Bond Act of 2000 (Proposition 12) for existing local park projects currently under construction. (See Attachment IV.)

The Budget Acts of 2000 and 2001 provided Proposition 12 funds to specific local parks projects. However, Proposition 12 specifies that grant funds shall be reverted commencing in fiscal year 2009-10 if the funds have not been expended by the grant recipients. Because of this statutory reversion requirement, it is necessary to provide Parks with a new appropriation, instead of an extension of liquidation period to fund these existing local park projects that are already underway.

It is also requested that Item 3790-497 be amended to revert a 2001 Proposition 12 appropriation for non-motorized trail grants. (See Attachment V.) This proposed reversion was inadvertently excluded from the Budget Act of 2009.

**Amendment to and Addition of Various Budget Bill Items, Support, Local Assistance, and Capital Outlay, Department of Water Resources**

**Realignment of Positions and Funds: Central Valley Flood Protection Board**

It is requested that Item 3860-001-0001 be amended to reflect the proper alignment of positions and funding that support the Central Valley Flood Protection Board (Board). Specifically, \$2,190,000 and 11.0 positions will be shifted from Program 35—Central Valley Flood Protection Board to Program 30—Public Safety and Prevention of Damage. This technical proposal is consistent with a Memorandum of Agreement that defines the programmatic and administrative relationship between the Board and the Department of Water Resources (DWR). Funding and staff that are dedicated to flood control projects such as FloodSAFE and the Early Implementation projects will remain under DWR's Flood Projects Office.

**Salton Sea Conservation Implementation**

It is requested that Item 3860-001-0001 be amended by increasing Reimbursements by \$8.0 million. The DWR is under contract with the Department of Fish and Game and the Wildlife Conservation Board to support the state's obligations for Salton Sea restoration, mitigation, and monitoring activities as a result of the Colorado River Quantification Settlement Agreement. This proposal will allow this work to continue through fiscal year 2009-10.

**Groundwater Storage Grant Program**

It is requested that Item 3860-101-6025 be added in the amount of \$218,000 to provide the balance of funding owed under two Groundwater Storage Grant Program contracts. Although the DWR only recently received the invoices for this work, the funds available for payment were unintentionally reverted on June 30, 2007. Since the claims are valid, it is necessary to make funds available to pay them.

**Federal Funding for Floodplain Mapping**

It is requested that Item 3860-001-0890 be increased by \$5,320,000 and that Item 3860-001-0001 be amended to reflect this change, to enable the DWR to receive grants to continue floodplain mapping activities. The DWR received a notice from the Federal Emergency Management Agency in February 2009 that these grant funds were available to support the DWR's Central Valley Floodplain Evaluation and Delineation Project, with potential for additional funding in subsequent years. The DWR is concurrently submitting a Section 28.00 request for this funding as it anticipates receipt of funding towards the end the current fiscal year.

**Supervision of Safety of Dams**

It is requested that Item 3860-001-3057 be increased by \$300,000 and that Item 3860-001-0001 be amended to reflect this change, to enhance the Dam Safety Program. This proposal will enable the DWR to install additional strong motion instruments on high hazard dams and reconvene the Earthquake Analysis Board.

**Delta Fishery Improvements**

It is requested that 4.0 positions be established to evaluate cost-effective fish facility improvement alternatives at State Water Project facilities and comply with the requirements of the National Marine Fisheries Biological Opinion. These positions will be funded within existing resources of the State Water Project.

**Delta Fish Agreement 2008 Amendment**

It is requested that 4.0 positions and 1.0 temporary help position be established to implement mitigation actions for Delta smelt, longfin smelt, and winter and spring-run salmon as required by the Delta Fish Agreement 2008 Amendment. These activities are necessary to comply with various federal permit requirements and a current court judgment against the State Water Project.

**South Sacramento County Streams**

It is requested that Item 3860-301-6052 be increased by \$4,258,000 and Reimbursements be increased by \$1,742,000 to continue construction of the South Sacramento County Streams project. This funding is necessary to address project cost increases for environmental mitigation, hydraulic reevaluation and design changes, inflation, and schedule adjustments.

**Sutter Bypass East Borrow Canal: Water Control Structures Project**

It is requested that Item 3860-301-6052 be increased by \$3,992,000 to continue construction of the Sutter Bypass East Borrow Canal project. This funding is necessary to address project cost increases for changes in foundational designs, environmental mitigation requirements, and access requirements for adjacent property owners.

### **Reappropriation of Various Capital Outlay Projects**

It is requested that Item 3860-490 be added to reappropriate funding for the following projects:

- Upper Sacramento Area Levee Reconstruction: This project was delayed due to design changes, environmental constraints, and modifications to the project due to unforeseen levee deficiencies.
- Merced County Streams, Castle Dam Unit-Construction: This project was delayed due to funding constraints of the Federal Army Corps of Engineers (Corps).
- Lower Sacramento Area Levee Reconstruction: This project is physically complete, but reappropriation is needed for various activities including final accounting with the Corps and locals, completion of operations and maintenance manuals, and turnover of the completed project works to local agencies.
- Tehama Section 205 Flood Control Project: This project is physically complete but reappropriation is needed for various activities including final accounting with the Corps and locals.
- American River Watershed, Folsom Dam Raise, Bridge Element: This project was delayed due to procurement issues experienced by the Corps and difficulties during construction. The project is nearing completion and expected to be open for traffic in 2009.
- American River Flood Control Project (Natomas Features): This reappropriation is necessary to enable the state to reimburse the local sponsor for the state's share of costs that the Corps determines to be eligible for two of the three phases of this project.

These projects have been delayed for the reasons noted above, therefore reappropriation is requested (see Attachment A).

### **Extension of Liquidation, Capital Outlay**

It is requested that Item 3860-491 be added to extend the liquidation period for the Merced County Streams Project. This flood control project has been delayed due to funding constraints of the Corps (see Attachment B).

Some of these items were included in Budget Change Proposals as part of the 2009-10 Governor's Budget, and approved by the Legislature, but were inadvertently left out of the February 2009 Budget Act. These reversions are necessary to maintain DWR's expenditures within the amounts authorized in various bond allocations (see Attachment E).

### Technical Adjustments

It is requested that Item 3860-101-0544 be eliminated. It is also requested that Item 3860-001-0404 be reduced by \$869,000 and that Item 3860-001-0001 be amended to reflect this change. In reconciling the statewide bond allocations, it was discovered that a limited term appropriation had inadvertently not been removed as part of the 2009-10 Governor's Budget. This technical correction will ensure that the bond fund is not oversubscribed.

It is further requested that Item 3860-001-0001 be amended to ensure funds are budgeted in the appropriate program categories. In fiscal year 2007-08, a \$570,000 one-time cost reduction for snow surveys was inadvertently taken from Program 10.30—Data Collection, Evaluation and Use, rather than Program 30.10—Flood Management where the costs had been budgeted. This technical adjustment will correct that baseline error.
