Amendment to Budget Bill Item 1110-001-0770, Support, Department of Consumer Affairs

It is requested that Item 1110-001-0770 be increased by \$1,124,000 to provide funding for the Board for Professional Engineers, Land Surveyors, and Geologists to continue its national examination operations as mandated by state law. This one-time special fund augmentation funds the additional costs required by the National Council of Examiners for Engineering and Surveying to administer the 2011-12 national licensing examinations in the areas of engineering and land surveying.

Amendment to Various Budget Bill Items, Support, Franchise Tax Board

IT Refresh—Enterprise Tape Library (Issue 026)—It is requested that Item 1730-001-0001 be increased by \$19,000 and Item 1730-001-0044 be increased by \$1,000 to facilitate a three-year funding realignment to conform to the revised project schedule for the replacement of Franchise Tax Board's (FTB) Enterprise Tape Library.

Voluntary Contribution Check-Off Funds (Issue 027)—It is requested that Items 1730-001-8022, 1730-001-8053, 1730-001-8055, and 1730-001-8056, all voluntary contribution check-off funds that have not met statutory contribution levels required to remain listed on the California personal income tax form, each be reduced by \$6,000.

It is requested that Items 1730-001-8064, 1730-001-8065, 1730-001-8066, and 1730-001-8067 each be increased by \$6,000. These funds, which are included on the 2010 California personal income tax returns, are voluntary contribution check-off funds established by recently enacted legislation.

Enterprise Data to Revenue Project (Issue 029)—It is requested that Item 1730-001-0001 be increased by \$28,878,000 to redirect 52.0 existing positions and fund a benefits-based vendor contract to implement FTB's previously approved Enterprise Data to Revenue Project, which will upgrade FTB's filing, audit and collection operations, resulting in \$4.7 billion in new General Fund revenue over the six-year contract term.
