Addition of Budget Bill Item 5227-401 and Amendment to Budget Bill Item 5227-101-0214, Support, Board of State and Community Corrections and Eliminate Budget Bill Item 0690-495, Support, California Emergency Management Agency

It is requested that Item 5227-401 (Attachment I) be added, Provision 1 of Item 5227-101-0214 be deleted, and Item 0690-495 be eliminated to allow the Board of State and Community Corrections (BSCC), established pursuant to Chapter 36, Statutes of 2011 (SB 92), to assume responsibility for the California Gang Reduction, Intervention and Prevention (CalGRIP) program previously administered by the California Emergency Management Agency (Cal EMA). These changes are necessary to enable the BSCC to carry out the liquidation of Cal EMA's prior and current year CalGRIP appropriations.

Proposed Budget Bill Language

Authority for the Board of State and Community Corrections to make Prior and Current Year California Gang Reduction, Intervention and Prevention Payments

Add Item 5227-401

5227-401—Pursuant to Chapter 36, Statutes of 2011 (SB 92), the balance of Item 0690-102-0214, Schedules (1) (b) and (1) (c), Budget Act of 2010 and Item 0690-102-0214, Schedules (1) (b), and (1) (c), Budget Act of 2011, as of June 30, 2012 should be transferred to the Board of State and Community Corrections (5227) to carry out the liquidation of these appropriations.
