**Amendment to Budget Bill Items 7100-001-0588 and 7100-001-0870, Support,
Employment Development Department**

It is requested that Item 7100-001-0588 be increased by \$33,787,000 and Item 7100-001-0870 be amended to reflect this change in order to support the fourth year of development, testing, and implementation of the Disability Insurance Automation project. The California Technology Agency approved a Special Project Report for the project in November of 2011. The project end date has been extended from August 2012 to June 2013 and scope changes provide for an interface with the Single Client Database (SCDB) DB2 system.

It is also requested that Items 7100-001-0588 and 7100-001-0870 be revised by adding provisional language authorizing the Department of Finance to augment these items if additional funding is necessary for increased costs due to increased server usage. When the SCDB was converted from an Integrated Data Management System to a DB2 environment, batch and online processing times increased, resulting in increased costs. The Employment Development Department (EDD) is implementing efficiency measures to reduce this processing time and is redirecting savings from unrelated Office of Technology rate reductions to fund the remaining anticipated cost increase. However, should efficiency measures fail to decrease costs to the level anticipated, the EDD may require additional funding for this expense. (See Attachment A for proposed provisional language.)

Add the following provision to Item 7100-001-0588:

- x. The Director of Finance is authorized to increase this item in the instance that the data center expense associated with the DB2 environment within the Single Client Database exceeds projected expenditures of \$3.3 million. Any such augmentation may be authorized not sooner than 30 days after written notification is provided to the chairpersons of the fiscal committees of each house of the Legislature and the Chairperson of the Joint Legislative Budget Committee, or not sooner than whatever lesser time after that notification the chairperson of the joint committee, or his or her designee, may in each instance determine. Funds provided pursuant to this provision may not be used for any other purpose.

Add the following provision to Item 7100-001-0870:

- x. The Director of Finance is authorized to increase this item in the instance that the data center expense associated with the DB2 environment within the Single Client Database exceeds projected expenditures of \$3.3 million. Any such augmentation may be authorized not sooner than 30 days after written notification is provided to the chairpersons of the fiscal committees of each house of the Legislature and the Chairperson of the Joint Legislative Budget Committee, or not sooner than whatever lesser time after that notification the chairperson of the joint committee, or his or her designee, may in each instance determine. Funds provided pursuant to this provision may not be used for any other purpose.

Add the following provision to Item 7350-001-0223:

- x. The Department of Industrial Relations shall report, on or before July 1, 2014, to the Director of Finance and the chairpersons of the fiscal committees of each house of the Legislature and the Chairperson of the Joint Legislative Budget Committee on the status of transitioning to electronic recording processes in Workers' Compensation Appeals Board adjudication hearings. The report shall include an update and description of all staff redirection and workload pursuant to the proposed transition.
