Addition of Various Budget Bill Items and Reimbursements, Capital Outlay, Judicial Branch

In response to continued fiscal constraints, the Judicial Branch (Branch) recently conducted a comprehensive review of its court facilities program and adopted a revised courthouse construction funding plan in February 2013. The revised plan reduces long-term program costs through a combination of project delays and project cost reductions.

The following changes are consistent with the Branch's revised funding plan.

It is requested that Item 0250-301-0668 be added in the amount of \$511,374,000 (lease revenue bonds) for the construction phase of the San Diego County: New San Diego Courthouse project. It should be noted that \$4,623,000 for the construction phase of this project is also requested below in Item 0250-301-3138, from the Immediate and Critical Needs Account, for a total of \$515,997,000 for construction. Working drawings are expected to be complete in June 2013 and the requested funding will allow this project to begin construction in the budget year, as currently scheduled.

This request also includes a scope change to eliminate the planned tunnel between the new courthouse and the adjacent jail, for an estimated savings of \$25 million. While the tunnel would result in desirable efficiencies, this option is too costly to be pursued at this time. Furthermore, it is requested that provisional language be added to align the expenditure period with the current construction schedule (see Attachment A).

It is requested that Item 0250-301-3138 be added in the amount of \$26,295,000 and reimbursements be added in the amount of \$3,578,000 to reflect the following changes (see Attachment B):

Add a total of \$15,384,000 for the working drawings phase for the five projects listed below. These requests include various design changes, ranging from basic value engineering to more substantial scope reductions, needed to meet cost reduction targets set by the Council.

 Glenn County: Renovation and Addition to Willows Courthouse—Working drawings (\$2.6 million). This request reflects value engineering efforts and a scope change to decrease the size of the project by approximately 7 percent to remove non-essential program space.

- Imperial County: New El Centro Courthouse—Working drawings (\$3,344,000). This
 request reflects value engineering efforts and a scope change to decrease the size of
 the project by approximately 12 percent to remove non-essential program space and to
 change the court calendar from juvenile and family matters to juvenile and adult criminal
 matters.
- Merced County: New Los Banos Courthouse—Working drawings (\$1,974,000). This
 request reflects estimated project savings of 24 percent through value engineering
 alone.
- Riverside County: New Indio Juvenile and Family Courthouse—Working drawings (\$3,484,000). This request reflects value engineering efforts and a scope change to decrease the size of the project by approximately 19 percent to remove non-essential program space.
- 5. Tehama County: New Red Bluff Courthouse—Working drawings (\$3,982,000). This request reflects estimated project savings of 24 percent through value engineering alone.

Add reimbursements in the amount of \$3,578,000 for the preliminary plans phase of the Siskiyou County: New Yreka Courthouse project. The County of Siskiyou has agreed to fully-fund preliminary plans, thereby allowing this project to avoid a one-year delay approved by the Council. This request also reflects value engineering efforts and a scope change to replace the planned parking structure with surface parking.

Add a total of \$10,911,000 for the construction phase of the three projects listed below:

- 6. San Diego County: New San Diego Courthouse—Construction (\$4,623,000). This funding is needed to address certain construction costs not eligible for lease revenue bond funding, as requested above in Item 0250-301-0668. It is further requested that provisional language be added to allow a portion of these funds to be used to buy-out an existing lease with the County of San Diego necessary for the project to move forward.
- 7. San Joaquin County: New Stockton Courthouse—Construction (\$3,083,000). This funding is needed to relocate utilities and complete site preparation in advance of the main construction activities, as proposed below for partial reappropriation in Item 0250-490 (\$240,183,000), for total construction funding of \$243,266,000.
- San Joaquin County: Renovation/Addition to Juvenile Justice Center— Construction (\$3,205,000). Construction funding for this project expired on June 30, 2012, before this project was ready to proceed to bid. This request will allow this project to start construction in fiscal year 2013-14 without further delay.

It is requested that Item 0250-490 be added to reappropriate a total of \$240,183,000 for construction for the San Joaquin County: New Stockton Courthouse project. Working drawings are nearly complete, but the project is not expected to proceed to bid by June 30, 2013. This request will allow this project to start construction in 2013-14 without further delay. As noted above, the reappropriation of existing construction funding is also requested in Item 0250-301-3138 (see Attachment C).

It is requested that Item 0250-491 be added to reappropriate construction funding for the Alameda County: New East County Courthouse project and authorize the funds to be used to acquire equity or other real property interest in this project. In addition, provisional language is

proposed to reauthorize the Branch to enter into a lease-purchase agreement with the County of Alameda for the development of this project (see Attachment D).

The effect of my requested action is reflected on the attachment.

Provisions:

- The State Public Works Board may issue lease-revenue bonds, notes, or bond anticipation notes pursuant to Chapter 5 (commencing with Section 15830) of Part 10b of Division 3 of Title 2 of the Government Code to finance the design and construction of the project authorized by this item.
- 2. The Judicial Council and the State Public Works Board are authorized and directed to execute and deliver any and all leases, contracts, agreements, or other documents necessary or advisable to consummate the sale of bonds or otherwise effectuate the financing of the scheduled project.
- 3. The State Public Works Board shall not be deemed a lead or responsible agency for purposes of the California Environmental Quality Act (Division 13 [commencing with Section 21000] of the Public Resources Code) for any activities under the State Building Construction Act of 1955 (Part 10b [commencing with Section 15800] of Division 3 of Title 2 of the Government Code). This provision does not exempt the Judicial Council from the requirements of the California Environmental Quality Act. This provision is declaratory of existing law.
- 4. Notwithstanding any other provision of law, the funds appropriated in this item shall be available for encumbrance until June 30, 2017.

Amendment to Budget Bill Item 2720-301-0044 and Addition of Budget Bill Item 2720-491, Capital Outlay, California Highway Patrol

It is requested that Item 2720-301-0044 be decreased by \$21,358,000 as funding for the construction phase of the California Highway Patrol's (CHP) Santa Fe Springs: Replacement Facility project will not be needed in the fiscal year 2013-14. The Governor's Budget proposal was predicated on the pending acquisition of property in early 2013. Since the release of the Governor's Budget, negotiations for the identified parcel have fallen through and the CHP has started a new site search. Several promising parcels have been identified, and the CHP believes it will be possible to secure property in 2013-14. However, construction funding will not be needed until after 2013-14, as there will need to be some level of redesign to conform to the new location. In conjunction with the decrease in construction funding, there is a request to reappropriate acquisition and preliminary plans funding for this project (see Item 2720-491 below) in order move forward with identifying a new site.

It is requested that Item 2720-491 be added to reappropriate the following projects from the Budget Acts of 2007, 2009, 2010, and 2011:

- Santa Fe Springs Area Office Replacement Facility—Acquisition and Preliminary Plans
- California Highway Patrol Enhanced Radio System (CHPERS): Replace Towers and Vaults Phase 1—Preliminary Plans, Working Drawings, and Construction
- CHPERS: Replace Towers and Vaults Phase 2—Acquisition, Preliminary Plans, Working Drawings, and Construction

The CHPERS Phase 1 and Phase 2 projects were for Tower and Vault replacements at 21 sites. Of these 21 sites, five have had delays for the following reasons:

- Required United States Forest Service (USFS) development of a new site lease agreement. In order to start construction, the state needs long-term access to a site by means of a ground lease. For sites on USFS land, the USFS will complete the National Environmental Protection Act review process.
- Extended lease negotiations with some current property owners are more challenging than anticipated. To the extent that these negotiations fail, it may be necessary to relocate to a nearby location.
- Extended California Environmental Quality Act investigations, including threedimensional modeling of the final project, in order to address community concerns.

- Pursuit of an interagency agreement that, had it been successful, would have eliminated the need for capital improvements at one of the sites. Development at this site was placed on hold during negotiations.
- Required Division of State Architect review of the towers and the mounts used for antennas.

In addition, to the reasons affecting the five sites, three additional sites are nearing the completion of design and are undergoing final Division of State Architect review. There is a possibility that one or more of the sites will not be able to proceed to bid until after the current year, and a reappropriation is necessary to ensure these sites can move forward.

Finally, one CHPERS Phase 1 site that was scoped out of the project at the April 2011 State Public Works Board meeting is requested to be added back to the project. It was the intent that a local agency would provide for the tower and vault, but ultimately that was not possible, and the state will need to provide the improvements necessary to ensure modern communications ability at this site.

It is anticipated that preliminary plans will be completed in 2013-14 for all CHPERS sites that are requested for reappropriation, with the possible exception of the site being added back to the project. There will likely be a need for future construction reappropriations for a few sites that are unable to proceed to bid in time. The reappropriations ensure the CHP's ability to move forward with these tower and vault replacements that will address deteriorating radio communications infrastructure and will improve radio operability among various public safety agencies.

Amendment to Budget Bill Item 3790-496, and Addition of Items 3790-301-6029 and 3790-491, Capital Outlay, Department of Parks and Recreation

It is requested that Item 3790-496 be amended to revert funding for the California Indian Museum project. The completion of this project has been delayed, as noted below, and the balance of the existing funding (construction) will not be needed in fiscal year 2013-14. New funding for preliminary plans has been requested below in Item 3790-301-6029 (see Attachment A).

It is requested that Item 3790-301-6029 be added in the amount of \$1.2 million for the preliminary plans phase of the California Indian Museum project, with provisional language to extend the expenditure period until June 30, 2016. The completion of this project has been delayed by complex siting and land acquisition issues, extensive negotiations with stakeholders, and lengthy environmental reviews. Because the existing funding will expire on June 30, 2013, this request will allow the project to continue without additional delay and will align funding availability with the current project schedule. It should be noted that the existing project funding is proposed for reversion in Item 3790-496 above (see Attachment B).

It is requested that Item 3790-491 be added to reappropriate funding for the following capital outlay projects (see Attachment C):

0263-Off-Highway Vehicle Trust Fund

- Southern California Opportunity Purchase—Acquisition. This acquisition is close to being finalized, but will not be ready for consideration by the State Public Works Board until 2013-14, therefore, the requested reappropriation will help ensure this acquisition can proceed without further delay.
- Carnegie State Vehicular Recreation Area: Road Reconstruction—Construction. Design completion was delayed because of difficulties in finding an acceptable engineering solution to simultaneously meet the requirements of three separate regulatory agencies. Although verbal agreement was reached with all three agencies in February 2013, the project will not be ready to bid by June 30, 2013. The requested reappropriation will help ensure this project can proceed without further delay.

0392—State Parks and Recreation Fund

3. Leo Carrillo State Park: Steelhead Trout Barrier Removal—Construction. This project is fully-reimbursed through non-state grants. Design work on this project was delayed by fundraising efforts that took longer than originally expected. While all of the necessary funds are now in place, it will not be possible to proceed to bid by June 30, 2013. The reappropriation of associated reimbursements is also requested to help ensure this project can be completed as currently authorized.

6051—Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Fund of 2006

- 4. Eastshore State Park: Brickyard Cove—Preliminary plans. The Department of Parks and Recreation is close to finalizing negotiations on a 30-year operating agreement with the Eastbay Regional Park District, as required before these funds can be expended. The requested reappropriation will help ensure this project can move forward in 2013-14 once the required operating agreement is in place.
- 5. Fort Ord Dunes State Park: New Campground and Beach Access—Working drawings. This project was delayed by design challenges related to coastal access and public safety exclusion zones (unexploded ordinance). These issues have since been resolved and the preliminary plans are scheduled to be complete by June 2013. The requested reappropriation will allow this project to continue design activities in the budget year without additional project delays.
- 6. Silverwood Lake State Recreation Area: Nature Center Exhibits—Construction and equipment. The completion and approval of preliminary plans was delayed by several factors, including the need to cancel the design contract with a poorly-performing design firm. The project is now on track, but will not be ready to proceed to bid by June 30, 2013. The working drawings are scheduled to be complete by August 2013. The requested reappropriation will help ensure this project can start construction in 2013-14 without further delays.
