## Addition of Budget Bill Item 8570-491, Capital Outlay, Department of Food and Agriculture

It is requested that Item 8570-491 be added to reappropriate the following project phases:

1. 90.18.001—Relocation: Yermo Agriculture Inspection Station—Acquisition, preliminary plans, working drawings, and construction (See Attachment A).

The working drawings for this project have been completed; however, construction is not expected to start until the fall of 2013 because of issues with the state's underlying property rights. The Department of Food and Agriculture and the California Department of Transportation are working closely with the federal government (Bureau of Land Management) to acquire the necessary property rights. Acquisition is scheduled to be completed by June 2013.

Amendment to Budget Bill Items 8955-001-0001 and 8955-001-0890, Support, California Department of Veterans Affairs

Activation of Veterans Homes in Redding and Fresno (Issue 200)—It is requested that Item 8955-001-0001 be increased by \$24,544,000 and 248.0 positions to provide funding and resources for the continuing activation of the Veterans Homes in Redding and Fresno. This funding replaces \$27.0 million General Fund set aside for this purpose in the Governor's Budget.

**Yountville Cemetery Renovation (Issue 203)**—It is requested that Item 8955-001-0890 be increased by \$2,902,000 for renovation of the Yountville Cemetery. It is further requested that Item 8955-495 be added to revert the unexpended balance of federal funds previously appropriated for this purpose.
