Environmental Improvement Plan Funding—Proposition 84

It is requested that Item 3125-301-6051 in the amount of \$4.0 million and Item 3125-496 be added to appropriate Proposition 84 funds to the California Tahoe Conservancy (Conservancy) to fund land acquisitions and site improvements for the Lake Tahoe Environmental Improvement Program (See Attachment A). The Conservancy expects to encumber approximately \$4 million for this program during the budget year for acquisitions and site improvements in the Lake Tahoe Basin. The Conservancy's current appropriation for this purpose has an unencumbered balance of approximately \$6 million and expires on June 30, 2013. This proposal will revert the remaining balance to provide the necessary funds for a new appropriation.

Addition of Budget Bill Item 3360-001-0853, Support, Energy Resources Conservation and Development Commission

Appliance Efficiency Database Modernization

It is requested that Item 3360-001-0853 be added in the amount of \$2,400,000 to provide funding to modernize the Appliance Efficiency Database (Database).

The Energy Resources Conservation and Development Commission (Commission) appliance efficiency standards specify how manufacturers of energy or water using appliances report appliance performance to the Commission before the appliances are sold in California.

All performance information reported is stored and available to the public through the Database. The Database system contains data for 24 types of appliances (e.g., pool heaters, air conditioners, emergency lighting, etc.). The system was designed in 1999 and no longer has sufficient database capacity.

This proposal will replace the current system with an automated system to allow manufacturers to electronically complete and submit necessary applications and appliance data. The Commission has completed the required Feasibility Study Report.

Strategic Growth Council—Continuation of Grant Program

It is requested that the following items be added to support the continuation and completion of projects funded by Proposition 84 for the Sustainable Communities Planning Grant and Incentive Program (SCPGIP), which is administered by the Department of Conservation on behalf of the Strategic Growth Council:

- 1. Item 3480-495: \$14,782,000. This item will provide a one-time reversion of unencumbered Proposition 84 funds related to SCPGIP. (See Attachment 1)
- 2. Item 3480-001-6051: \$848,000, and amend Item 3480-001-3046 to reflect addition of this new payable. This item will provide funds to support the competitive grants program identified in Item 3. (See Attachment 2)
- 3. Item 3480-101-6051: \$17,191,000. This item will fund the third of three rounds of grants for SCPGIP, and adds provisional language to allow for encumbrance until June 30, 2016. (See Attachment 2)

These actions will allow for the release of unspent expenditure authority and will provide new appropriations that will consolidate bond funds from numerous enactment years for implementation and support of the efforts of the Strategic Growth Council.

Amendment to and Addition of Various Budget Bill Items, Support, Department of Fish and Wildlife

Conservation and Mitigation Banking

It is requested that Item 3600-001-0200 be increased by \$1,263,000 and 9.0 positions to fund the first phase of the Conservation and Mitigation Banking Program which was established through Chapter 565, Statutes of 2012. This increase will allow for a specified process and timeline for the Department of Fish and Wildlife's (DFW) review of bank-related documents for 32 conservation banks and 25 wetland mitigation banks. Additional funding and positions will be provided in the subsequent two fiscal years, contingent on the receipt of projected revenues, with total funding of \$3,068,000 and 23.0 positions in place by June 30, 2016. This request will also establish a dedicated account within the Fish and Game Preservation Fund.

Scientific Collecting Permit Program

It is requested that Item 3600-001-0200 be increased by \$517,000 and 5.0 positions to fund the implementation and administration of the Scientific Collecting Permits Program enacted by Chapter 559, Statutes of 2012. Specifically, this request will provide the DFW with dedicated staff to receive and review scientific permit applications, issue permits, and manage the required submission of results. The funding will support a program that will address current challenges in permitting decisions, approval times, and permitting management procedures.

Agriculture and Grazing Leases

It is requested that Item 3600-001-0447 be added in the amount of \$2.5 million to provide DFW resources, generated from agriculture and grazing leases on department lands, for management and oversight of state-owned land. This proposal includes trailer bill language to clarify that revenue generated from leases is authorized to be used to improve and maintain the intrinsic and ecological values of wildlife areas, ecological reserves, and other DFW managed lands.

Bond Fund Reversions and New Appropriations

It is requested that Item 3600-495 be added to revert \$53,198,000 from previous Proposition 13, 50, and 84 appropriations in order to make the funds available for new appropriations. The

items scheduled for reversion have previously been reappropriated multiple times. It is also requested that Item 3600-001-6051 be increased by \$20,077,000 and Items 3600-001-6027 and 3600-001-6031 be added in the amounts of \$545,000 and \$7,216,000, respectively, to provide continued funding for the following projects: 1) Bay Delta—Integrating Agricultural Activities with Ecosystem Restoration, 2) Bay Delta—Ecosystem Restoration Program, 3) Bay Delta—Natural Community Conservation Plans, 4) Coastal Salmon and Steelhead Fishery projects, and 5) Interim Water Supply and Quality projects (see Attachment 1). The new appropriations will minimize the need for future reappropriations and will align the availability of funds with the cash requirements of the various projects. Item 3600-001-0200 will be amended to reflect these changes. It is also requested that Provision 1 of Item 3600-001-6051 be amended to extend the availability of the appropriation to June 30, 2016 to be consistent with other bond appropriations (see Attachment 2).

Proposition 84 Planning and Acquisition Funding

It is requested that Item 3640-301-6051 be added in the amount of \$5,147,000 to appropriate the specified amounts from the following existing appropriations, which will expire on June 30, 2013 (See Attachment 1):

- \$1.5 million Proposition 84 funding for the Oak Woodlands Conservation Program. The original 2007 appropriation was for \$14,293,000, and this proposal will appropriate the remaining unencumbered balance.
- \$2,368,000 Proposition 84 funding for grants to assist farmers to integrate agricultural activities with ecosystem restoration and wildlife protection. The original 2007 appropriation was for \$4,762,000, and this proposal will appropriate the remaining unencumbered balance.
- \$1,279,000 Proposition 84 funding for the Rangeland, Grazing Land and Grassland Protection Program. The original 2007 appropriation was for \$14,293,000, and this proposal will appropriate the remaining unencumbered balance.

In addition, it is requested that Item 3640-491 be amended to reappropriate an additional \$10 million of 2009 Proposition 84 funding for the Sacramento-San Joaquin Delta Natural Community Conservation Plan. The original appropriation was for \$24 million, and the remaining unencumbered balance is approximately \$19 million. The Governor's Budget proposes a \$5.5 million reappropriation, and this proposal will reappropriate an additional \$10 million to fund the additional projects that the Wildlife Conservation Board (WCB) has identified for the budget year. The remaining unencumbered \$3.5 million would revert back to the fund until additional grant recipients are identified.

The requested funding will allow the WCB to fund a number of projects in 2013-14 that would otherwise have to wait until subsequent years to be funded.

Fund Shift to Realign Baseline Budget

It is requested that the following adjustments be made to realign the State Coastal Conservancy's (Conservancy) budget and reflect the effect of declining Conservancy Trust Fund balances and the decreasing availability of bond funding:

- Delete Item 3760-001-8047 and add Item 3760-101-8047 in the amount of \$131,000.
 Add provisional language to authorize the Conservancy to use up to 10 percent of the funds for support costs. This action is necessary to appropriately budget the grant funds as local assistance, instead of state operations.
- Increase Item 3760-001-0890 by \$100,000 to provide sufficient federal fund expenditure authority to the Conservancy consistent with historical federal funding levels.
- Decrease Item 3760-001-6051 by \$85,000 to reflect the declining availability of Proposition 84 bond funds.

Sacramento-San Joaquin Delta Invasive Species Control

It is requested that Item 3790-001-0516 be increased by \$742,000 and that Item 3790-001-0392 be amended to reflect this change for the purpose of controlling two invasive species within the Sacramento-San Joaquin Delta (Delta), water hyacinth and spongeplant. Of the proposed amount, \$167,000 is for the control of water hyacinth, and \$575,000 is for the control of spongeplant. Unusually warm weather and high water flows have caused a proliferation of these plants throughout the Delta, and the increased funding will help prevent the detrimental effect on navigation and recreation that these plants would have without additional control efforts.

Reappropriation of Local Assistance Project Funding

It is also requested that Item 3790-490 be added to reappropriate \$426,000 in Proposition 12 funding for the YMCA of San Diego County: Border View Expansion Project (See Attachment 1). The funding for this project was originally appropriated in 2000, and the period of liquidation was extended in 2008 and 2009. Although the project was completed in May 2010, due to an oversight the final encumbrance was not made prior to the expiration of the funding at the end of fiscal year 2009-10. In addition, it is also requested to reappropriate the \$11,626,000 in Proposition 40 funding for the Railroad Technology Museum Grant-Rehabilitation and Facilities Plan. The funds have not been expended to date because final agreements have not yet been reached with regard to the remediation of the Sacramento Railyards.

Technical Adjustments

It is requested that Items 3860-101-0744 and 3860-101-0790 be deleted. The Ground Water Recharge and Water Conservation Loan and the Water Supply and Water Conservation Loan programs are concluding and the funds are no longer needed.

Reappropriations

It is requested that Item 3860-491 be added to reflect reappropriated funds from various appropriations in previous years (See Attachment A) and add provisional language making the funds available for encumbrance or expenditure through June 30, 2015. Amendment to Budget Bill Item 3885-001-0001 and Reimbursements, Support, Delta Stewardship Council

Delta Plan Implementation

It is requested that Item 3885-001-0001 be increased by \$777,000 General Fund to replace expiring bond funds and maintain the existing level of positions as the Delta Stewardship Council (Council) begins implementation of the Delta Plan (Plan). Five existing positions in the Plan Division of the Council are currently supported by Proposition 84 funds, which are anticipated to be exhausted by June 30, 2013. The proposed funding would allow the positions to continue as the Council transitions into performing operational activities associated with the Plan. The Council anticipates adopting the final draft of the Plan in the spring of 2013 and ongoing resources will be necessary for implementation.

Reimbursement Authority—Delta Science Programs

It is requested that Item 3885-001-0001 be amended by increasing reimbursements by \$6 million to provide for an interagency agreement between the Department of Water Resources (DWR) and the Council. This action will conform to the DWR request to extend the liquidation period for Proposition 84 funds appropriated for research activities related to the Sacramento-San Joaquin Delta (Also see Department of Water Resources Finance Letter, Item 3860-493, Issue 151).
