## Amendment to Budget Bill Control Section 4.20, Support, Contribution to Public Employees' Contingency Reserve Fund

It is requested that language be added to Control Section 4.20 to stipulate that the state's contribution to the Public Employees' Contingency Reserve Fund (CRF) can be used only for the health care program administration costs on behalf of state employees and retirees. The CRF identified in Control Section 4.20 is a health care premium surcharge assessed on the state and local government employers to pay for health care administration costs at the California Public Employees' Retirement System. Suggested Budget Bill language is attached (Attachment 1).

## **ATTACHMENT 1**

"SEC. 4.20. (a) Notwithstanding any other provision of law, the employer's state's contributions to the Public Employees' Contingency Reserve Fund, as required by Section 22885 of the Government Code, shall be 0.32 percent of the gross health insurance premiums paid by the employer and employee for administrative expenses on behalf of state employees. The Director of Finance may, not sooner than 30 days after notification to the Joint Legislative Budget Committee, adjust the rate to ensure a three-month reserve in the Public Employees' Contingency Reserve Fund.

(b) The allocation made from funds appropriated for this purpose shall not be used for administration expenses of other public agencies or contract agencies."
