Amendment to Various Budget Bill Items and Reimbursements, Support, Department of Transportation

Capital Outlay Support: Project Delivery Workload (Issue 150)—It is requested that the Capital Outlay Support Program be decreased by \$25,153,000 and 166 positions. This request reflects decreased workload due to diminishing fund sources, such as Proposition 1B and the federal American Recovery and Reinvestment Act.

Amendment to Budget Bill Item 2660-001-0042, Support, Department of Transportation

Affordable Sales Program (Issue 003)—It is requested that Item 2660-001-0042 be increased by \$2,546,000 and 6 positions to provide resources to support the disposition and sale of Phase 1 properties, primarily single and multi-family residences, in Los Angeles County, pursuant to the requirements of the Roberti Act and Chapter 468, Statutes of 2013 (SB 416). These one-time resources will support the first phase of the program. Additional resources will be needed in subsequent years. It is further requested that provisional language be added to this item to allow the item to be increased if actual costs exceed the amount budgeted.

Road Usage Charge Pilot Program Acceleration (Issue 004)—It is requested that the multi-year expenditure plan for the Road Usage Charge Pilot Program submitted in the 2015-16 Governor's Budget be updated to reflect an additional \$1.3 million in Item 2660-001-0042 in fiscal year 2016-17 to address an accelerated schedule for the implementation of the pilot program. This additional contract funding will enable the state to complete the pilot a year earlier.

Provision XX

X. Of the amount appropriated in this Item, \$2,546,000 is for the Affordable Sales Program. If the actual costs to implement this program exceed the costs budgeted for this purpose, this Item may be augmented by the amount of the excess on order of the Department of Finance no sooner than 30 days following notice in writing to the chairpersons of the fiscal committees in each house of the Legislature and the Chairperson of the Joint Legislative Budget Committee.
